#### REQUEST(S)

• Change-in-Zoning from R-6, CM & M-2 to EZ-1

- Waiver of Land Development Code (LDC), section 10.2 to omit the 15' vehicle use area landscape buffer area (VUA LBA)
- District Development Plan

#### **CASE SUMMARY**

The proposal calls for a change in zoning from multi-zones to EZ-1. The site is in an industrial area immediately adjacent to the Muhammad Ali International Airport. No residential uses are within the immediate vicinity of the proposed zoning change. Residential zones that adjoin are owned by the Louisville Regional Airport Authority. No improvements or change in the use of the properties is proposed with this application. At the time of development or redevelopment, a detailed district development plan will be required.

#### STAFF FINDING

The proposed change in zoning is in conformance with the land use and development policies of Plan 2040. The proposed district is appropriately located within the Suburban Workplace form district and concentrates industrial activities near the airport within the same zone.

#### STANDARD OF REVIEW FOR ZONING AND FORM DISTRICT CHANGES

Criteria for granting the proposed form district change/rezoning: KRS Chapter 100.213

- 1. The proposed form district/rezoning change complies with the applicable guidelines and policies Plan 2040; **OR**
- 2. The existing form district/zoning classification is inappropriate and the proposed classification is appropriate; **OR**
- 3. There have been major changes of an economic, physical, or social nature within the area involved which were not anticipated in Plan 2040 which have substantially altered the basic character of the area.

#### STAFF ANALYSIS FOR CHANGE IN ZONING AND FORM DISTRICT

The Following is a summary of staff's analysis of the proposed rezoning against the Land Use and Development Policies of Plan 2040:

#### The site is in the Suburban Workplace Form District

Suburban Workplace is a form characterized by predominately industrial and office uses where the buildings are set back from the street in a landscaped setting. Suburban workplaces often contain a single large-scale use or a cluster of uses within a master planned development. New larger proposed industrial uses are encouraged to apply for a planned development district.

In order to provide adequate transportation access in suburban workplaces connected roads, public transportation and pedestrian facilities should be encouraged. Walkways to workplace-serving uses are encouraged for workplace employees. Development within suburban workplace form districts may need significant buffering from abutting uses.

The proposed district is appropriately located within the Suburban Workplace form district adjacent to like zones and uses having necessary infrastructure and transportation facilities. It does not encroach upon residential areas or zones. No residential uses are located adjacent to or in the immediate vicinity. Residential zones that abut site to the north are mostly consolidated and owned by the Louisville Regional Airport Authority. No residences, schools, parks or vulnerable populations will be impacted by noises or traffic created within the proposed zone. The site is currently improved. It would not appear to contain natural resources that may be harmed as a result of development and MSD preliminary review and approval to ensure the safety and welfare of users within flood prone areas has been received.

### STANDARD OF REVIEW AND STAFF ANALYSIS FOR WAIVER

(a) The waiver will not adversely affect adjacent property owners; and

STAFF: The waiver will not adversely affect adjacent property owners as the subject property is in a developed industrial area and site conditions presently encroach into the buffer.

(b) The waiver will not violate specific guidelines of Plan 2040; and

STAFF: The waiver will not violate specific guidelines of Plan 2040. Community form Goal 1, Policy seeks to ensure an appropriate transition between uses that are substantially different in scale and intensity or density of development. The transition may be achieved through methods such as landscaped buffer yards, vegetative berms, compatible building design and materials, height restrictions and setback requirements. Policy 12 calls for the parking, loading and delivery areas located adjacent to residential areas to minimize adverse impacts from noise, lights, and other potential impacts. The encroachment is a result of existing conditions and no improvements have been proposed which create greater non-compliance or worsen the impacts of the viewshed along this roadway having industrial on both sides.

(c) The extent of the waiver of the regulation is the minimum necessary to afford relief to the applicant; and

STAFF: The extent of the waiver of the regulation is the minimum necessary to afford relief to the applicant as the encroachment is present and triggered by the requested change in zoning. Upon re-development of the subject site, landscape buffers and tree canopy may be required.

#### (d) Either:

- (i) The applicant has incorporated other design measures that exceed the minimums of the district and compensate for non-compliance with the requirements to be waived (net beneficial effect); **OR**
- (ii) The strict application of the provisions of the regulation would deprive the applicant of the reasonable use of the land or would create an unnecessary hardship on the applicant.

STAFF: The strict application of the provisions of the regulation would create an unnecessary hardship on the applicant as no development is being requested and the waiver is the result of existing encroachments.

#### STANDARD OF REVIEW AND STAFF ANALYSIS FOR DISTRICT DEVELOPMENT PLAN

- a. The conservation of natural resources on the property proposed for development, including: trees and other living vegetation, steep slopes, water courses, flood plains, soils, air quality, scenic views, and historic sites;
  - STAFF: The conservation of natural resources on the property proposed for development, including: trees and other living vegetation, steep slopes, water courses, flood plains, soils, air quality, scenic views, and historic sites will be provided. The subject property is developed and does not contain natural resources.
- b. <u>The provisions for safe and efficient vehicular and pedestrian transportation both within the</u> development and the community;
  - STAFF: Provisions for safe and efficient vehicular and pedestrian transportation within and around the development and the community will be provided. Sidewalks on Wabasso Avenue are available and serve primary entrances. No other improvements to the site are proposed.
- c. <u>The provision of sufficient open space (scenic and recreational) to meet the needs of the proposed development:</u>
  - STAFF: The development site is built-out and does not require open space.
- d. The provision of adequate drainage facilities on the subject site in order to prevent drainage problems from occurring on the subject site or within the community;
  - STAFF: The Metropolitan Sewer District has approved the preliminary development plan and will ensure the provisions of adequate drainage facilities on the subject site in order to prevent drainage problems from occurring on the subject site or within the community.
- e. The compatibility of the overall site design (location of buildings, parking lots, screening, landscaping) and land use or uses with the existing and projected future development of the area;

STAFF: The proposal is compatible with the overall character of the area and design of the form district. The development site is built out and concentrates industrial activities in an industrial area adjacent to the airport.

f. Conformance of the development plan with the Comprehensive Plan and Land Development
Code. Revised plan certain development plans shall be evaluated for conformance with the nonresidential and mixed-use intent of the form districts and comprehensive plan.

STAFF: The proposed development plan conforms to the Comprehensive Plan and all relief requested from the Land Development Code appears to be adequately justified.





Walkways to workplace-serving uses are encouraged for workplace employees. Development within suburban workplace form districts may need significant buffering from abutting uses.

The proposal is in a workplace form adjacent to similar and like industrial uses readily served by infrastructure and transportation facilities. The site is concentrated in an industrial area adjacent to the airport. No residences, schools, parks or vulnerable populations will be impacted. Traffic entering the area will not need to pass through residential areas to access the interstate or arterial roadways.


