The following was discussed:

- Questions and concerns about staffing issues and what is being done to retain drivers
- Questions and concerns about the lose of a large amount of drivers over the last 12 months
- MV Transportation, Inc. has a new training program to retain drivers
- Questions and concerns about whether the public was made aware of the shortage of drivers
- Question and concerns about whether provisions are made for drop-off and pick-up of customers when a driver does not show up for their shift
- Questions and concerns about customers being left stranded for long periods of time
- Questions and concerns about customers being contacted in a timely matter that they will not be picked up
- Transit Authority of River City "TARC" has the ability to sub-contract with other contractors for TARC 3 riders
- The current pay rate is \$15 per hour for TARC 3 drivers
- Question about whether taxi cabs drivers can be used as sub-contractors
- zTrip does approximately 65% of the driving for TARC 3
- TARC 3 drivers do not have to have a Commercial Drivers License
- Question about whether TARC can cancel the contract with MV Transportation
- Questions and concerns about all TARC employees being able to apply for posted job openings within TARC
- MV Transportation has received 37 new applications for driver positions
- TARC was asked to return on August 3, 2021 for follow-up questions

The following was discussed:

- The Ordinance would clarify the exemption to sell farm produce that a homeowner has produced at their residence
- This Ordinance was not intended to become a full time Conditional Use Permit to sell produce daily
- This Ordinance is to limit the amount of time you can sell the produce
- Code enforcement would have more latitude to identify where the person was getting there produce
- Questions about whether a provision is in the Ordinance that states the produce is to be sold at the property which the produce was grown on
- Questions about whether the Land Development Code has language that encourages selling produce on any private property and not just the property in which it is grown

A motion was made by Vice Chair Engel, seconded by Committee Member Flood, that this Ordinance be tabled.
