Local Property Tax TIF (ad Valorum TIF)

- The project constructs a building, employs people, and provides access to goods and services on what is now a paved parking lot
- The project causes New Property Taxes to be created
- Only a Portion of just the Newly Created Property Taxes, that <u>do not exist unless the project</u> <u>occurs</u>, and only for a number of years...to ensure the project is able to occur
- 20% of the new property taxes created by the project go to the City at the beginning and 100% go to the City after the TIF time period.

Benefits to Phoenix Hill neighborhood and other surrounding neighborhods:

- Jobs paying at the top of the pay scale (see Partnerships For Success below)
- Access to Goods & Services (Grocery, Food & Beverage, Floral, Hotel)
- New Tax Revenue to support City Services, which also support the creation of other projects by other companies in the future
- **Cultural Enrichment** (Art outside, Programmable Space for Events, Connectivity Between NuLu/Liberty Green)
- **Momentum** -Renewed new construction investment, especially important after the economic challenges of the COVID-19 Pandemic
