AN ORDINANCE APPROPRIATING \$4,900 <u>\$7,375</u> <u>\$9,525</u> FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICT 9; \$850 FROM DISTRICT 10; <u>\$725</u> <u>FROM DISTRICT 4; \$600 FROM DISTRICT 8; \$500 EACH FROM</u> <u>DISTRICTS 2, 13, AND 24;</u> \$350 EACH FROM DISTRICTS <u>1, 12, 14,</u> 15, 17, 21, AND 25; AND \$300 <u>EACH FROM</u> DISTRICTS <u>6, 7 AND 20;</u> <u>AND \$250 EACH FROM DISTRICTS 3 AND 16;</u> THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC. TO HELP FUND THE ANNUAL BUY LOCAL FAIR <u>(AS AMENDED)</u>.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$4,900 \$7,375 \$9,525 is hereby appropriated from

Neighborhood Development Funds in the following manner: \$2,000 from District 9; \$850

from District 10; \$725 from District 4; \$600 from District 8; \$500 each from Districts 2, 13,

and 24; \$350 each from Districts 1, 12, 14, 15, 17, 21, and 25; and \$300 each from

Districts 6, 7 and 20; and \$250 each from Districts 3 and 16; through the Office of

Management and Budget, to the Louisville Independent Business Alliance, Inc. to help

fund the annual Buy Local Fair.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
