
>> THIS REGULAR MEETING OF THE LOUISVILLE METRO COUNCIL IS BEING CONDUCTED VIA VIDEO TELECONFERENCE PURSUANT TO KRS 61.826 AND IN ACCORDANCE WITH THE SENATE BILL 150 SOME MEMBERS ARE PRESENT IN CHAMBERS AND OTHERS ARE ATTENDING VIRTUALLY. IF WE EXPERIENCES A DISRUPTION IN THE VIDEO FEED OF ANY OF OUR MEMBERS ATTENDING VIRTUALLY THE MEETING WILL BE SUSPENDED FOR 10 MINUTES WHILE WE MAKE A REASONABLE ATTEMPT TO FIX THE ISSUE. WHILE THE MEETING IS SUSPENDED, ALL DISCUSSION OF BUSINESS WILL CEASE AND NO ACTION WILL BE TAKEN. IF AFTER 10 MINUTES THE ISSUE WITH THE MEMBER'S FEED CONTINUES WE'LL RESUME THE MEETING AND THE MEETING WILL CONTINUE AS LONG AS WE STILL HAVE A QUORUM OF MEMBERS. WHILE THE MEETING IS SUSPENDED ALL DISCUSSION OF PUBLIC BUSINESS WILL CEASE AND NO ACTION WILL BE TAKEN. IF AFTER 20 MINUTES THE ISSUE CANNOT BE RESOLVED THE MEETING WILL STAND ADJOURNED. ANY UNFINISHED OR PENDING BUSINESS AT THAT TIME WILL BE ADDRESSED AT THE NEXT MEETING OF THE COUNCIL.

THAT'S MORE FAMILIES MOURNING THE LICE OF A MOM, DAD, BROTHER, SISTER OR CHILD. I CANNOT EXPRESS HOW STRONGLY ENOUGH HOW IMPORTANT IT IS WE GET VACCINATED AND MASK UP AND TOGETHER WE CAN BEAT THIS. WE'RE STILL IN THE RED ZONE HERE IN LOUISVILLE AND EXPERIENCING A SHARP INCREASE IN CASES ESPECIALLY AMONG OUR CHILDREN. PLEASE JOIN ME IN A MOMENT OF SILENCE FOR THOSE THAT WE'VE LOST. THANK YOU. COUNCIL MEMBER WINKLER, I BELIEVE YOU HAVE A SPECIAL GUEST AND PROCLAMATION AND LET THE RECORD REFLECT COUNCIL MEMBER PIAGENTINI HAS TAKEN THE CHAIR.

 HIS SERVICE AND HAVE A PROCLAMATION WE WORKED ON PRESIDENT JAMES
 WILL GIVE YOU AND I WILL READ. SO TO WHOM THE LETTERS SHALL COME
 GREETING THE LOUISVILLE COUNCIL HONORS HIM AND HE GRADUATED IN
 1989 WITH A BACHELOR'S DEGREE IN BROADCASTING AND WORKED AS A
 LOCAL REPORTER AND TONY BEGAN WORKING AS A COMMUNICATIONS

DIRECTOR FOR THE MAJORITY CAUCUS IN APRIL 2006 AND HAS HELPED GUIDE THE COUNCIL THROUGH CHANGES SUCH AS IN EXPANDING LOCAL MEDIA LANDSCAPE AND THE EVOLUTION OF SOCIAL MEDIA AND VIRTUAL MEETINGS AND WHERE HIS FRIENDLINESS AND ACCEPTABILITY WERE THE HALLMARKS WERE THE TIME OF THE LOUISVILLE METRO AND THE COUNCIL THANKS HIS FOR HIS YEARS OF SERVICE TO THE COUNCIL AND CITY AND HOPE BUT THE FUTURE BRINGS NOTHING BUT THE BEST INCLUDING MORE NATIONAL CHAMPIONSHIPS FOR LOUISVILLE AND DONE IN THE COMMONWEALTH OF KENTUCKY, THIS 26TH DAY OF AUGUST, 2021.  HONORS AND PRESENTATIONS. BACK IN MARCH OF 2006 AFTER ABOUT 29
 YEARS OF BROADCASTING, IT WAS TIME FOR ME TO HAVE A CHANGE AND I
 HEARD ABOUT THIS JOB BY THE DEMOCRATIC CAUCUS AND I CALLED THE

DISTRICT 10 OFFICE AND TALKED TO A YOUNG FELLA NAMED ROB HOLTZMAN WHO SAID WE WANT YOU TO APPLY. TWO HOURS LATER JIM KEEN CALLED AND SAID I HEAR YOUR INTERESTED IN THE JOB. BOY, YOU WOULD BE A GREAT ADDITION TO THIS METRO COUNCIL. SO I CAME TO WORK HERE TO REMIND EVERYBODY WHO WAS HERE BACK THEN, THE BIG ISSUE BACK THAT SUMMER WAS THE ANIMAL CONTROL ORDINANCE. THERE WERE SOME PIT BULLS THAT WERE TERRORIZING POST OFFICE WORKERS IN THE VALLEY STATION AREA AND BOB HENDERSON AMONG OTHERS WAS ADAMANT TO GET SOMETHING DONE AND WHO WERE NOT THERE IN 2006 FOR A MEETING THAT WENT TO 2:30 IN THE MORNING WE FINALLY MADE IT THROUGH THAT ONE. I THOUGHT ABOUT THIS OVER THE MONTHS SINCE I DECIDED TO RESIGN AND RETIRE. I'VE ALWAYS APPRECIATED THE LEGISLATIVE BRANCH OF GOVERNMENT. I KNOW OTHERS HAVE TOLD ME OVER THE LAST COUPLE DAYS THEY REALLY APPRECIATED MY EFFORTS IN GETTING THEM THROUGH SOME TOUGH TIMES. I'LL TELL YOU TWO OTHER THINGS THEN I'LL HUSH UP, PROMISE. PRIOR TO COVID, YOU ALL KNOW MY OFFICE IS RIGHT BY THE

COFFEE MACHINE ON THE THIRD FLOOR AND IT WAS NOT UNCOMMON FOR COMMITTEE WEEK FOR ME TO BE VISITED BY COUNCIL MEMBER BENSON WHO WAS ALWAYS LOOKING FOR COFFEE AND HE'D STOP BY MY DOOR AND TALK ABOUT WHAT'S ON HIS MIND AND HE'D SAY I KNOW PEOPLE THINK I'M --THAT'S A COMMON FRAME. SO YOU WILL ALWAYS HAVE A SPECIAL PLACE IN MY HEART. THAT'S IT. THAT'S ALL I HAVE TO SAY. IT'S BEEN AN HONOR AND PRIVILEGE AND I CAN'T THINK OF A BETTER WAY TO SPEND MY LAST 15 YEARS THAN HELPING YOU ALL HELP THE PEOPLE OF LOUISVILLE SO THANK YOU ALL.

- >> MEMBERS OF THE COUNCIL, I'M CLARENCE HIXON, A LOCAL ATTORNEY REPRESENTING DENNIS DOLAND WHO IS CHALLENGING RECENT DEVELOPMENT ACTIONS. IN MANY PARTS OF METRO LOUISVILLE, IF YOU FLUSH THE TOILET IN WET WEATHER YOU HAVE NO ASSURANCE THE WASTE WATER WILL ACTUALLY MAKE IT TO THE TREATMENT PLANT AND IF IT DOES GET THERE, THAT THE TREATMENT PLANT IS NOT ALREADY OVERLOADED AND WILL NOT SIMPLY BYPASS IT INTO THE RIVER. WE NEED TO CLOSE A MAJOR LOOPHOLE IN THE LAND DEVELOPMENT CODE, CHAPTER 11 REVIEW STANDARDS THAT SETS OUT REVIEW PROCEDURES FOR NEW DEVELOPMENTS. CHAPTER 11 NEEDS TO BE AMENDED BY METRO COUNCIL WITH A TRUTH AND DEVELOPMENT ACT TO CLOSE THE LOOPHOLE. THE TRUTH IN DEVELOPMENT ACT WOULD REQUIRE REVIEWING AGENCIES AND THE CASE MANAGER OF PLANNING AND DESIGN TO DISCLOSE IN THE RECORD PRIOR TO THE HEARING THE SPECIFIC DETAILS OF THE FREQUENCY, VOLUME AND LOCATION OF ANY DOWNSTREAM SEWER OVERFLOWS AND SEWER CAPACITY

ISSUES AND OTHER ENVIRONMENTAL IMPACTS. EFFECTED NEIGHBORS AND PLANNING COMMISSIONER SHOULD KNOW IN DETAIL THE IMPACTS MUCH NEW DEVELOPMENT ON THE ENVIRONMENT AT THE TIME THEY CONSIDER NEW DEVELOPMENT IN THE COUNTY. PLAN 2040 DEMANDS THE LAND DEVELOPMENT CODE FAILS TO SPECIFY THE DISCLOSURE. THE PLANNING COMMISSION SHOULD NOT HAVE APPROVAL THE RECENT PROVIDENCE POINT DEVELOPMENT FOR 520 APARTMENTS. THE CONSEQUENCES FOR THAT DECISION WERE NOT KNOWN TO THE COMMISSIONERS BECAUSE CHAPTER 11'S BROAD AND VAGUE REVIEW LANGUAGE DOESN'T REQUIRE PEOPLE BE TOLD THE WHOLE TRUTH. RIGHT NOW THERE IS NO TRUTH IN DEVELOPMENT LANGUAGE AND THE CONSEQUENCES ARE THE CITY ADDS NEW MAJOR SEWER LOADS TO THE BROKEN OVERLOADED WASTE WATER SYSTEM. SINCE WE CONTINUE TO OVERLOAD THE SYSTEM AND NEVER LET THE INFRASTRUCTURE CATCH UP, LOUISVILLE WELL CONTINUE A MAJOR POLLUTER FOR YEARS TO COME AND RATE PAYERS WILL BE FORCED TO PAY BILLIONS IN A FUTILE EFFORT TO STOP A SYSTEM THAT NEVER STOPS POLLUTING. THE LOUISVILLE SEWER SYSTEM IS IN A CRISIS AS MSD IS BEING PROSECUTED IN FEDERAL DISTRICT COURT AND IN THE FEDERAL EPA FOR VIOLATIONS OF THE CLEAN WATER ACT. SINCE NEITHER EPA NOR THE CABINET HAVE IMPOSED A MORATORIUM ON THE DEVELOPMENT TO THE OVERLOADED SEWER LINES, METRO COUNCIL CAN AND SHOULD REQUIRE THE WHOLE TRUTH BE TOLD ABOUT THE IMPACTS OF DEVELOPMENT TO OUR CRUMBLING INFRASTRUCTURE. MV TRANSIT WAS CANCELED IN RICHMOND FOR FAILURE TO SHOW UP FOR RIDES AT ALL. IT WAS FIRST CONTRACTED OUT HERE IN KENTUCKY AND AGAIN THEY FELL SHORT. IN ATLANTA, THERE WAS A FEDERAL

INVESTIGATION WHERE MV TRANSIT AND THE FEDERAL TRANSIT HAD A COMPLAINT THAT THEY IGNORED THE OBLIGATION OF CONTRACTS WITH THE MINORITY OWNED BUSINESS. AND IT FAILED TO PROVIDE 20% OF THE WORK TO THE DISADVANTAGED BUSINESS AND THE UNION IS MAKING A CLAIM SHE SHOULD BE REPLACED. THANK YOU.

- >> WONDERFUL. GOOD EVENING, COUNCIL MEMBER AND CHAMBER

 ARMSTRONG, PRESIDENT NAMES AND OTHER MEMBERS OF THE COUNCIL. I'M

 ARIANA LEVINSON AND I'M SPEAKING ON BEHALF OF MYSELF AND THE 490

 PROJECT ASK YOU TO REVIEW THE METRO CONTRACT WHEN AVAILABLE AND

 VOTE KNOW IF THEY STILL CONTAIN THE DANGEROUS PROVISIONS NOT

 CONSISTENT WITH STATE LAWS. FOR INSTANCE, SEVERAL REQUESTED

 ARTICLE 17 BE RENEGOTIATED. IF IT STILL CONTAINS THE MEMO IN

 SECTION 2 OR THE IN SECTION 1 THAT ALLOWS CITIZEN COMPLAINTS TO

 BE HANDLED INFORMALLY SO NO INVESTIGATIVE WORK IS ENTERED IN THE

 OFFICER'S PERSONAL FILE OR TO BE DISPOSED OF AFTER 90 DAYS WE

 HOPE YOU WILL HONOR YOUR PROMISE TO VOTE NO. WHILE THE PRESS

 RELEASE FROM THE MAYOR'S OFFICE MENTIONED CHANGES TO THE

 DISCIPLINE PROCESS IT'S UNCLEAR WHETHER THESE PARTICULAR

 PROVISIONS OF ARTICLE 17 HAVE BEEN CORRECTED. YOU'LL SEE OTHER

PROBLEMATIC PROVISIONS ARE NOT ADDRESSED AT ALL IN THE PRESS RELEASE. ALL KINDS OF OTHER REFORMS CAN BE MADE BUT IF THE CONTRACTS ARE NOT CHANGED, THE F.O.C. WILL CONTINUE TO PROTECT OFFICERS AFTER IMPUNITY AND USE EXCESSIVE FORCE BECAUSE THE CONTRACTS ALLOWS THEM TO DO SO. THE 490 PROJECT SPENT TIME CONSOLIDATING THE BUDGET COMMENTS RECEIVED BY THE METRO COUNCIL TO ONE SINGLE EXCEL SHEET TO ANALYZE THEM. YOU CAN SEE FROM THE RESULT IN THE CIRCULATED MEMO, AROUND 40% OF ALL COMMITTED COMMENTS GOT A DECREASE IN THE POLICE BUDGET. THE PERCENT OF COMMENTS THAT REQUESTED AN INCREASE IN FUNDING AROUND 4% WAS LOWER THAN THE EXPRESSED CONCERN AROUND THE COLLECTIVE BARGAINING PROCESS AROUND 5%. A LARGE NUMBER OF CITIZENS ARE CONCERNED WITH THE LOADED LMPD BUDGET AND THE LACK OF TRANSPARENCY IN THE PROCESS AND URGE YOU TO VOTE NO ON ANY CONTRACT THAT CONTINUES TO CONTAIN PROVISIONS NOT IN LINE WITH STATE LAW OR WITH OTHER CONTRACT. WE, THE 490 PROJECT, ARE HAPPY TO HELP ANY OF YOU REVIEW THE CONTRACT CHANGES AND ASCERTAIN THEIR MEANING. OUR E-MAIL IS AT THE TOP OF THE CIRCULATED MEMO. WE HOPE COUNCIL MEMBER DORSEY'S COMMITTEE OR WHATEVER COMMITTEE'S COLLECTIVE BARGAINING AGREEMENTS ARE ASSIGNED TO WILL HOST A COMMUNITY EDUCATION SESSION ABOUT THE CONTRACTS AND INVITE THE 490 PROJECT TO PARTICIPATE AS AN EDUCATOR. THANK YOU FOR YOUR TIME AND CONSIDERATION

>> GOOD EVENING, I'M FRAN HARTEL TO TALK ABOUT THE USE OF THE CHEROKEE PARK. I'D LIKE TO BEGIN BY ASKING YOU TO RAISE YOUR HAND IF YOU KNOW AN ELDERLY PERSON OR YOU KNOW SOMEONE WITH A DISABILITY. DO YOU KNOW ANYONE WHO DRIVES FOR AN ELDERLY PERSON OR A DISABILITY IN SOME CITIZENS ARE OF THE OPINION THE HYBRID MODEL OF THE PARK LOOP IS A COMPROMISE. THIS MODEL DOES ALLOW FOR BIKERS, RUNNERS AND WALKERS TO HAVE TOTAL ACCESS TO THE PARK LOOP. CARS ARE LIMITED. THIS IS NOT A COMPROMISE. THE COMPROMISE WAS IN THE '90S UNDER THE MAYOR. THE PARK WAS TRANSFORMED FROM A TWO-WAY TRAFFIC PATTERN TO A PLAIN WHERE BIKERS AND WALKERS AND CARS SHARED THE ROAD. ONE LANE FOR BIKES. ONE LANE FOR RUNNERS, WALKER, STROLLERS, DOGS. FOR DECADES WE ALL ENJOYED THE PARK. WE SHARED THE ROAD. WE SHARED THE LOOP. IT WORKED. THE HANDOUTS BEFORE YOU ARE EXCERPTS FROM THE AMERICANS WITH DISABILITIES ACT. UNDER THE A.D.A., STATE AND LOCAL GOVERNMENTS GIVE PEOPLE WITH DISABILITIES AN EQUAL OPPORTUNITY TO BENEFIT FROM PROGRAMS, SERVICES AND ACTIVITIES. REQUIREMENTS PROHIBIT EXCLUSION, SEGREGATION AND UNEOUAL TREATMENT IN A PUBLIC ACCOMMODATION. CHEROKEE PARK IS A PUBLIC PARK. MEMBERS OF COUNCIL, THIS IS NOT A SURVEY. IT DOES NOT INVOLVE PUBLIC OPINION. THIS IS THE LAW. THE A.D.A. IS A CIVIL RIGHTS LAW. PLEASE, VOTE FOR ALL OF YOUR CONSTITUENTS. VOTE TO OPEN THE CHEROKEE PARK LOOP. THANK YOU.

>> HI, I'M A DISTRICT 4 RESIDENTS AND ASKING YOU TO VOTE NO ON OFFICER RAISES. I'M AGAINST THE FOTCBA AND IN ARTICLE 15 SECTION 9 OFFICERS ARE PERMITTED TO REVIEW THEIR BODY CAMERA FOOTAGE BEFORE MAKING A STATEMENT ON INCIDENTS THEY'RE INVOLVED IN AND ANOTHER SECTION STOPPED RECORDINGS OF THEIR OWN INTERVIEWS FROM THE PUBLIC INTEGRITY UNIT. THIS HELPS A COP GET HIS STORY STRAIGHT. IF IT GIVES OFFICERS UNFAIR ACCESS TO EROSION OF PUBLIC TRUST MANY SAID THE CONTRACT NEGOTIATIONS WERE STARTING IN JANUARY, 2021. YOU INDICATED YOU [INAUDIBLE] WOULD WAIT FOR REFORMS IN THE NEXT CBA. I HOPE YOU'LL TAKE A STAND BY VOTING NO ON THE PROPOSED CBA UNTIL THE PROVISIONS ARE REMOVED ENTIRELY. [INDISCERNIBLE] THE ITEMS ABOVE HAVE NOT BEEN ADDRESSED. I HEARD MANY SAY YOU HAVE NO CONTROL OVER THE CONTRACT NEGOTIATING PROCESS BUT YOU DO. YOU CAN VOTE KNOW AND MAKE CLEAR TO THE MAYOR YOU WILL NOT PASS A CONTRACT THAT CONTINUES TO CATER AND HARM CITIZENS AND HOPE YOU'LL ADD THESE ADDING A SECTION YOU WILL NOT HIRE INDIVIDUALS WITH A DOCUMENTED HISTORY OF CONDUCT AND A REPRIMAND TO TURN ON THE CAMERA NOT ENOUGH FOR AN OFFICER TO CARE. DORMANT. I DON'T WANT TO BE HERE REPEATING MYSELF FOR THE

COMMITTEE AT THE NEXT CONTRACT. I'M ASKING YOU TO CHANGE THINGS

NOW. PLEASE LET IT BE KNOWN. WE HAVE TO STOP ALLOWING OFFICERS

DIFFERENT TREATMENT THAN OTHER CITIZENS. I DEMAND WE HOLD

OFFICERS ACCOUNTABLE AND BEGIN USING AN EARLY WARNING SYSTEM FOR

OUR SAKE. THANK YOU.

>> GREETINGS PRESIDENT JAMES. I'M NANCY AND A PRESIDENT IN DISTRICT 26. I'M ALSO A MEMBER OF THE 490 PROJECT. I SPEAK TONIGHT IN ANTICIPATION OF THE NEW CONTRACTS BEING PRESENTED TO YOU, THE METRO COUNCIL IN THE COMING WEEKS. I'M ASKING THE METRO COUNCIL TO VOTE NO TO THE NEW CONTRACT IF THEY INCLUDE ANY OF THE PROBLEMATIC PROVISIONS NOTED TONIGHT OR IN THE RECENT PAST. SPECIFICALLY ANY PROVISIONS CALLING FOR NO LAYOFFS SHOULD BE REMOVED. IT'S NOT A PROVISION IN ANY OTHER LAYOFF AGREEMENT AND THEY'RE CONSIDERED TO BE MANAGEMENT DECISIONS. IT CONTINUES TO SUPPORT THE UNDESIRABLE OUTCOMES AND UNNECESSARY COST BURDEN ON THE TAXPAYERS OF OUR CITY. WE HEARD COUNCIL AND COMMUNITY MEMBERS ARTICULATE THE REMOVAL OF MANY PROBLEMATIC PROVISIONS MENTIONED TONIGHT. I REMAND COUNCIL MANY ANTICIPATED SEEING CHANGES TO THE NEW CONTRACT INCLUDING REMOVAL OF SOME OF THESE PROBLEMATIC PROVISION. WE'RE COUNTING ON YOU TO VOTE NO IF THEY'RE STILL IN THE CONTRACT. WE'RE ALSO ASKING METRO COUNCIL

TO VOTE NO TO THE NEW CONTRACT IF THEY ASK FOR ADDITIONAL FUNDS FOR THE BUDGET INCLUDING FOR SALARY INCREASES. THE APPROVED 21-22 BUDGET FOR LMPD IS OVER \$195 MILLION ALREADY HAS FUNDS BEYOND THE NEED FOR CURRENT STAFFING AND ANY ANTICIPATED ADDITIONAL STAFFING. THERE'S ALSO SIGNIFICANT FUNDS IN THE BUDGET FOR PURCHASE OF EQUIPMENT, SYSTEMS AND WE WERE TOLD IN THE BUDGET MEETINGS MULTIPLE TIMES BY COUNCIL MEMBERS THERE'S SUFFICIENT FUNDING IN THE LMPD BUDGET. WE'RE COUNTING ON YOU TO VOTE NO IF THE NEW CONTRACT CALLS FOR ADDITIONAL FUNDING. MY LAST REQUEST IS FOR A YES. IT'S A YES VOTE FROM YOU TO INCLUDE COMMUNITY PARTICIPATION IN THE CONTRACT APPROVAL PROCESS. WE'RE TOLD REPEATEDLY THAT OUR VOICES ARE HEARD THROUGH THE METRO COUNCIL MEMBERS. I'M REQUESTING SUFFICIENT TIME BE GIVEN FOR COMMUNITY INPUT THROUGH A SERIES OF SPECIAL MEETINGS REGARDING THE CONTRACT ONCE MADE AVAILABLE TO ALL OF US TO READ. AND ONLY ONE SUCH MEETING WAS HELD ALLOWING ONLY 60 PEOPLE TO SPEAK. THIS IS HELD JUST AN HOUR BEFORE THE COMMITTEE MET AND THE COUNCIL MET THREE LATER TO VOTE ON THE APPROVAL OF THAT SAME CONTRACT AND WE NEED EDUCATION AND INPUT MEETINGS. PLEASE ALLOW THE TIME AND SPACE TO HEAR ABOUT WHAT THE COMMUNITY IS ASKING FROM YOU AS OUR ELECTED OFFICIALS AS YOU RESPOND AND PREPARE TO VOTE ON THESE NEW CONTRACTS. GIVE US REAL TRANSPARENCY AND ACCOUNTABILITY NOT JUST WORDS. DON'T RUSH, BE BOLD. DO SOMETHING NEW. NOW IS THE

TIME. AND REMEMBER, WE CONTINUE TO STAY HER NAME, BREONNA TAILOR.

>> TO YOU METRO CITY COUNCIL AND PRESIDENT JAMES AND THE COUNCIL. I'M PASTOR THOMAS BAKER OF CHRIST WAY MISSIONARY BAPTIST CHURCH AT THE CORNER OF FLOYD AND BRECKENRIDGE STREET. AS A RESIDENT AND POS PASTOR AND OUR MAUL SMALL TIME COMMUNITY I MUST PROPOSE OPPOSITION TO THE PROPOSED PROPERTY FOR THE PERSONS WHO HAVE FALLEN INTO HOMELESSNESS JUST STEPS FROM OUR DOORS. THE CHRIST WAY CHURCH AND THE SMOKE TOWN COMMUNITY WITH WERE GIVEN NO ADVANCED NOTICE, NO INPUT AND EXTREMELY LIMITED INFORMATION. WE WERE ONLY ALERTED BY A NEWS FLASH AS WAS THE BROADER COMMUNITY. I MUST BE CLEAR, WE RECOGNIZE THE SITUATION IS EXTREMELY COMPLEX AND INTERVENTION IS NECESSARY WE ARE NOT ANTI. WE WANT A SOLUTION THAT DOES NOT RAVISH OUR CHURCH AND COMMUNITY VALUE BECAUSE WE'RE IN A FOOD DESERT, BECAUSE SO MANY IN OUR COMMUNITY HAVE LIMITED ACCESS TO PPE, BECAUSE THE INFLUX OF HOUSELESS WITHIN OUR COMMUNITY AND OUR CHURCH STANDS IN THAT GAP AND HELPS FEED THE HOUSELESS AND FOOD INSECURE AND EVEN DISTRIBUTES PPE WEEKLY. WE ALSO PARTNER WITH SEVERAL ORGANIZATIONS. WE DO OUR PART AND WE HAVE BEEN HELPING TO DO THE WORK ON THE GROUND, ON OUR PROPERTY. WE HAVE HAD NUMEROUS ACCOUNTS OF DESPERATE DESECRATION ON THE GROUNDS. WE'VE HAD CAMP SITES SET UP. THERE'S BEEN FECES AT OUR FRONT DOORS AND VIOLENT AND DANGEROUS SITUATIONS ESCALATE RIGHT BEFORE OUR EYES. THE PROPOSED SITE IN OUR BACKYARD AND WE'LL INVITE MORE OF THE SAME. WE BELIEVE THIS SITE POSES A SEVERE THREAT TO DETERIORATE THE SAFETY OF OUR COMMUNITY. IT POSES A THREAT TO STIFLE THE APPEAL OF OUR MINISTRY AND IT IS A GUARANTEE TO DIMINISH THE ECONOMIC STABILITY AND VIABILITY MUCH OUR CHURCH. YOU DELAY THE ADOPTION OF THIS PROPOSAL, THAT YOU DO ADDITIONAL RESEARCH THAT INCLUDES COMMUNITY AND MOST DEEPLY AFFECTED AND LASTLY, YOU DO THE WORK TO PRESENT A BETTER AND MORE VIABLE SOLUTION THAT DOES NOT [INDISCERNIBLE] THANKS FOR YOUR THOUGHTFUL CONSIDERATION.

- >> GOOD EVENING. I'M FROM DISTRICT 4. I'VE BEEN IN LOUISVILLE

 THE LAST 24 HOURS AND WATCHED THE CITY EVOLVE IN VARIOUS WAYS. I

 WAS PRIVILEGED WITH QUIET STREETS WHERE FRIENDS AND I COULD BIKE

 TO THE PARK OR SCHOOL WITHOUT FEAR. IT WAS A FORM OF FREEDOM FOR

 THE YOUTH IN MY AREA. NOW I LIVE CLOSER TO DOWNTOWN AND NOTICE

 THE SAME PRIVILEGE IS NOT AFFORDED. I DON'T SEE KIDS ON THE

 STREET RIDING TO THE PARK OR CONVENIENCE STORES AND DON'T SEE

 THEM RIDING TO SCHOOL. THERE ARE A FEW QUIET STREETS IN OUR

URBAN AREA BETWEEN LIFTED PICK UP TRUCKS AND STREET WITH MORE LANES THAN HIGHWAYS IT ISN'T SAFE FOR A YOUNG PERSON TO RITE RIDE A BIKE AND HAVING BEEN HIT BY A CAR ON MULTIPLE OCCASIONS IT'S RARELY SAFE FOR A BIKE EITHER. A BICYCLE IS NOT A CAR BUT SOMETIMES WE'RE FORCED TO USE THIS METHOD AND 30 PEOPLE HAVE BEEN KILLED IN TRAFFIC IN 2020 HIGHLIGHTING THE IMPORTANCE OF CREATING SAFE, ACCESSIBLE SPACES SUCH AS WE HAVE WITH THE LOOP. SOME COLLEAGUES HAVE CLAIMED THIS AREA WAS DESIGNED TO ACCOMMODATE CARS AND CRUISING THE SCENERY WAS THE INTENT AND WHEN THE CHEROKEE PARK WAS DESIGNED HENRY FORD WAS 28 YEARS OLD AND THE MODEL T WOULDN'T COME OFF THE FACTORY LINE FOR YEARS AND THERE WAS AN ARTICLE BY THE COURIER JOURNAL THAT SAID THE PARK WAS TO QUICKLY GIVE PEOPLE A CHANCE TO CHEAPLY AND PLEASANTLY ESCAPE THE TOWN AND COME UNDER THE AGREEABLE FORM OF SCENERY. THE DESIGN GIVES THAT. IT GIVES BICYCLISTS AND PEDESTRIANS A CHANCE. THE DATA SHOWED LIMITING CAR ACCESS HAS BEEN POPULAR BUT THE VISITS INCREASING 80% DURING THE CLOSURE. VISITORS CAME FROM MORE AREAS THAN BEFORE. IN SHORT THE PARK WAS NEVER ACCOMMODATING THAN WHEN WE NEED IT MOST. MAINTAINING ACCESS FOR THOSE WITH LIMITED MOBILITY HAS BEEN COMPROMISED. THE PAVED WALKING PATH AND RUGBY FIELD AND THE FOUNTAIN ALL CAN BE ACCESSED BY CAR. THE ONLY CHANGE IS MANY CAN ONLY ACCESS HALF THE LOOP AND THERE'S ROADWAY IN THE CITY MANY WHICH PASS THROUGH SCENERY AREAS LIKE JEFFERSON MEMORIAL AND THE PARKLAND. 80% OF

THE ROADS THROUGHOUT CHEROKEE PARK REMAIN OPEN. WHILE SOME CLAIM IT'S BEEN LED THROUGH SELF-SERVING ELITISTS THE PARK PROVIDED SAFE REFUGE THE STREETS COULD NOT. WE SHOULD LEARN FROM THAT AND STRIVE TO CREATE SAFE SPACES. I WILL END WITH WISDOM FROM A COLLEAGUE THAT SAID WHEN NEITHER SIDE IS HAPPY YOU'RE PROBABLY DOING THE RIGHT THING. IT SEEMED WE REACH THE POINT WE FOUND COMPROMISE AND REACHED A BALANCE. GREAT CITIES ACROSS THE WORLD HAVE INVESTING IN SPACES FOR PEDESTRIANS AND HOPE YOU DO THE SAME FOR LOUISVILLE. THANK YOU

ACCESSIBLE TO EVERYONE IN THIS CITY WHETHER YOU'RE 8 OR 80 YEARS

OLD, RICH OR POOR, DISABLED OR NOT. OUR PUBLIC SPACES, PARKS AND

ROADS MUST BE ACCESSIBLE TO EVERYONE AND WE HAVE A LOT OF WORK

TO DO IN THAT REGARD IN THE CITY. WHAT PUZZLES ME IS MANY

COUNCIL MEMBERS WHO ARE PLANNING TO VOTE NO ON THE CHEROKEE PARK

ORDINANCE TODAY CLAIM THEY ARE GOING TO DO SO IN THE NAME OF

ACCESSIBILITY. I BELIEVE THESE COUNCIL MEMBERS, UNFORTUNATELY,

ARE INACCURATELY CLASSIFYING THE ACCESSIBILITY. THE

ACCESSIBILITY CONVERSATION HAS CENTERED UPON ONE GROUP, ELDERLY



 ENVISION CHEROKEE PARK AS A SQUARE, THERE'S CURRENTLY VEHICULAR
 ACCESS ON TWO SIDES OF THE SCARE AND THE OTHER SIDES ARE VEHICLE
 RESTRICT. ON THE SIDES THERE'S NO AMENITIES AND VEHICULAR ACCESS
 TO EVERY PLAYGROUND AND ONE TRANSACTION ONE MIGHT WANT TO VISIT
 AND EVEN ON THE SIDE WHERE THE SQUARE IS CLOSED, A LOT OF TIMES
 YOU CAN DRIVE UP TO ACCESS POINTS IMMEDIATELY ADJACENT. FOR
 EXAMPLE, ON ONE SIDE THERE'S A LARGE PARKING LOT NEAR THE GOLF
 COURSE. PEOPLE WOULD PARK THERE AND WALK REGARDLESS OF ROADS ARE
 OPEN OR NOT SO IN REALITY WE'RE TALKING ABOUT A SHORT AREA MAYBE

150 YARDS THAT IS COMPLETELY VEHICLE RESTRICTED. FROM MY PERSPECTIVE AS THE COUNCIL PERSON ON THE PARK THE COMPROMISE HAS BEEN WORKING WELL. I BELIEVE WHEN WE LOOK AT WHOSE VOICES WE ARE LISTENING TO IN THIS DEBATE, ONE THING WE HAVE TO DO IS LOOK AT THE PEOPLE UTILIZING THE PARK AND HAVE UTILIZED THE PARK. PEOPLE WHO ARE OLD AND NEW USERS AND MOST OF ALL PEOPLE ACTUALLY UTILIZING THE PARK AND I THINK WHEN WE LOOK AT THE PUBLIC OPINION SURVEYS CONDUCTED WITH THAT FRAME OF REFERENCE THE RESULTS ARE NOT MIXED, THEY'RE ACTUALLY QUITE CLEAR. THERE ARE TWO SURVEYS DONE. ONE WAS A RANDOMIZED COMMUNITY SURVEY WHERE 30% WERE LOOP USERS AND HAD ANY FAMILIARITY WITH THE LOOP AND 138 PEOPLE AND THAT GROUP HAD A SLIGHT PREFERENCE. IT WAS LESS THAN HALF OPINION BUT THE LEADING PREFERENCE WAS TO RE-OPEN THE ROADS ENTIRELY HOWEVER, I'VE NEVER SEEN ANYTHING SUGGESTING THAT WAS A STATISTICALLY SIGNIFICANT DIFFERENCE OR PREFERENCE BECAUSE WE'RE TALKING ABOUT SUCH A SMALL GROUP OF PARK USERS. IN CONTRAST THE OPEN SURVEY ANYONE CAN TAKE YIELDED OVER 800 PARK USERS AND MORE THAN 70% OF INDIVIDUALS LIKED THE COMPROMISED PLAN AND THOUGHT IT WAS WORKING. CHEROKEE PARK IS UNIQUE. IT'S A PARK THAT HAS A LOT OF VEHICULAR TRAFFIC BEFORE THE PANDEMIC BECAUSE CUTTING THROUGH THE PARK IS THE EASIEST WAY TO GET FROM HIGH LAND TO 64 AND LEXINGTON ROAD AND A LOT OF PEOPLE WILL FREELY ACKNOWLEDGE WHAT THEY DON'T LIKE ABOUT THE TRAFFIC PATTERN IS IT MAKES IT MORE DIFFICULT FOR THEM TO GET FROM POINT A TO POINT B IN THE PARK. I THINK WHEN WE THINK ABOUT CREATIVE WAYS TO DISCOURAGE CUT-THROUGH TRAFFIC MOST AGREE HAVING PEOPLE CUTTING THROUGH THE PARK AND SPEEDING WITH CHILDREN AND PEOPLE WITH DISABILITIES AND LOW VISION AND DIFFICULTIES HEARING, WE SHOULD BE DISCOURAGING PEOPLE JUST USING THE PARKS FROM GETTING FROM POINT A TO POINT B. WHEN WE LOOK AT CREATIVE WAYS TO DECREASE THAT, A PARTIAL CLOSURE OF A SMALL SECTION OF THE ROAD TO MAKE IT NOT THE MOST CONVENIENT WAY TO GET THROUGH IS ONE IDEA WE'D ALL SAY SOUNDS LIKE IT COULD WORK AND IN FACT IS WORKING. I WANT TO MAKE A QUICK COMMENT ABOUT ACCESSIBILITY BECAUSE IT'S IMPORTANT AND I HAD A FORUM TO TALK ABOUT ISSUES OF EOUITY AND ACCESSIBILITY RELATED THE PARK. DURING THE DEBATE, A LOT OF TIMES WE HAVE SPOKEN MONOLITHICALLY AND A SPOKE TO HUNDREDS ABOUT THE ACCESSIBILITY NEEDS IN THE PARK INCLUDING PARENTS OF CHILDREN ON THE AUTISM SPECTRUM WHO PREFER VEHICLE RESTRICTED PLACES SO THE CHILDREN AREN'T ALARMED BY THE SENSORY OVERLOAD WITH LOUD TRAFFIC AND PEOPLE WITH LOW VISION WHO ENJOY HAVING A SPACE IN THE PARK WHERE THERE'S NOT GOING TO BE A VEHICLE TO RELAX AS THEY ENJOY THE QUIET WALK IN THE PARK. IT INCLUDED PEOPLE WITH HEARING ISSUES WHO PREFER NOT TO HAVE TO BE CONSTANTLY STANDING OVER THEIR SHOULDERS. THEY ENJOY THE PARK. WHILE I'M VERY SENSITIVE AND THINK WE HAVE TO PRIORITIZE THE NEEDS OF INDIVIDUALS WITH PHYSICAL DISABILITIES AND MOBILITY NEEDS, I BELIEVE THIS COMPROMISE DOES THAT AND I THINK IF YOU

ALL TAKE TIME TO LOOK AT THE MAP YOU'LL SEE THERE'S PARKING. THERE ARE ROADWAYS THAT ARE OPEN TO GET TO EVERY MAJOR AMENITY OF THE PARK AND I THINK THERE'S WAYS IF THIS COMPROMISED PLAN STANDS WE CAN ASK THE PARK TO LOOK AT SPECIAL PERMITS THAT INDIVIDUALS COULD GET, SPECIAL WAYS INDIVIDUALS WHO NEED A VEHICULAR ACCESS TO CERTAIN PLACES, THEIR NEED COULD BE ACCOMMODATED. THE LAST THING I WANT TO SAY IS THE REASONS WE CLOSED THE PARK TO VEHICLES ARE INITIALLY IN COVID TIMES ARE INCREASINGLY REAL. WE'RE DEALING WITH RISING CASE NUMBERS THROUGHOUT OUR COUNTY. WE'RE DEALING WITH A LOT OF PEOPLE WHO WANT TO BE OUTSIDE AGAIN AND PEOPLE WHO WANT TO MAINTAIN DISTANCE WHILE WE DO SO. THOSE WERE THE REASONS WE INITIALLY AGREED THE HIGHLAND IS A DENSE AREA AND A PARK FREQUENTED BY PEOPLE WHO LIVE IN THE URBAN CORE AND INCREASINGLY WE NEED SPACES WHERE INDIVIDUALS CAN BE OUTSIDE AND MAINTAIN DISTANCE IF THEY STILL WISH TO EXERCISE IN HEALTHY AND SAFE WAYS. FOR ALL THOSE REASONS I'M ASKING COUNCIL TO SUPPORT THIS COMPROMISED PLAN. IT BEST MEET THE NEEDS OF THE COMMUNITY AROUND THE PARK AND THE COMMUNITY THROUGHOUT THE CITY AND WITH THAT, THANK YOU, MR. PRESIDENT. I'M HAPPY TO ANSWER ANY QUESTIONS ANYONE HAS.

- >> THANK YOU, COUNCIL WOMAN. COUNCIL WOMAN PIAGENTINI.
- >> I WANT TO SPEAK IN OPPOSITION TO THIS AND DESCRIBE WHY. MOST IT PROCEDURAL AND THEN TALK ABOUT HOW THIS SHOULD HAVE GONE.


FIRST, THE PROCESS WAS FLAWED FROM THE BEGINNING. IN OTHER WORDS, WE DIDN'T START FROM WHERE THE PARK WAS BEFORE THE PANDEMIC AND THEN DISCUSS ALL THE WAYS IN WHICH WE CAN IMPROVE THE EXPERIENCE OF THE PARK AND MAKE IT SAFE. I WILL KEEP, AS A MATTER OF EXACT WE HAD WAYS TO COMPROMISE AND NONE OF THAT WAS CONSIDERED. WHAT'S HAPPENED HERE FROM A PROCEDURAL POINT OF VIEW, THE MAYOR MADE A UNILATERAL DECISION TO CLOSE ROADS WHICH OF US FOUGHT AGAINST BECAUSE IT WAS EARLY IN THE PANDEMIC AND WE NEEDED TO TAKE QUICK ACTION. BUT AS THINGS EVOLVED, HE MADE A COMPROMISE. HE MADE A DECISION WITHOUT INPUT FROM THE LARGER PUBLIC WE REPRESENT. IT WAS FUNDAMENTALLY FLAWED. IN FACT, I'D COMPLIMENT COUNCIL MEMBER ARMSTRONG THAT WERE IT NOT FOR HER INTERVENING THE ADMINISTRATION WAS NOT PLANNING ON DOING ANYTHING MORE THAN A 15 MINUTE OUESTION AND ANSWER PERIOD. COUNCIL MEMBER ARMSTRONG WANTED MORE INPUT AND HAD A PANEL OF PEOPLE AND MEMBER OF THE PARKS DEPARTMENT AND COUNCIL WOMAN ARMSTRONG AND THE CEO OF THE ARMSTEAD CONSERVATORY. WHEN PEOPLE SPEAK IT WAS HANDED TO THE CEO OF THE ARMSTEAD CONSERVANCY AND SHE WAS INFLUENCING AND YOU HAVE AN ADVOCATE FOR ONE POSITION ENGAGED IN THE PROCESS OF ENGAGE AS A PUBLIC OFFICIAL AND WASN'T. IF SHE WAS PROPERLY SHE SHOULD HAVE SIGNED UP AND HAD JUST A FEW MOMENTS TO SPEAK LIKE ANY OTHER PUBLIC PERSON. THE LAST THING IS WE VOTED UNANIMOUSLY TO PASS THIS ORDINANCE TO HAVE METRO COUNCIL HAVE SAY OVER THE LONG-TERM CLOSURES. THE


PROCESS IS SUPPOSED TO BE A PUBLIC MEETING AND THEN A VOTE AT COUNCIL FOR A NEW PROCESS IF THERE'S A PERMANENT CLOSURE OR OTHER THINGS RELATED TO THE PARK. WHAT WE'RE VOTING ON IF YOU VOTE YES, YOU'LL BE VOTING TO AMEND AN ORDINANCE WE UNANIMOUSLY AGREED TO THAT GIVES THE POWER TO MAKE THESE DECISIONS BACK TO THE MAYOR'S OFFICE AND TAKES IT AWAY FROM METRO COUNCIL. THIS WILL NOT EXTEND ONLY TO CHEROKEE PARK BUT GIVE THE MAYOR THE POWER TO DO THIS ANYTIME HE WANTS TO. SO THAT IS ONE OF MY --THIS IS MY PROCEDURAL ISSUE. THERE WAS A SURVEY AND POLL DONE. THE SURVEY DOESN'T EVEN HAVE CONTROLS OVER BEING ABLE TO ENTER MULTIPLE TIMES AND THE SCIENTIFIC POLLS BOTH USERS AND INFREQUENT USERS OF THE PARK INDICATED THEIR NUMBER ONE PREFERENCE WAS TO OPEN UP THE ROADS. ANOTHER COMMENT ON WHO SHOULD MAKE THE DECISIONS. I HAVE NO PROBLEM TO DEFER TO THE INPUT AND LISTEN TO GROUPS THAT USE THESE AMENITIES A LOT. THAT WOULD BE THE REGULAR PARK USERS. BUT ALL TAX PAYERS PAY FOR THIS PARK, ALL. IF I DON'T USE THAT PARK ONCE EVERY THREE YEARS OR USE THAT PARK AT ALL, THE TAXPAYER I HAVE A VOICE IN WHAT HAPPENS TO THE PARK. THE SAME THING OCCURS WITH PUBLIC SCHOOLS. MY DAUGHTERS FOR EXAMPLE, DO NOT USE THE PUBLIC SCHOOL SYSTEM. I DIDN'T USE IT GROWING UP. WE PAID FOR CATHOLIC SCHOOL BECAUSE WE'RE CATHOLIC AND HOW TO I WANT TO EDUCATE MY DAUGHTERS. I'M A TAXPAYER IN THE JEFFERSON COUNTY PUBLIC SCHOOL SYSTEM AND THEY LISTEN TO MY VOICE JUST AS MUCH AS THEY LISTEN TO ANYBODY ELSE'S VOICE BECAUSE I PAY FOR IT AND HAVE A SAY SO RELATED TO THE PUBLIC EDUCATION SYSTEM. SAME WITH THE PUBLIC PARK SYSTEM. FOR EXAMPLE, A COMMUNITY SURROUNDING CHEROKEE PARK IS BY THE LATEST CENSUS DATA THE LEAST ETHNICALLY DIVERSE GROUP IN THE ENTIRE CITY. WHEN WE SAY LISTEN TO THE FREQUENT USERS THEY DON'T EVEN MAKE UP REMOTELY A RACIALLY DIVERSE COMMUNITY THAT REPRESENTS THE REST OF LOUISVILLE WHEREAS I FIND IT INTERESTING WHEN SIMILAR DISCUSSION WAS POINT IN A PARK WITH A MORE RACIALLY DIVERSE COMMUNITY THE COMMUNITY WANTED TO REOPEN IT FOR EVERYBODY. I RESPECT THE FOLKS IN THE AREA. I DO THINK THERE ARE SOLUTIONS SUCH AS SLOWING THE SPEED LIMIT DOWN. IT'S RIDICULOUS, IN MY OPINION THE SPEED LIMIT IS 25. WHEN I DRIVE IT I'M BARELY DOING 15 IF I'M DOING A MILE AN HOUR. THERE'S WAYS TO SLOW IT DOWN AND PUT BETTER SIGNAGE AND BARRIERS UP TO PROTECT PEOPLE USING THE WALKING SIDE. IN CENTRAL PARK THE CONSERVANCY GOT A ONE-WAY STREET AND CLOSED DOWN SECTIONS OF IT AND THEN FINALLY CLOSED IT DOWN PERMANENTLY. AND THEY SAY IT'S NOT THEIR INTENTION BUT THE FOLKS I'VE SPOKEN TO, CLEARLY THEIR ULTIMATE INTENTION AND SOME HAVE BEEN HONEST AND SOME SAY NOT AND I'VE HAVE TO TAKE THEIR WORD FOR IT BUT THEIR ULTIMATE INTENT IS TO SHUT DOWN ALL VEHICULAR TRAFFIC TO SCENIC ROUTES LIKE THIS. I DON'T THINK IT'S A GOOD IDEA AND WAYS TO MAKE IT A SAFER PARK AND SHOULD EXPLORE THOSE IDEAS BUT NOT IN A BACKWARDS PROCESS

THAT GOES AGAINST THE INTENTION OF UNANIMOUSLY PASSED ORDINANCE.
THANK YOU VERY MUCH, MR. PRESIDENT.

>> THANK YOU, MR. PRESIDENT. I'LL BE BRIEF. I DO WANT TO THANK COUNCIL MEMBER ARMSTRONG FOR HER LEADERSHIP. SHE'S HAD ONE MEETING SHE IMPROVED BY THE WAY SHE CONDUCTED IT BUT SHE'S BEEN WITH THE COMMUNITY ON MULTIPLE OCCASIONS REGARDING THIS ENTIRE ISSUE. SHE'S BEEN A LEADER ON THE PARK IN HER DISTRICT. I KEEP HEARING AND GETTING E-MAILS THAT SAY THE ROADS TO AMENITIES IN THE PARK ARE CLOSED. AND THAT IS NOT TRUE. ROADS TO PLAY GROUNDS, TO PICNIC BENCHES, TO AMENITIES ARE NOT CLOSED UNDER THIS COMPROMISE. AND IF YOU COULD NOT GET TO THOSE AMENITIES BY ROAD, WOULD BE AGAINST IT AND I DON'T AGREE WITH COUNCIL MEMBER PIAGENTINI THE PEOPLE I HAVE TALKED TO AND NOT THE CONSERVANCY ARE INTERESTED IN CLOSING THOSE ROADS. THAT'S THE VALUE OF THIS COMPROMISE. MANY HAVE BEEN OVERWHELMINGLY IN FAVOR OF THIS COMPROMISE. AND FINALLY, I WANT TO REPEAT SOMETHING COUNCIL MEMBER ARMSTRONG HAS SAID. THIS PARK HAS BEEN A CUT-THROUGH TRAFFIC AREA FOR A VERY LONG TIME. IF YOU HAVE WALKED IN THE SCENIC ROUTE YOU HAVE SEEN CARS CUTTING THROUGH NOT ENJOYING THE SCENERY BUT CUTTING THROUGH FROM ONE AREA TO THE OTHER AND THIS HAPPENS REGULARLY. THE COMPROMISE IS AIMED TO PREVENT THAT AND TO MAKE A SAFER EXPERIENCE. I'VE HAD PEOPLE CONTACT ME SAYING THEY DON'T HAVE TO DEAL WITH STOP SIGNS AND TRAFFIC LIGHTS. THE QUICKEST WAY TO NAVIGATE THE CITY IS TO GO THROUGH CHEROKEE

- PARK. I DON'T THINK WE SHOULD ENCOURAGE THAT. I DON'T THINK
 THAT'S WHAT HOMESTEAD INTEND THE PARK TO BE AND THINK THE
 COMPROMISE INS THAT KIND OF DANGEROUS ACTIVITY WITHOUT KEEPING
 ANYBODY FROM BEING ABLE TO GET TO ANY AMENITIES IN THIS PARK BY
 CAR. THANK YOU.
- >> THANK YOU, COUNCIL MEMBER. COUNCIL MEMBER PEDEN.
- >> I BUZZED IN FOR TWO REASONS. ONE JUST IN CASE AND THERE'S ENOUGH PEOPLE BUZZING IN AFTER ME I'M GOING TO INVOKE THE 90 MINUTE RULE.
- >> THERE'S A MOTION TO LIMIT DEBATE.
- >> SECONDED BY COUNCIL WOMAN GEORGE. ALL IN FAVOR SAY AYE.

 WELL ROUNDED GROUP THE OTHER ONE HAD PEOPLE IN THE PARK HANDING
 OUT FLYERS QR CODES AND OTHER ACCESS POINTS. YOU'RE GOING TO
 HAVE AN OVERWHELMING NUMBER OF PEOPLE TO USE THE PARK. THE

- >> THANK YOU, MR. PRESIDENT. THE ISSUE OF DISABILITY AWARENESS IS SIGNIFICANT HOWEVER, I AM FOCUSSING ON WHAT CLOSURES TO OUTSIDERS WOULD THINK ABOUT THIS. THOUGH I KNOW IT'S NOT THE INTENT ON THE SURFACE IT SEEMS CLASSIST TO CLOSE THE PARK AT THIS TIME. SHOULD MY FAMILY BE REQUIRED TO TAKE AN UBER TO CHEROKEE PARK IF WE WANT TO VISIT THE PARK BECAUSE WE HAPPEN TO NOT LIVE IN THE NEIGHBORHOOD? WE GO TO VARIOUS PARKS ACROSS THE CITY BECAUSE AS MANY OF YOU KNOW MY SON IS A RUNNER AND HE LOVE TO RUN THE LOOP AT CHEROKEE. I DIDN'T GET A SURVEY. WHETHER WE'RE TALKING ABOUT CLOSURES TO AMENITIES, THIS IS THE PEOPLE'S PARK. WHAT IS SO SPECIAL ABOUT CHEROKEE THAT IS NOT SPECIAL ABOUT THE PARKLAND OR SHAWNEE PARK OR OTHERS? I LOVE THE HIGH LAND IT'S A BEAUTIFUL AND VIBRANT AREA OF TOWN HOWEVER, CHEROKEE PARK IS NOT THE PERSONAL BACKYARD TO ANY RESIDENT. TO CONTINUE TO KEEP IT CLOSED TO TRAFFIC AMOUNTS TO US GIVING CHEROKEE PARK TO ONLY THE RESIDENTS WHO CAN WALK THERE AND WALK THROUGH THIS PARK INSTEAD OF TO ALL. I WILL BE VOTING NO.
- >> THANK YOU, COUNCIL WOMAN. COUNCIL WOMAN ACKERSON.
- >> I DON'T REMEMBER WHO THE SPEAKER WAS BUT EARLIER ONE SPEAKER
 RANG THROUGH ON COMPROMISE. THE COMPROMISE TOOK PLACE YEARS AGO.
 AND BEING IN TRAFFIC. I HEARD ABOUT FOLKS COMPLAIN ABOUT TRAFFIC
 THROUGH THE PARK. LET'S SHUT DOWN THE ROADS BECAUSE WE HAVE

WALKERS AND LET'S SHUT DOWN ALL THE PARKS. IT'S RIDICULOUS. PRE
PANDEMIC THE PLAN WORKED AND COUNCIL WOMAN GREEN PUT IT PERFECT.

IT'S THE PEOPLE'S PARK. WHEN I HEAR PEOPLE SAY THERE WAS A

SURVEY OF A FEW THOUSAND PEOPLE. I DISREGARD THAT BECAUSE WE'RE
A CITY OF OVER 780,000 PEOPLE. AND 780,000 PEOPLE OWN THE PARK.

IT'S THEIR PARK. WHETHER THEY'RE 10 TIMES A MONTH OR ONCE A YEAR
OR ONCE EVERY THREE YEARS, AT THE SAME DAY THEY HAVE THE SAME

EQUAL RIGHTS AND SHOULD HAVE THE SAME EQUAL ACCESS TO A PIECE OF
PROPERTY THAT BELONGS TO THEM AND THE CITY AS A WHOLE. PRE
PANDEMIC WORKED FOR CHEROKEE PARK AND WE OUGHT TO GO BACK TO
THAT AND BECAUSE OF THAT I'LL BE A NO MOTION. THANK YOU,

>> I'M GOING TO VOTE YES AND WOULD LIKE TO EXPLAIN WHY. COUNCIL
WOMAN GEORGE SAID SOMETHING DURING THE SPECIAL HEARING THAT WAS
SO PROFOUND. SHE TALKED ABOUT HOW ADVOCACY GROUPS AND
SPECIFICALLY TWO ADVOCACY GROUPS I'M SURE SHE'LL MENTION DID NOT
EXPRESS CONCERN AROUND ACCESSIBILITY. AND THAT PIQUED MY
INTEREST BECAUSE I GOT UP HERE I WAS IN AN ADVOCACY GROUP AND
STILL IN AN ADVOCACY GROUP AND IF WE'RE TALKING ABOUT POLICE
ISSUES YOU'LL PROBABLY HERE ABOUT THE 490 PROJECT AND IF WE HEAR
ABOUT HOMELESS YOU'LL HEAR FROM ADVOCACY GROUPS AND WE TALKED
ABOUT THE CIGAR BAR AND THERE WAS A LONG EXHAUSTIVE LIST OF

PEOPLE WHO WERE PUSHING AGAINST THAT. THEY WERE ADVOCATES FOR THEIR SPECIFIC ISSUE. WHEN SHE TALKED ABOUT ADVOCACY GROUPS NOT EXPRESSING CONCERNS AROUND ACCESSIBILITY IT MADE THE THINK WITH THE CONSTITUENTS HAVE WITHIN THE WHEELCHAIR PART OF ANOTHER ADVOCACY GROUP SHE DIDN'T MENTION THE LOUISVILLE DISABILITY COALITION AND THEY HAVE NOT SAID A WORD EXPRESSED ANYTHING AND I UNDERSTAND WE'RE ALL COMPASSIONATE HERE BUT I WANT US TO FOCUS ON THE FACTS AND NOT VOTE BASED ON FICTION. WHEN YOU LOOK AT THE SURVEY RESULTS PARK USAGE WENT UP FOR A WIDE VARIETY OF PEOPLE FROM LOUISVILLE. THE CONCEPT OF THE PARK BEING INACCESSIBLE NOT TRUE AND HEARING FROM COLLEAGUES NOT DEALINGS WITH DISABILITY ISSUES FOR THE PEOPLE YOU'RE CLAIMING TO SPEAK FOR, HAVE NOT REACHED OUT TO ME. I DON'T NO IF THEY'VE REACHED OUT TO YOU BUT I HAVE NOT SEEN THAT ADVOCACY AND OF THE ACTIVIST COMMUNITY AND WANTED TO POINT THAT OUT. I'LL PROUDLY BE VOTING YES AND ENCOURAGE YOU TO VOTE YES AS WELL IF YOU'RE ON THE FENCE. COME OVER TO THIS SIDE.

>> I FIND IT REGRETTABLE SOMETHING AS FUN AND AS EXCITING AS
PARKS HAVE BEEN SO POLARIZING. WHAT IS THE ULTIMATE GOAL OF ANY
TRAFFIC PATTERN? IT SHOULD MAXIMIZE SAFETY TO THE LARGEST NUMBER
OF PEOPLE WITHOUT LIMITING ACCESS TO AMENITIES. AND I THINK IT'S
BEEN CLEARLY DEMONSTRATED FROM THOSE WHO ARE CLOSEST TO THE PARK
AND SPEND THE MOST TIME IN THE PARK THAT AMENITIES ARE NOT
RESTRICTED AND THIS IS DONE IN A WAY THAT MAXIMIZES THIS. THE

SECOND OUESTION TO BE ASKED AND I THINK AGAIN THIS IS NOT JUST RELEGATED TO THIS PARK BUT ANY PARK, IS WHAT IT MEANS TO BE ACCESSIBLE. COUNCIL MEMBER ARTHUR MENTIONED WHO WE'RE NOT HEARING FROM. WE ALL HEARD FROM A LOT OF PEOPLE AND IT WAS MENTIONED DURING THE COMMITTEE WE'VE NOT HEARD OPPOSITION FROM THE COMMISSION FROM PERSONS WITH DISABILITY OR FROM THOSE FROM ACCESSIBLE LIVING AND THERE'S REASONS FOR THAT. I WANT FOLKS TO THINK ABOUT WHO WE'RE NOT HEARING FROM. I HAVE THE RIGHT TO DRIVE MY CAR WHEREVER I WANT SIMPLY BECAUSE I PAY TAXES. I ALSO ENJOY THE RIGHT TO BE SAFE IN THE PARK AND HAVE A QUALITY EXPERIENCE AND NOT HAVE TO PICK UP BEER CANS AND GARBAGE WHICH I FIND TO BE THE CASE IN A DIFFERENT PARK. THE THIRD THING I WANT TO THINK ABOUT IS WHO IS MAKING THESE DECISIONS AND WHO SHOULD BE MAKING THESE DECISIONS? I'M NOT SO SURE COUNCIL MEMBERS SHOULD BE MAKING THESE DECISIONS. I KNOW THAT'S PROBABLY GOING TO BE AN UNPOPULAR THING TO SAY BUT I THINK WE HAVE A RESPONSIBILITY TO LISTEN TO THOSE CLOSEST TO THE ISSUES WE HAVE A RESPONSIBILITY TO LISTEN TO THOSE CLOSEST TO THE ISSUE AND NOT CLOSEST TO THE PARK BUT FOR FOLKS WHO UTILIZE THE PARK AND SPEND THE MOST TIME THERE AND UNDERSTAND THE LOGISTICS OR FOR THOSE WHO TAKE CARE OF THE STAFF. THEY HAVE A ROLE AND A VOICE AND WE SHOULD BE LISTENING TO THEM. I SPEND A HEALTHY AMOUNT OF TIME RUNNING THROUGH THE PARK BUT IT IS NOT MAI MY PARK. IF SOMEONE ASKED ME FOR SUGGESTIONS ON LOGISTICAL CHANGES I COULDN'T TELL

YOU. WHEN I'M THERE I CHECK OUT AND RUN AND NOT NECESSARILY

FAMILIAR WITH THAT. I SHOULDN'T BE THE PERSON MAKING THOSE

OPEN AND THAT'S IT'S OWN CONVERSATION. WITH THAT I'LL BE

SUPPORTING THIS AND ENCOURAGE ALL TO DO THE SAME.

>> I HAVE TO RESPECTFULLY DISAGREE WITH COUNCIL MEMBER GEORGE. I
BELIEVE CHEROKEE PARK IS MY PARK AND HAYES KENNEDY PARK IS MY
PARK AND TO SAY ONE PARK IS ONE COUNCIL PERSON'S PARK OR
RESIDENCE IS RIDICULOUS. LOOK, I USED TO LIVE CLOSE TO CHEROKEE
PARK AND WHO'S TO SAY CONNECTIVITY IS NOT PERSON. I USED TO
DRIVE TO IT TO GET TO 64 BECAUSE I LOVE GOING THROUGH THE PARK.
SOMETIMES IT'S BY CAR. THE SIMPLE TRUTH IS A LOT OF PEOPLE GO
THROUGH THE PARK FOR THE BEAUTY AND THEY SHOULD HAVE A RIGHT TO
DO THAT. I AM ON THE COMMISSION ON PERSONS WITH DISABILITIES AND
NO, THE COMMISSION HAS NOT WEIGHED IN HOWEVER, I HAVE RECEIVED
SEVERAL E-MAILS FROM PEOPLE THAT ARE DISABLED ENCOURAGING ME TO

VOTE NO ON THIS ORDINANCE AND THAT'S WHAT I PLAN TO VOTE. THANK YOU.

>> COUNCIL MEMBER KRAMER.

>> THANK YOU, MR. PRESIDENT. I WANT TO ASK THOSE COLLEAGUES OF MINE WHO HAVEN'T MADE UP THEIR MINDS IF THEY WOULD PLEASE CONSIDER THE THOUGHT I HAVE TO OFFER AND WOULD LOVE FOR THEM TO JOIN ME IN MY VOTE. IT IS INTERESTING TO ME AS I LISTEN TO FOLKS TALK ABOUT ACCESSIBILITY AND I THINK WE WERE TALKING ABOUT ANY OTHER ISSUE OF ACCESSIBILITY WE WOULD SHAKE OUR HEADS AND SAY --THE CLAIM IS WELL, 90% OF THE LOOP IS STILL OPEN SO THEY HAVE ACCESSIBILITY TO MOST OF IT AND EVEN IF THEY CAN'T USE THE WHOLE THING THERE'S PLENTY OF OTHER AMENITIES. I CAN'T IMAGINE SAYING TO A GROUP OF PEOPLE WE LEFT OPEN THE AMENITIES TO YOU, WHAT ARE YOU COMPLAINING ABOUT. YOU CAN'T JUST USE THE ONE. THIS IS THE ONE WE'VE CHOSEN FOR YOU NOT TO BE ABLE TO USE. IT AMAZES ME WE CAN SAY THAT TO PEOPLE ON THE COUNCIL AND PEOPLE IN THE COMMUNITY CAN SAY THAT WITH SUCH EASE. WE'RE DENYING ACCESS TO AMENITIES TO A GROUP OF PEOPLE AND TO SAY IT DOESN'T DENY AMENITIES THAT'S ANOTHER THING THAT'S INTERESTING. THE LOOP ITSELF IS AN AMENITY. TOES NOT ABOUT SOCCER FIELD. THE PEOPLE WANTING TO DRIVE THROUGH THE LOOP WERE DRIVING THROUGH. COUNCIL MEMBER REED SAID HOMESTEAD [INDISCERNIBLE] WHEN THEY DEVELOPED THESE I SHOULD HAVE WRITTEN DOWN THE QUOTE BUT IT WAS AN

OPPORTUNITY FOR PEOPLE TO GET AWAY FROM THE CRAZINESS OF THE WORLD WE'RE IN AND GRANTED THERE WERE NO PARKS JUST CARRIAGES AND HORSES BUT THE IDEA WAS THIS WOULD BE A PLACE THAT SOMEONE COULD GAIN SOME RESPITE FROM THE WORLD WE STRUGGLE IN AND OUR LIVES ARE CRAZY AND I WOULD ARGUE THEY'RE MORE CRAZY THAN THEY WERE. TO COUNCIL MEMBER REED'S POINT, IF YOU WANT TO REDUCE THE SPEED LIMIT TO 15 MILES AN HOUR AND PUT BARRIERS BETWEEN MYSELF AND THE FOLKS WALKING OR RIDING A BIKE OR FIND A WAY TO ENHANCE SAFETY I DON'T HAVE A PROBLEM WITH THAT. IF I HAVE A CRAZY DAY AND HAVE AN EXTRA 30 MINUTES IN MY DAY AND GOING FROM POINT A TO POINT B AND CAN GET THERE IN SO MINUTES OR TAKE A DIVERSION THROUGH THE PARK OR TAKE ADVANTAGE OF AN AMENITY THAT WAS HANDED DOWN TO MY GENERATION FROM PREVIOUS GENERATIONS, AN AMENITY I WOULD THINK IS AVAILABLE TO MY CHILDREN AND GRANDCHILDREN, THAT TO ME SEEMS LIKE A REALLY SIGNIFICANT AMENITY. AND I'VE DONE THAT. MAYBE I'VE DRIVEN THROUGH THERE TOO QUICKLY, I SUPPOSE. I DON'T THINK SLOWING IT FROM 25 TO 15 IS NECESSARILY A BAD IDEA BUT THAT'S NOT WHAT WE'RE TALKING ABOUT. WE'RE SAYING YOU CAN'T USE IT. IT FEELS LIKE WE'RE SAYING TO PEOPLE, YOU MAY BE A RESPONSIBLE USER OF THIS PARK, YOU MAY BE USING IT EXACTLY THE WAY HOMESTEAD DESIGNED IT. IT MAY BE PRECISELY WHAT YOU NEED IN THIS HUSTLE, BUSTLE CRAZY WORLD WE LIVE IN BUT BECAUSE THERE ARE OTHER PEOPLE WHO DON'T BEHAVE RESPONSIBLY, BECAUSE THERE ARE SOME PEOPLE WHO AREN'T WILLING TO USE THE AMENITY THE WAY IT WAS

DESIGNED, WE'RE GOING TO CLOSE THE AMENITY OFF TO EVERYONE INCLUDING YOU AND IT'S OKAY BECAUSE WE'RE ONLY CLOSING OFF A SMALL PART AND YOU CAN GET THAT SOMEWHERE ELSE. YOU REALLY CAN'T. IT AMAZES ME IT SEEMS LIKE IT'S TO SAY TO A GROUP OF PEOPLE. MY LAST COMMENT I THINK IT'S INTERESTING WE HAVE COUNCIL MEMBERS ARGUING THAT IF I'M NOT AN ACTIVIST MYSELF OR DON'T ENGAGE IN ACTIVIST WHAT'S IMPORTANT TO ME DIDN'T MATTER BECAUSE I DIDN'T REACH OUT TO THE RIGHT PEOPLE OR SAY THE RIGHT THINGS IN THE RIGHT CROWD OR ENGAGE IN THE PROPER SURVEY. THAT'S NOT MY UNDERSTANDING OF HOW GOVERNMENT WORKS AND THERE'S 26 OF US ELECTED TO PAY TAKES TO TRY TO FIGURE OUT AND MAKE THE BEST DECISIONS FOR ALL OF THE CITIZENS OF OUR COMMUNITY. NOT JUST THE MOST VOCAL, NOT JUST THE ONES THAT HAVE THEIR OWN DESIRES THAT THEY WANT TO PROTECT, BUT TO RECOGNIZE AND UNDERSTAND WHY HOMESTEAD DESIGNED THE PARK THE WAY IT DID, WHAT THE AMENITY TRULY MEANS AND HOW TO BE USED AND HOW TO BALANCE THAT WHERE EVERYBODY CAN BENEFIT INSTEAD OF SAYING THESE ARE THE WINNERS AND THESE THE LOSERS. I'LL ASK MY COLLEAGUES IF YOU HAVEN'T DECIDED YET, PLEASE CONSIDER CREATING WINNERS AND LOSERS INSTEAD OF SEEKING A TRUE COMPROMISE.

- >> THANK YOU, COUNCIL MEMBER. COUNCIL MEMBER FOWLER.
- >> THANK YOU, MR. PRESIDENT. YOU KNOW WHAT BROTHERS ME IS WE'RE AGAIN USING COVID AS A REASON TO REDUCE AMENITIES IN OUR CITY

AND IT JUST DON'T MAKE SENSE. IT DID DURING THE HEIGHT AND NOW WE MIGHT BE IN THE HEIGHT RIGHT NOW BUT WE'RE NOT REDUCING ANYTHING. WE'RE NOT STOPPING PEOPLE FROM GOING INTO THE PARK. PARK USAGE WAS UP EVERY WHERE ACROSS THE CITY. SHOULD WE CLOSE THOSE ROADS TOO? MAYBE, I DON'T KNOW. WELL, I DO KNOW, I DON'T THINK IT'S RIGHT. WHAT ABOUT VISITORS TO OUR CITY WHO MAY NOT IN ABLE TO WALK, BIKE, HIKE, SKATE. THEY COMPLETELY MISS THE WHOLE EXPERIENCE OF THAT PARK BECAUSE OF WHAT I FEEL LIKE IS SELFISHNESS. I THINK IT'S VERY SELFISH TO EXCLUDE A WHOLE GROUP OF CITIZENS, DISABLED PEOPLE, PEOPLE THAT MAY OR MAY NOT BE ABLE TO PHYSICALLY MAKE IT TO THOSE SECTION ARE CLOSED WHAT ARE WE DOING? SERIOUSLY, I DON'T KNOW. IT DOESN'T MAKE SENSE WHAT WE ARE DOING AND THINK TRASH IN A PARK IS A REASON TO CLOSE ROADS. ARE WE NOT THE DECISION MAKERS. WITH IF WE PUT THIS TO A VOTE I THINK WE KNOW WHAT THEY'D VOTE FOR AND WE HAVE TO THINK OF THOSE WHO MAY OR MAY NOT BE ABLE TO GET IN THE PARK AND USE IT TO ITS FULLEST. I'M ALL FOR BIKING. I LOVE TO RIDE MY BIKE. I WISH I COULD JOG BUT I CAN'T. IT WOULD BE WONDERFUL THOUGH IF WE HAD A WORLD IF WE HAD A PATH SURROUNDING OUR CITY AND SOME ARE NOT FULLY COMPLETED YET BUT WE HAVE THE LOUISVILLE LOOP FOR GOODNESS SAKE. IT'S CRAZY TO CLOSE ROADS WHEN ALL PAY FOR THE AMENITIES AN I'LL BE A NO VOTE FOR THAT REASON.

>> I WANT TO THANK EVERYBODY FOR THEIR PASSION ON BOTH SIDES OF THE ISSUE. I THINK CERTAINLY APPRECIATE COUNCIL WOMAN CHAMBERS ARMSTRONG CONCERN FOR THE COMPROMISE SHE TRIED TO WORK OUT HERE. I WILL SAY I WILL BE A NO VOTE PARTICULARLY FOR THIS REASON. THERE ARE PEOPLE WHO WANT TO ACCESS ALL KINDS OF ROADS. WE HAVE ROADS ACROSS THE CITY AND WE HAVE SIDEWALKS WHERE IT'S SAFER FOR PEOPLE TO RIDE THEIR BIKE OR WALK. SHOULD WE CLOSE TRAFFIC IN THOSE NEIGHBORHOODS? IT WOULD SLOW SPEED AND HAVE ONE WAY TRAFFIC. WE HAVE A HUGE PROBLEM WHERE I REPRESENT IN ANCHORAGE WHERE THERE'S LOTS OF CUT-THROUGH TRAFFIC INSTEAD OF PEOPLE USING WEST PORT ROAD OR THE GENE SNIDER THEY'RE CUTTING TO GET TO LENDEN TO GET TO 64. SHOULD WE CLOSE THOSE ROADS? WE HAVE LOTS OF NEIGHBORHOODS WHERE WE HAVE NEIGHBORHOOD STREETS SO THEY CAN CUT TIME OFF TRAFFIC. AND SHOULD WE CLOSE THOSE? I APPRECIATE THE POSITION AND WORK THAT'S GONE IN THIS. I DON'T THINK WE SHOULD GO THAT WAY. THANK YOU.

>> COUNCIL MEMBER MULVHILL.

>> THANK YOU, MR. PRESIDENT. I HAVE AND IT'S PROBABLY A QUESTION FOR THE SPONSOR BUT IT'S A QUESTION/COMMENT. I'VE LISTENED TO DEBATE TONIGHT AND KEEP HEARING WE HAVE 780,000 RESIDENTS, WHICH WE DO, AND THERE'S NO WAY TO HEAR FROM 780,000 PEOPLE. BUT I ALSO KNOW WE ADOPTED AN ORDINANCE MAYBE WE TO OR DIDN'T MEAN TO AND GAVE OURSELVES A TIGHT DEADLINE TO KEEP A PATTERN OR NOT. WE

HAD TO PUT A LOT TOGETHER IN A SHORT TIME WHETHER IT'S SURVEYS

OR MEETINGS. CAN THE SPONSOR TALK A LITTLE BIT ABOUT BECAUSE I

KNOW AS BILL HOLLANDER MENTIONED AND HAS BEEN INVOLVED. CAN YOU

TALK ABOUT THE PUBLIC ENGAGEMENT WITH FOLKS YOU DID MEET WITH

AND SURVEY AND THE FOLKS WHO REPRESENT THEM? COUNCIL WOMAN.

>> THE COMMUNITY MEETINGS BEGAN IN THE SPRING IN MARCH AND WE HAD A VIRTUAL PUBLIC MEETING BACK WHEN EVERYONE WAS DOING AND IN THAT WAS IN CONJUNCTION WITH THE PARKS DEPARTMENT. WE HAD A SEPARATE COMMUNITY FORUM AROUND EOUITY AND ACCESSIBILITY AND INVITED PEOPLE WITH PARTICULAR EXPERTISE TO COME AND SPEAK TO MAKE SURE WHATEVER OPTIONS WERE ON THE TABLE WERE NOT LIMITING CHEROKEE PARK JUST TO THE RESIDENTS OF CHEROKEE PARK BECAUSE I DO BELIEVE IT'S AN AMENITY FOR THE CITY AS A WHOLE AND WE'RE BEING MINDFUL OF THE COMPLEXITIES OF DISABILITY AND MAKE SURE EVERYBODY CAN ENJOY THE PARK AND IT MAXIMIZE THE RANGE OF PEOPLE WITH DISABILITIES AND DIFFERENT TYPES OF DISABILITIES TO ALL BE ABLE TO TAKE ADVANTAGE OF CHEROKEE PARK. I HAD OFFICE HOURS AT THE PARK WHERE PEOPLE WERE ALLOWED TO SIGN UP WITH ONE-ON-ONE SLOTS AND SMALL GROUP SLOTS AND I SAT OUTSIDE THE GOLF COURSE AND SPOKE TO MEMBERS OF THE COMMUNITY. WE HAD OUR IN-PERSON PUBLIC MEETING AND I WOULD SAY I'VE CONTINUED TO HEAR FROM RESIDENTS AND NON RESIDENTS AND SERVED AS A POINT OF CONTACT BECAUSE THE PARK IS IN MY DISTRICT. I'M CERTAINLY NOT UNDERESTIMATING WHEN I SAY I TALKED TO AT LEAST 500 PEOPLE

PERSONALLY ABOUT THIS. I TALKED TO A SWATH OF THE CITY AND PEOPLE WITH ALL SORTS OF DISABILITIES THAT HAVE ALL SORTS OF OPINION AND IN DIFFERENT ZIP CODES WHEN I TALK ABOUT YOUTH IN PUBLIC SPACES OUR JOB IS TO MAXIMIZE THE MOST PEOPLE WITH THE MOST NEEDS ENJOY THE PARK WITH A SPECIAL MIND TO MARGINALIZED COMMUNITIES THAT MIGHT NEED SOME SPECIAL ATTENTION WHEN WE'RE MAKING THE DECISIONS AND I BELIEVE THAT'S ALWAYS BEEN THE CENTER OF THIS COMPROMISE. WHEN I TALK TO THE PARENTS WITH YOUNG KIDS AND TALK TO PARENTS WITH KIDS WITH PROCESSING ISSUE, IS IT FAIR THEY DON'T HAVE ANYWHERE ON THE LOOP WHERE THEIR CHILDREN AREN'T EXPOSED TO LOUD MOTORCYCLES OR NOISY VEHICLES AND IS IT FAIR FOR PEOPLE WITH THAT TYPE OF DISABILITY THERE'S NO SPACE ON THE SCENIC LOOP. I UNDERSTAND PEOPLE HAVE DIFFERENT VIEWS. I APPRECIATE EVERYONE'S ROBUST CONVERSATION AND DEBATE. I DO WORRY ABOUT THE SEPTEMBER 1 DEADLINE. TO BE HONEST, THERE'S ALREADY BEEN SIGNIFICANT STRIPING AND IMPROVEMENT. WHEN THE TRAFFIC PATTERN CHANGED TO TEST THE COMPROMISED DESIGN IT TOOK WEEKS FOR PEOPLE TO GET IT RIGHT AND FOR THE PUBLIC TO HAVE NOTICE EVEN WITH STRIPING CHANGES AND LARGE SIGNS I WORRY A DECISION TONIGHT ON THE SEPTEMBER 1 DEADLINE WILL CREATE A SAFETY CONCERN IN THE DISTRICT AND NOT GIVE THE PUBLIC ENOUGH NOTICE TO ADEQUATELY ADJUST. SO I HOPE IF COUNCIL DECLINES TO APPROVE THE COMPROMISED PLAN, I HOPE WE'LL BE WILLING PARTNERS WITH THE PARKS DEPARTMENT AND PUBLIC WORKS WHO HAVE PUT A LOT OF EFFORT INTO MAKING THE

ACTUAL PHYSICAL ENVIRONMENT CHANGES TO MAKE THE COMPROMISE

POSSIBLE WILLING TO GIVE THEM EVERY RESOURCE THEY NEED TO

QUICKLY INFORM THE PUBLIC AND MAKE SURE THE TRANSITION HAPPENS

SAFELY. THANK YOU.

I ASKED WHAT'S BEEN THE RESULT OF THE CHANGE AND IN 2019 THERE WERE 93 COLLISIONS. THEY DIDN'T GET SPECIFIC ABOUT PEDESTRIAN AND CAR, BICYCLE-CAR AND CAR AND CAR. THEY DIDN'T HAVE THAT INFORMATION BUT THAT'S NOW IN 2020 IT WAS 44. I WANTED TO PUT THAT ON THE RECORD AS WELL. THANK YOU.
- >> THANK YOU, COUNCIL MEMBER. I JUST WANT TO MAKE SURE WE'RE

 ACCURATE ABOUT THE RECORD. COUNCIL MEMBER FLOOD ACTUALLY WENT

 AND GOT INFORMATION FROM LMPD THAT HAS DIFFERENT NUMBERS IN IT.

 COULD YOU TALK ABOUT THOSE NUMBERS?
- >> I DON'T KNOW IF I CAN PULL UP THE E-MAIL AND Y'ALL STILL SEE ME. CAN YOU STILL SEE ME?
- >> YES, MA'AM.
- >> I DIDN'T KNOW YOU WERE GOING TO CALL ON ME RIGHT NOW OR I
 WOULD HAVE HAD IT PULLED UP. MY E-MAIL TO METRO POLICE
 DEPARTMENT ACCIDENT REPORT. I ASKED INFORMATION CONCERNING

CHEROKEE PARK FROM DECEMBER 1 TO 2019 TO DECEMBER AND JANUARY
AND DECEMBER 31 OF 2020. THEY CAME BACK WITH AND SAID IT CAME
FROM THE STATE POLICE AND MY PARAMETERS WERE TO LINE OUT VEHICLE
ACCIDENTS VEHICLE VERSUS VEHICLE AND VEHICLE VERSUS PEDESTRIAN
AND VEHICLE VERSUS BICYCLE AND BICYCLE VERSUS PEDESTRIAN AND
WHAT THEY SENT BACK TO ME WAS A SHEET THAT SAID THERE WERE 2019

- >> THANK YOU, MR. PRESIDENT. I ONLY HAVE A SMALL THING TO SAY. I WISH THEY [INDISCERNIBLE] INTEREST IN THE PARK AND LOW INCOME AREA AS THEY PUT IN OTHER PARKS AND HOMESTEAD PARK. AT MY PARK WE WEREN'T GIVEN A CHANCE. WE WEREN'T GIVEN ALL KINDS OF DIFFERENT THINGS THEY PUT IN PUBLIC MARKS. I KNOW THEY PUT [INDISCERNIBLE] AND CHEROKEE PARK AND ALL THAT. THEY DON'T PUT ANYTHING IN NEWBURY PARK AND IT'S A LOW-INCOME AREA. WE SIT HERE ARGUING ABOUT ALL THE DIFFERENT THINGS FOR THIS OUT IN THE HIGHLAND BUT WE DON'T GET ANYTHING IN THE PARK OUT THERE AND SO I WILL BE VOTING NO. I WANT TO SAY THAT.

- >> THANK YOU, MR. PRESIDENT. I WANTED TO ASK COUNCIL WOMAN FLOOD
 ABOUT HER REPORT. SHE SAID IT WAS DIFFERENT FROM THE PARKS
 DEPARTMENT. CAN YOU TELL ME WHO HAD MORE ACCIDENTS REPORTED WAS
 IT THE POLICE OR PARKS DEPARTMENT?
- >> WELL, THEY SAID BOTH PARKS AND THE LMPD SAID THEY PICKED
 THOSE BECAUSE THE STATE POLICE ARE THE ONES WHO ARE THE OFFICIAL
 RECORD KEEPER OF TRAFFIC ACCIDENTS NO MATTER WHAT IT IS. AT THE
 MEETING IT WAS REPORTED THERE WAS 93 ACCIDENTS IN 2019 AND IN
 2020, 44 ACCIDENTS.
- >> I WANT TO MAKE A COMMENT LISTENING TO THE DEBATE AND I THINK

 I HAVE HAD A CHANGE OF HEART HOW I WANT TO VOTE -- UM, AND I

 HAVE TO BRING THIS UP. I HAVE TO MENTION THIS. HISTORY TELLS ME

 A LOT, AND FROM WHAT WE HAVE BEEN SEEING IN THE PAST THREE YEARS

 WITH RACISM, AND THE SOCIAL INJUSTICE HERE IN THE CITY, I

 DEFINITELY AS AN AFRICAN AMERICAN FEMALE, I DON'T WANT TO ADD

 TO, I AM VERY PROTECTIVE WITH WHAT GOES ON WITH RACE RELATIONS

 AND I JUST HAVE TO BE LET IT BE KNOWN THAT WHEN CHEROKEE

 PARK -- LOOKS LIKE WHEN IT WAS DESIGNED, CHEROKEE PARK WAS A

>> I THINK COUNCILWOMAN ARMSTRONG DID THE YEOMAN'S WORK TRYING TO SORT OUT THIS ISSUE. WELL DONE. THE QUESTION ABOUT DISABILITY, THOSE THAT HAVE ISSUES ON THE AUTISM SPECTRUM OR ISSUES, THERE ARE FOUR MILES OF TRAILS AT CHEROKEE PARK, NOT TO MENTION A CRAZY AMOUNT OF OPEN SPACE THAT ANYBODY HAS ACCESS. THERE ARE EXISTING OPTIONS FOR THOSE THAT ARE AMBULATORY. IF BEING NOT THE AMBULATORY IS NOT THE ISSUE OR SENSORY ISSUES, FOUR MILES OF TRAILS AND A TON OF OPEN SPACE AND HAVE AT IT. THE ONLY PLACE THAT SOMEBODY WITH AN AMBULATORY ISSUE HAS ACCESS TO. THEY WENT GET OUT AND ACCESS THE TRAILS OR USE THE OPEN SPACE. REGARDING THE SEPTEMBER 1ST DEADLINE, JUST A HISTORY LESSON ON THE EVOLUTION OF THE ORIGINAL ORDINANCE, AGAIN TO BE CLEAR, WE ARE AMENDING THE ORDINANCE THAT WE PASSED UNANIMOUSLY GIVING BACK THE MAYOR POWER THAT WE TOOK AWAY FROM HIM. WE ARE NOT APPROVING A PLAN FOR CHEROKEE PARK. IT WAS COUNCILWOMAN WHO SET THE SEPTEMBER 1ST DEADLINE. ADOPTED WHOLEHEARTEDLY. THIS ISN'T A DATE THAT SNUCK UP ON SOMEBODY. THE ADMINISTRATION AND OTHERS HAVE SEEN IT COMING AND HAD TIME TO PREPARE. WHAT'S FRUSTRATING THEY WAITED SEVERAL DAYS BEFORE SEPTEMBER 1ST TO BRING IT TO COUNCIL FOR A VOTE. I JUST WANT TO CLARIFY ON THE RECORD FOR THAT. THANK YOU, MR. PRESIDENT.

- >> I HAVE RECEIVED JUST LIKE THE REST OF MY COLLEAGUES QUITE A FEW EMAILS AND PHONE CALLS REGARDING THIS ISSUE. I WORKED VERY, VERY HARD IN LISTENING TO MY CONSTITUENTS IN DISTRICT 7, PLUS I REACHED OUT EARLIER, I THINK IT WAS YESTERDAY OR THE DAY BEFORE, TO ASK POINTED QUESTIONS. THE MAIN CONCERN I HAD WAS ABOUT THE TRAFFIC STUDY THAT WAS SENT, AND I HAD QUESTIONS AND I WANTED TO KNOW HOW TO INTERPRET THE RESORT. AND BASICALLY, IT TOOK A DAY OR SO BEFORE SOMEONE WOULD GET BACK TO ME. SO I FOLLOWED UP AND I ASKED FOR THE TRAFFIC REPORT, THE ACCIDENT RATE IS WHAT I ASKED FOR FOR VEHICLES, NOT BICYCLES, BUT VEHICLES. SO I FINALLY GOT SOMETHING FROM ONE OF THE MAYOR'S ADMINISTRATION EMPLOYEES AND IT WAS JUST RAW DATA. AND SO I REPLIED WITHOUT INTERPRETATION, I AM LEFT TO MY OWN INTERPRETATION. WITHOUT COMMENTARY, I AM LEFT WITH MY OWN INTERPRETATION. AND THEN I ASKED COUNCILWOMAN CHAMBERS, WHO I JUST HAVE TO COMMEND ON DOING A YEOMAN'S JOB OF TRYING TO MOVE THIS ISSUE FORWARD, TO REACH

ALTER ACCESS TO SEXUAL ASSAULT VICTIMS IN OUR COMMUNITIES. THIS CONTRACT AS COUNCILMAN PIAGENTINI SAID IT'S FOR OUR SEXUAL ASSAULT NURSE EXAMINERS IT'S A PROGRAM RUN THROUGH THE UNL HOSPITAL DEDICATED EXPERT NURSES PROVIDE 24-7 AROUND THE CARE ACCESS TO VICTIMS OF SEXUAL ASSAULT AND DOMESTIC VIOLENCE. THE SAME NURSES ARE NATIONALLY RECOGNIZED AS THE GOLD STANDARD IN THE CARE THAT THEY PROVIDE. EVERY ONE OF THEM IS A REGISTERED NURSE WITH 100 ADDITIONAL HOURS OF TRAINING AND FORENSIC NURSING CARE, SEVERAL MONTHS OF ON-THE-JOB TRAINING AND THEY SEE MORE THAN 700 VICTIMS ANNUALLY. RECENTLY THEY EXPANDED THEIR SERVICES TO MAKE SURE EVERYONE CAN RECEIVE ON-SITE CARE AND ALL OF THE EXAMS ARE REVIEWED BY AMANDA WHO IS IN THE GALLERY TODAY AND NURSE MANAGER VICKI, FOR ACCESSORY. AMANDA AND VICKI HAVE WORKED WITH MORE THAN A THOUSAND VICTIMS OF SEXUAL ASSAULT AND DOMESTIC VIOLENCE IN THEIR CAREER AND AMANDA HAS SERVED AS MANAGER FOR MORE THAN SIX YEARS AND IS RECOGNIZED AS AN EXPERT IN THE COMMUNITY IN THE STATE. HER WORK IS RESPECTED AND THE WORSE OF THE NURSES IS RELIED ON BY OUR POLICE FORCE WHO REGULARLY CALL THEM AS EXPERT WITNESSES IN CRIMINAL TRIALS. IN FACT, VICKI TESTIFIED IN A CASE LAST WEEK THAT RESULTED IN CONVICTIONS FOR MURDER ONE AND WANTON ENDANGERMENT AND ASSAULT IN A SEXUAL ASSAULT CASE. MY CONCERN IS WITHOUT HEARING MORE AND EXPLORING THE CHANGE, THE NEED FOR PURPOSE AND DRIVING THIS CHANGE, WILL LIMIT THE NUMBER OF PATIENT WHO NEED ACCESS FOR FORENSIC CARE

WHEN THEY NEED IT. WHEN SOMEONE IS COMING IN THAT'S A VICTIM OF SEXUAL ASSAULT, THEY WILL LIKELY BE GOING IN TO AN EMERGENCY ROOM AND WE ARE HEARING ON THE NEWS RIGHT NOW HOW OUR EMERGENCY PHYSICIANS ARE STRETCHED PARTICULARLY THIN. PERSONALLY, I DON'T HAVE ANY SINCE WHAT REQUISITE TRAINING AND SPECIALIZED CARE THAT VICTIMS OF SEXUAL ASSAULT NEED AND EXIST IN THE COMMUNITY. I WORRY WITHOUT AN OPPORTUNITY TO HEAR MORE FROM THE NURSES AND HEAR HOW THE COMMUNITY IS IMPACTED AND HOW THIS COULD AFFECT THE CARE THAT WE ARE PROVIDING TO VICTIMS OF SEXUAL ASSAULT AND DOMESTIC VIOLENCE IN OUR COMMUNITY, I WORRY THAT WE WILL BE MAKING A DECISION WITHOUT FULLY UNDERSTANDING THE CONSEQUENCES. FOR THAT REASON, I WOULD ASK MY COLLEAGUES VOTE NO UNLESS WE PROVIDE AN OPPORTUNITY TO SEND THIS TO COMMITTEE AND HAVE A PROPER DISCUSSION ABOUT IT. THANK YOU, MR. PRESIDENT.

>> THANK YOU. SO THIS ACTUALLY CAME FROM LMPD SURGEON, HIS NAME IS DR. SMOCK. SO SOME OF THE MEMBERS OF LMPD, INCLUDING THE HOMICIDE INVESTIGATION UNIT AND DERIVATIVE MET WITH THE DOCTOR. THEY REVIEWED A CASE TO GIVE YOU A SPECIFIC EXAMPLE, A CASE FROM NORTON WHO WAS INITIALLY SEEN BY ONE OF THE SAME NURSES. WHAT HE DISCUSSED WAS THE NEED FOR A PEER REVIEW FORENSIC COURT. THE FORENSIC NURSE MISIDENTIFIED A WOUND AS LACERATION, WHICH IT WAS A WOUND FROM AN EDGED IMPLEMENT. THE THERE WAS CONCERNED VICKI ATTEMPTED TO DISCOURAGE HER FROM INVESTIGATION OF A CASE FROM POSSIBLE SEXUAL ASSAULT, DR. SMOCK INDICATED THE PROGRAM PROVIDES A TREMENDOUS SERVICE TO THE COMMUNITY. IF I THOUGHT THAT WASN'T THE CASE, I WOULD VOTE AGAINST THIS WHOLE THING AND I WOULD HAVE IN COMMITTEE, BUT THIS IS A WAY TO ENSURE THAT THE WORK IS BEING DOUBLE CHECKED BY FORENSIC EXPERTS AND PHYSICIANS. AGAIN, THIS CAME FROM SURGEONS AND OTHER MEDICAL PROFESSIONAL DOCTORS WHO ARE FAMILIAR WITH THE PROGRAM IN ORDER TO ENSURE THAT THESE ARE ACCURATE AND THEY ACTUALLY HAVE HAD AT LEAST ONE EXAMPLE THAT'S ALREADY BEEN PROVIDED IN WHICH THERE WAS A MISTAKEN CALL MADE. AGAIN, THIS IS A WAY TO ENSURE THAT WE HAVE LESS OPPORTUNITY FOR THOSE MISTAKES TO BE MADE. AGAIN, THIS IS NOT AN INDICTMENT. THINK ABOUT HOW MUCH TALK WE HAVE HAD OF POLICE REFORM AND CHECKS AND BALANCES ON THE OVERALL PUBLIC SAFETY SYSTEM. THIS IS ONE SMALL ONE AND I WOULD ARGUE IT IS TREMENDOUSLY COMMON IN THE MEDICAL FIELD TO HAVE MEDICAL

DECISIONS DOUBLE CHECKED, PARTICULARLY ONES THAT HAVE THE WEIGHT THAT THESE ANALYSES HAVE. SO THAT'S WHY IT DID COME FROM LMPD AND SURGEONS AND DOCTORS THAT WORK WITH THEM. [INDISCERNIBLE]. THANK YOU, MR. PRESIDENT.
