SECTION 3. That because the applicant has not yet secured full financing for the project or fully completed its site plans, the parcels will be sold at the market value listed above as determined by an appraisal of the parcels.

That the applicant agrees to return the properties back to the Authority should the applicant fail to manage and maintain the properties consistent with Metro's ordinances and regulations or if the applicant is unable to construct a commercial office/warehouse for its business on the properties, such requirement being included and recorded as a deed restriction.
