### **CASE SUMMARY/BACKGROUND**

The applicant is purposing to construct a 2,438 square feet office addition, a parking lot addition and minor changes to the exterior walk and entry area of the multi-purpose buildings.

#### STAFF FINDING / RECOMMENDATION

There are five listed requirements for the private institution use. The applicant will need relief of item C. Based upon the information in the staff report and the testimony and evidence provided at the public hearing, the Board of Zoning Adjustment must determine if the proposal meets the standards established in the LDC for a Conditional Use Permit, Variances, and Waivers.

#### **RELATED CASES**

**B-179-00** An application for a Conditional Use Permit to allow off-street parking in the R-5

zoning district. The case was approved by the Louisville Board of Zoning

Adjustment on September 18, 2000.

**B-180-00** An application for variances to allow existing structures and off-street parking to

encroach into the required yards. This case was approved by the Louisville

Board of Zoning Adjustment on September 18, 2000.

Neighborhood meeting will be held on May 25, 2021 and at least two people attended not including the applicant.

#### STANDARD OF REVIEW AND STAFF ANALYSIS FOR CONDITIONAL USE PERMIT

- 1. Is the proposal consistent with applicable policies of the Comprehensive Plan?
  - STAFF: The proposal meets all applicable policies of the Comprehensive Plan.
- 2. <u>Is the proposal compatible with surrounding land uses and the general character of the area including factors such as height, bulk, scale, intensity, traffic, noise, odor, drainage, dust, lighting and appearance?</u>
  - STAFF: The proposed improvements are compatible with surrounding development and land uses.
- 3. <u>Are necessary on-site and off-site public facilities such as transportation, sanitation, water, sewer, drainage, emergency services, education and recreation adequate to serve the proposed use?</u>
  - STAFF: The subject property is served by existing public utilities and facilities. Transportation Planning and MSD have reviewed the proposal and has comments.

4. Does the proposal comply with the following specific standards required to obtain the conditional use permit requested?

Private institutional uses, except for such uses specifically regulated elsewhere in this LDC, may be allowed in the R-R, R-E, R-1, R-2, R-3, R-4, R-5, and U-N zoning districts upon the granting of a Conditional Use Permit and compliance with the listed requirements:

A. Except in the R-R zoning district, all structures, except fencing, and all off-street parking shall be at least 30 feet from any property line adjacent to an existing residential use or residential zoning district. In the R-R zoning district all structures, except fencing, shall be at least 150 feet from any property line and all off-street parking shall be at least 30 feet from any property line.

The proposed off-street parking/maneuvering will be located along the Lancashire Avenue front property line.

- B. The applicant must demonstrate that the impact of the traffic generated by the use can be mitigated. *A traffic study was not required by Transportation Planning.*
- C. Off-street parking not located within a driveway shall be located to the side or rear of the building(s). The number of required off-street parking spaces shall be determined by the Planning Director in consultation with the Director of Public Works based on the standards for the closest comparable use and on the particular parking demand and trip generation characteristics of the proposed use. The proposed of-street parking/maneuvering will be located in front of the existing school. The addition of off-street parking spaces will allow existing employees to be nearer the office and open up additional spaces on the lot for students/visitors to the site.
- D. All activities shall be in compliance with the Metro Noise Ordinance (LMCO Chapter 99). *The proposal will comply with the Metro Noise Ordinance.*
- E. The Board of Zoning Adjustment may set hours of operation for the institutional use in order to minimize potential negative impacts on surrounding residential properties. *The hours of operation are as follows:*

Parish Office: M-F 8:00-4:30 School: M-F 7:00-2:45 Evening Meetings M-F 6:00-7:00

Mass: M-F Noon/Sat. 4:00/Sun 8:30 & 10:30

Confessions: Sat 2:30-3:30

### 21-VARIANCE-0090 STANDARD OF REVIEW AND STAFF ANALYSIS FOR VARIANCE FROM TABLE 5.3.2

(a) The requested variance will not adversely affect the public health, safety or welfare.

STAFF: The requested variance will not adversely affect the public health, safety or welfare as the parking and maneuvering area will be landscaped in a way that will block the view of residential properties across Lancashire Avenue.

(b) The requested variance will not alter the essential character of the general vicinity.

- STAFF: The requested variance will not alter the essential character of the general vicinity as additional screening will be added along Lancashire Avenue.
- (c) The requested variance will not cause a hazard or nuisance to the public.
  - STAFF: The requested variance will not cause a hazard or nuisance to the public as the flow of traffic will be similar to what exists currently.
- (d) The requested variance will not allow an unreasonable circumvention of the zoning regulations.
  - STAFF: The requested variance will not allow an unreasonable circumvention of the zoning regulations because the encroachment area will have significant screening to block the view of residential properties across Lancashire Avenue.

#### ADDITIONAL CONSIDERATIONS:

- 1. <u>The requested variance arises from special circumstances which do not generally apply to land in the general vicinity or the same zone.</u>
  - STAFF: The requested variance does arise from special circumstances which do not generally apply to land in the general vicinity or the same zone as the site has been developed before the request.
- 2. The strict application of the provisions of the regulation would deprive the applicant of the reasonable use of the land or create an unnecessary hardship on the applicant.
  - STAFF: The strict application of the provisions of the regulation would not deprive the applicant of the reasonable use of the land. The applicant would have to reconfigure the site to take up less of the required buffer area.
- 3. The circumstances are not the result of actions of the applicant taken subsequent to the adoption of the zoning regulation from which relief is sought.
  - STAFF: The circumstances are not the result of actions of the applicant taken subsequent to the adoption of the zoning regulation from which relief is sought as the property was developed before the proposal.

# 21-WAIVER-0083 STANDARD OF REVIEW AND STAFF ANALYSIS FOR VARIANCE FROM TABLE 10.2.6

- a. The waiver will not adversely affect adjacent property owners; and,
  - STAFF: The waiver will not adversely affect adjacent property owners, as there will be significant landscape screening that will block .the view of the residential properties across Lancashire Avenue
- b. The waiver will not violate the Comprehensive Plan; and,
  - STAFF: The waiver will not violate the comprehensive plan, which the vehicular use area landscape buffer area will be eliminated the landscape requirements will be met.

c. The extent of waiver of the regulation is the minimum necessary to afford relief to the applicant; and,

STAFF: The extent of the waiver of the regulation is the minimum necessary to afford relief to the applicant. All other requirements of the Land Development Code will be met except the variance requested.

d. <u>Either: 1. The applicant has incorporated other design measures that exceed the minimums of the district and compensate for non-compliance with the requirements to be waived (net beneficial effect); or 2. The strict application of the provisions of the regulation would deprive the applicant of the reasonable use of the land or would create an unnecessary hardship on the applicant</u>

STAFF: The strict application of the provisions of the regulation would not deprive the applicant of the reasonable use of the land. The applicant would have to reconfigure the site to take up less of the required buffer area.
