The following was discussed:

- Questions about whether 80% of the energy innovation funds are being invested
- The remaining 20% of the energy innovation funds will be for Louisville Metro Government to put in savings and possibly go toward projects
- Question about the street lighting assessment
- Question about whether a contractor has been selected for the street lighting
- Questions about whether the Cool Roof Rebate Program is to be used for residential homes and Louisville Metro Government
- Question about the length of time that Louisville Metro Government will be working with National Renewable Energy Laboratory (NREL)
- Louisville Metro Government has a paid contract with NREL; the cost for phase I is \$30,000 and phase II is \$250,000
- Phase II project focus is the technical, economic, legal, and practical feasibility of various avenues for achievement of 100% clean renewable electricity for Louisville Metro Government operations by year 2030
- Beyond 2030 the goal is to have clean energy for Louisville Metro Government operations by year 2035, and to have clean energy community-wide by year 2040
- Question about whether there is a city that is being used as a model with the same concept as Louisville Metro Government
- Question about whether there are estimates for Louisville Gas and Electric Company's green tariff and solar shares
- Solar shares are \$5.50 a piece
- Questions about whether there where any gains with the Energy Project Assessment District program
