Vice Chair Piagentini gave a brief summary on the following:

- Two contracts -- One Lieutenants and Captains within Louisville Metro Police Department ("LMPD") , and another contract for Sergeants and Officers within LMPD
- The Lieutenants and Captains contract was announced on September 20, 2021 that it was approved by the applicable members of the Fraternal Order of Police ("FOP") -- This will soon be submitted to the Labor and Economic Development Committee ("LED") to vote on this contract
- Gave clarification on the Committee and Council vote process regarding this contract
- The Sergeants and Officers contract was voted down on September 20, 2021 by the applicable members of the FOP -- This contracts process has restarted and has been sent back to the Mayor's Office and Administration to come back together and establish another agreed upon contract, to then come back to FOP for a vote of approval prior to coming before the LED committee and Council
