Meeting Minutes by William Tabor

Meeting was conducted at the end of said property garage driveway and street.

William Tabor opened meeting with person welcome and sharing of personal information. William Tabor offered tour of home on several occasions throughout the meeting, however, no neighborhood attendees accepted offer to tour the home. The meeting atmosphere was mostly civil but the tone of some of the comments seemed racially motivated. A few neighborhood attendees stated they own and rent multiple properties for the past 45 years but oppose me from doing the same thing citing you can't control everyone's actions.

Neighborhood attendee: Why did you buy here and not Shelbyville, KY?

William Tabor: I have a right to buy where my family likes, easy access to Interstate 65 and I like the

restaurants and activities that Louisville has to offer.

Neighborhood attendee: Why are you doing the short-term rental?

William Tabor: To help on the financial return on my family's property investment.

Neighborhood attendee: How will we know that pedophiles and drug dealers aren't staying there? William Tabor: I stated please let's not stereotype people and I will not stand for any form of discrimination. I explained the Airbnb past reviews are looked at and I will follow the Louisville Metro and short-term rental standards and regulations. I also shared that we have made the investment into beautifying both the interior and exterior of the home and property to keep the neighborhood and property values up, not to have someone destroy what we have worked so hard to build.

Neighborhood attendee: Will you perform credit checks on the potential short-term renters? William Tabor: I explained the Airbnb guest reviews are looked at and I will follow the Louisville Metro and short-term rental standards and regulations.


Neighborhood attendee: Will you consider long-term stays instead or short-term stays? William Tabor: I'm looking into corporate housing for the larger local Louisville employers as a possibility. Anything over 29 days of consecutive stay does not require a short-term rental permit as I understand from Louisville Metro. Long-term stays do not require neighborhood meeting nor a permit from Louisville Metro.

Neighborhood attendee: Why don't you sell your home and stay in an AirBnB? William Tabor: My family decided on this property because we liked it. If someone would like to buy the property, I am willing to accept an offer of \$400k. No offer was received.


Neighborhood attendee: After hearing that we oppose a short-term rental what are your plans?
