The area in green on the LOJIC map is a section of land that was donated to the city to be used only for a park if not left a green space. The way I understand it ,if it was used for anything else it would be reverted back to the Peterson family who it came from.

I had a meeting a long time ago with then Mayor Abramson and Park mgr. Mr Heitz. Both of them acknowledged this land was indeed set aside for that purpose. The only reason nothing was done with it back then was the parks and Rec dept did not have money to do that it their budget. The suggestion back then from the Mayor was a soccer park.

I wanted to make sure that this proposed area is not infringing on the open space. Also, this is a low-lying area, and the mini warehouse would need to be built above the BFE and an extra board foot. Doing so would most likely create a flooding hazard for the green space.

I would also like to point out the area in front of the proposed area has a problem with accidents now and fatalities. Increase traffic coming in and out of this would create an unsafe situation for those people who live in Windsor Forest
