- >> PRESIDENT JAMES: THANK YOU. ALL RIGHT. COUNCILWOMAN HOLTON STEWART, I THINK I HAVE A SPECIAL PRESENTATION TODAY. EVERY YEAR WE DESIGNATE OCTOBER AS BREAST CANCER AWARENESS MONTH AND CITIZENS TO WEAR PINK TO SHOW SUPPORT FOR THOSE THAT WE LOST. THOSE FIGHTING BREAST CANCER AND THOSE THAT SURVIVED. CITY HALL CLOCK TOWER WILL REMAIN PINK. THE SOBERING FACT, IN 2021, 281,550 NEW CASES OF INVASIVE BREAST CANCER WILL BE DIAGNOSED IN WOMEN IN THE U. S. AS WELL AS 49,290 NEW CASES OF NONINVASIVE BREAST CANCER. 63 PERCENT OF CASES WITH DIAGNOSED IN A LOCALIZED PLACE. NO EVIDENCE IT SPREAD OUTSIDE THE BREAST AND THE FIVE-YEAR SURVIVAL RATE IS 99 PERCENT. BLACK WOMEN HAVE A 40 PERCENT HIGHER DEATH RATE THAN WHITE WOMEN IN THE U. S. BLACK WOMEN WITH MORE LIKELY TO BE DIAGNOSED WITH BREAST CANCER BEFORE 40 THAN MOST WHITE WOMEN. THIS YEAR ESTIMATED 43,600 WOMEN WILL DIE FROM BREAST CANCER IN THE U. S. MEN TO GET BREAST CANCER AS WELL. IN 2021, 6,250 MEN WILL BE DIAGNOSED WITH BREAST CANCER THIS YEAR IN THE U. S. AND APPROXIMATELY 530 WILL DIE. ONE IN EIGHT WOMEN IN THE U. S. WILL BE DIAGNOSED WITH BREAST CANCER. IT IS THE MOST COMMON CANCER FOR AMERICAN WOMEN EXCEPT FOR SKIN CANCER. IT IN 2021, MOST CANCER DIAGNOSES WILL BE BREAST CANCER. THERE ARE 3.8 MILLION SURVIVORS IN THE U. S. REGULAR MAMMOGRAMS AND MONTHLY EXAMS ARE RECOMMENDED. CALL THE DOCTOR IF YOU NOTICE ANY CHANGE IN THE SIZE OR SHAPE OF THE BREAST OR A NEW LUMP IN THE BREAST OR UNDERARM. THANK YOU. ANY ADDRESSES TO COUNCIL?

>> LET ME REMIND THOSE ADDRESSING COUNCIL REFRAIN FROM USING PROFANITY OR MAKING DEROGATORY STATEMENTS. AS REMINDER, WE CANNOT DISCUSS PLANNING AND ZONING LEGISLATION CURRENTLY IN FRONT OF THIS BODY. PLEASE REFRAIN FROM MAKING COMPS RELATED TO A CURRENT PLANNING OR ZONING CASE. MADAM CLERK, BRING THEM FORWARD.

>> CLERK: ZACH CONTINO. DIANA CLEM. I'M THE FIRST GENERATION TO DEEPLY UNDERSTAND WHAT WE'RE DOING TO OUR PLANET. IT IS TIME TO DO SOMETHING TRANSFORMATIVE ABOUT IT. HELLO AND GREETINGS TO METRO COUNCIL MEMBERS AND METRO STAFF. MY NAME IS DIANA BROTHWAIT. I LIVE IN DISTRICT 16. I'M LOOKING AT THE ENERGY ALLIANCE IN LOUISVILLE AND ITS RESOLUTION. I BELIEVE YOU HAVE A COPY. I ENCOURAGE COUNCIL TO CONTINUE TO FIGHT CLIMATE CRISIS. THE RIVER AND THE BOUND BOUNTY BELONG TO THE TRIBE. PEOPLE WERE TREATED LIKE CATTLE. OUR GROUND IS SACRED. THE PEACEMAKER TAUGHT US ABOUT THE SEVENTH GENERATION. HE SAID WHEN YOU SIT ON COUNCIL FOR THE WELFARE OF THE PEOPLE, YOU MUST NOT THINK OF YOURSELF OR YOUR FAMILY, NOT EVEN OF YOUR GENERATION. HE SAID MAKE YOUR DECISIONS ON BEHALF OF THE SEVEN GENERATION THAT IS COMING SO THEY MAY HAVE WHAT YOU HAVE TODAY. WITH THE LITTLE HEALING OF OUR PIECE OF EARTH AND OURSELVES AND THE SEVEN GENERATIONS AHEAD. IT IS SAID IN CRISIS THERE'S DANGER AND IN OPPORTUNITY YOU DON'T WANT TO ACT OUT OF FEAR. THERE'S A TIME TO SEE THE OPPORTUNITY BALANCING AND RESTORING PERSONHOOD OF ALL CITIZENS. MARSHALL.

>> MY NAME IS CONNIE MARSHALL. WWW. JUSTICE FOR ALL CITIZENS. COM. MY E-MAIL ADDRESS IS CONNIE MARSHALL AT GMAIL. COM. MELTEN MANAGER AT LGE SENT A DEATH THREAT TO HIMSELF AND SIGNED MY NAME AS THE SENDER AS I TOLD HIM I WOULD REPORT HIM FOR SENDING PEOPLE AND ITEMS TO MY PROPERTY ONLY WITHOUT I.D. AND REFUSING TO GIVE THEIR NAMES AND TELLING THEM THEY WERE NOT RECORDED. POLICE OFFICERS AND OTHER POLICE WHO HAVE PREVIOUSLY SINCE DEATH THREATS TO ME AND CONFESS THAT I ASSIST THEM PARTICIPATED IN CREATING THE DEATH THREATS THEMSELVES. JEREMY RIVERS TRIED TO GET ME ARRESTED BY THE COMPLAINTS THAT THE POLICE CREATED. FORMER CHIEF CONRAD DENIED MY COMPLAINTS AND I SHOWED IT ON JUNE 5, 2020. ON JULY 15TH, 2021 A MEETING WAS HELD IN WHICH I WAS NOT NOTIFIED. MS. DOROTHY WAS ABLE TO GET THE MEETING RESCHEDULED FOR AUGUST 25TH, 2021. IT HAS BEEN CANCELED. I HAVE TO ATTEND A VIRTUAL MEETING. I HAVE TOO MUCH EVIDENCE TO SUBMIT. A VIRTUAL MEETING WOULD NOT ALLOW ME TO HAND SUBMIT MY INFORMATION. FURTHER, SCHOOLS ARE OPEN, CHURCHES ARE HAVING SERVICES. THE GOVERNOR NOT DECLARED NO IN-PERSON MEETINGS AND I'M STANDING HERE BEFORE YOU WEARING A MASK WHICH COULD BE DONE AT THE MEETING. IN THAT I HAVE BEEN WAITING ONE YEAR AND FOUR MONTHS TO GO BEFORE THE MERIT BOARD I'M REQUESTING THE COUNCIL ASSIST ME IN HAVING THAT FIGHT. HOW DO YOU KNOW I'M TELLING THE TRUTH?

I GUARANTEE YOU THAT NONE OF THE AFOREMENTIONED WOULD SUE ME FOR DEFAMATION. MORE INFORMATION GO TO MY WEBSITE AND TO MY YOUTUBE ACCOUNT. MY NAME IS CONNIE MARSHALL. THANK YOU.

>> CLERK: EMILY GENTRY. PRESIDENT JAMES AND COUNCIL MEMBER.

THANK YOU FOR THE OPPORTUNITY TO SPEAK. I'M FROM DISTRICT 10. I'M SPEAKING IN OPPOSITION OF THE PROPOSED CBA. A PROPOSED CBA DOES NOT INSURE OFFICER TRANSPARENCY TO THE COMMUNITY. IT REMOVES CLAUSES REGARDING FILES FOR POLICE OFFICERS. IT REMOVES RECORDS ON A PERMANENT BASIS. MAINTAINING CONTINUOUS RECORDS IS IMPORTANT TO UNDERSTANDING INDIVIDUAL OFFICERS OVER TIME AND PATTERNS OF MISCONDUCT AND POOR PERFORMANCE. WHY DOES LMPD NOT WISH TO MAINTAIN THESE RECORDS WHEN THEY HIRE, TRAIN AND RETAIN THE BEST TALENT AVAILABLE. BEYOND THAT, WHY ARE THESE REQUIREMENTS NOT INCLUDED IN THE OPEN RECORDS LAWS. THIS DOES NOT CLARIFY ANY UNJUSTIFIED USE OF FORCE IS A FIREABLE OFFENSE. TO INSURE COMMUNITY SAFETY, IT IS IMPERATIVE THAT UNJUSTIFIABLE USE OF FORCE IS ALWAYS AN OFFENSE. THE TAXPAYERS HAVE AN INTEREST IN UNDERSTANDING WHERE THE TAX DOLLARS GO. THE CONTRACT VERBIAGE ARE FOR OFFICERS THAT ARE UNDER INVESTIGATION TO BE SUSPENDED WITH PAY. IF AN OFFICER IS UNDER INVESTIGATION FOR A CRITICAL OFFENSE THEY SHOULD NOT BE GIVEN PAID TIME OFF ON THE TAXPAYERS DIME. ADDITIONALLY TAXPAYERS SHOULD NOT BE ON THE HOOK FOR PAYING OFFICERS FOR MISCONDUCT. THE HEARINGS AND APPEALS, FORMERLY CALLED PROCESS RIGHTS IS OF PARTICULAR CONCERN TO CITIZENS. 6. 8 OUTLINED A CLEAR ADMINISTRATIVE PROCESS FOR OFFICERS PARTICIPATING IN A MISCONDUCT OR APPEALS HEARING. THE CBA REMOVES THE DETAILS OF THE ADMINISTRATIVE STEPS AND REPLACES IT WITH, QUOTE, THE PARTIES SHALL FOLLOW THE PROCEDURES AND LIST THREE OF THEM AND AS THEY CURRENTLY EXIST OR EXIST OR MAY BE AMENDED. FIRST EXIST SHOULD NOT BE THOROUGH, IT SHOULD BE SINGULAR EXIST. AND REMOVING PROCESS TERMS ENTIRELY. IN TERMS OF

THE STATUTES, THE PROCESS DETAILS SUGGEST THE MATERIALS AT THE CITY LEVEL. INSTEAD THIS IS CEDED TO THE KENTUCKY GENERAL ASSEMBLY IN FRANKFURT AS THE LARGEST CITY IN THE STATE, THE CENTER OF THE STATE'S ECONOMY AND FULLY 25 PERCENT OF ITS POPULATION AS OF THE 2010 CENSUS, THERE'S NO GOOD REASON FOR METRO COUNCIL AND MAYOR FISHER TO HAND THE KENTUCKY STATE LEGISLATURE THIS MUCH POWER OVER THE PROCESSES THAT PERTAIN TO OUR POLICE FORCE. WE'RE A SERVING ENTITY AND SHOULD BE TREATED THAT WAY. I APPRECIATE IT. I'M EMILY GENTRY FROM DISTRICT TEN. >> UCOA. OKAY. I'M READY. HI, MY NAME IS TAYLOR. I'M A MEMBER OF THE 490 PROJECT, RESIDENT OF DISTRICT EIGHT AND HERE TONIGHT THAT YOU VOTE NO ON THE COLLECTIVE BARGAINING AGREEMENT THAT IS ON YOUR AGENDA AS NEW BUSINESS. WE SENT YOU A BREAKDOWN OF THE DANGEROUS PROVISIONS IN THE CONTRACT. I WANT TO REMIND YOU THAT ONE OF THOSE PROVISIONS STILL IN THE CONTRACT IS THAT CITIZEN COMPLAINTS MADE ABOUT LMPD CONDUCT WILL BE COMPLETELY ERASED AFTER TWO YEARS. NEEDLESS TO SAY THAT PROVISION DOES NOT BUILD TRUST WITH THE COMMUNITY AND ONLY OPERATES AS AN OBFUSCATION FOR DANGEROUS OFFICERS. I WANT TO SPEND THE REMAINDER OF MY TIME SPEAKING FOR THOSE THAT CAN'T BE HERE TONIGHT. YOU CAN SEE THE HANDOUT FOR THE INFORMATION I'M ABOUT TO POST. FIRST I WANT TO GIVE YOU QUANTITATIVE DATA FROM A SURVEY THAT YOU THE METRO COUNCIL COLLECTED BEFORE YOU VOTED ON THE CITY'S BUDGET, WE FOUND 341 OF THE 736 COMMENTS AND 46 PERCENT WE'RE TALKING ABOUT LMPD'S BUDGET. OF THE 341 COMMENTS, 89 PERCENT REQUESTED LESS FUNDING FOR LMPD. 89 PERCENT. THAT MEANS HUNDREDS OF PEOPLE REPORTED TO YOU THAT THEY WANT THE CITY TO DIVEST FROM LMPD'S

POWER. SECOND, I WANT TO GIVE YOU QUALITATIVE DATA WHICH I THINK IS THE MOST POWERFUL. THESE ARE THE THEMES OF THE COMMENTS SUBJECTED TO YOUR BUDGET SURVEY AND FROM OUR MOST RECENT PETITION, AMOUNTING TO A TOTAL OF 1300 INDIVIDUAL COMMENTS BETWEEN THE TWO AND VOICES OF YOUR CITIZENS. THEY'RE CONCERNED THAT THEIR TAX DOLLARS ARE BEING GIVEN TO A POLICE FORCE THAT OPERATES WITH NO ACCOUNTABILITY. IF THEY WANT MORE OF OUR TAX MONEY, THEY NEED TO COOPERATE. WHY NOT ENTER INTO A CONTRACT THAT MAKES THEM ACCOUNTABLE AND IS TRANSPARENT. YOUR CITIZENS ARE THE ONES THAT HAVE THE MOST INTERACTION WITH POLICE AND SHOW THEIR BEST INTERESTS ARE NOT PRESENTED. THEY TELL YOU THEIR VOICES HAVE NOT BEEN HEARD. IF IT IS NOT YOUR JOB TO LISTEN AND ACT ON THEIR BEHALF. WHAT IS?

IF THAT'S WHAT YOU WANT TO DO YOU CAN'T LET THIS CONTRACT
LAPSE. THE MORAL ARC OF THE UNIVERSE IS LONG AND POINTS TOWARD
JUSTICE. THESE CONTRACTS YOU'RE VOTING ON ARE ONLY NEGOTIATED
TWICE A DECADE. I COULD APPRECIATE A UNIVERSAL MORAL ART BUT I
AND THE CITY CAN'T WAIT TO RELEVANT CHANGES TO OCCUR. THAT ARC
NEED TO BEND AND IT NEEDS TO BEND NOW. YOU HAVE THE POWER TO

THANK YOU FOR BRINGING THIS UP. APPRECIATE IT. GLAD WE WORKED THROUGH THE FUNDING THING. I'M NOT SHOCKED WE CONTINUE TO UNDERESTIMATE

REVENUE GROWTH. THAT'S A TRACK RECORD THAT IS A GOOD THING. I'M GLAD WE'RE ABLE TO GET IT FUNDED THAT WAY AND I WOULD ENCOURAGE EVERYBODY TO SUPPORT THIS.

>> THANK YOU. COUNCILWOMAN MCCRANEY, DID YOU WANT TO SPEAK TO THE AMENDMENT?

- >> AYE. ALL OPPOSED. AYES HAVE IT. WE NOW HAVE THE -- THE -- THE AMENDED ORDINANCE BEFORE US. THE SUBSTITUTED ORDINANCE BEFORE US. ANY FURTHER DISCUSSION?

COLLEAGUES IN THE -- IN THE DEBATE ON THIS ISSUE BACK ON THE BUDGET COMMITTEE LAST THURSDAY, THERE WAS TALK OF A NEED FOR -- FOR LAW ENFORCEMENT ON THE LAWS WHEN IT CAME TO ALCOHOL BEVERAGE CONTROL. I HEARD FOWLER AND OTHER FOLKS, PURVIS TALKING ABOUT THE NEED FOR MORE ENFORCEMENT ALSO IN GENERAL OF CODES AND REGULATIONS IN NEIGHBORHOODS AND WOULD FURTHER ADD ENFORCEMENT OF WHAT WE HAVE IN THE BOOKS AND ADD TO

THE PUBLIC SAFETY. BEAUTIFYING THE NEIGHBORHOOD. I'M MAKING -- PROPOSING AN AMENDMENT TO WHAT HAS BEEN AMENDED BY SUBSTITUTION AND THEN IN YOUR SYSTEM IT IS LISTED UNDER PROPOSAL NUMBER TWO, I THINK IT IS PHAM 2. WHAT IT IS IT IS THE AMENDMENT TO ADD IN ADDITION TO THE THREE ABC OFFICERS TO ADD FIVE CODE ENFORCEMENT OFFICERS. THAT WOULD CHANGE THE DOLLAR AMOUNT FROM -- 339,500 TO 577,208. 34. THEN ALSO AT END OF THE TITLE IT WOULD ADD LANGUAGE TO STATE AND INSURE COMPLIANCE WITH THE -- WITH THE LMCO PROPERTY MAINTENANCE CODE. THERE WOULD BE AN ADDITIONAL WHEREAS ADDED AT THE END. THAT WOULD BE AT THE LAST PART OF THE WHEREASES. WHEREAS THE LACK OF STAFF MAKES IT DIFFICULT FOR CODE AND REGULATIONS TO BE ENFORCED FOR PROPERTY MAINTENANCE CODE TO ADEQUATELY SERVE THE REMOVAL OF THE JEFFERSON COUNTY METRO. I WOULD MAKE A MOTION TO AMEND BY SUBSTITUTION TO INCLUDE THAT SO NOW WE HAVE THE ADDITIONAL SURPLUS OF FIVE MORE CODE ENFORCEMENT OFFICERS.

- >> I THINK I HEARD SECOND FROM GREEN. ANY -- COUNCILMAN FOWLER
 IN COUNCIL MEMBER FOWLER. NOW ANY DISCUSSION?
 COUNCIL MEMBER WINKLER. COUNCIL MEMBER OLIVER.
- >> THANK YOU. THANK YOU. THANK YOU ACKERSON. I SUPPORT HAVING
 MORE CODE ENFORCEMENT OFFICERS. WE ADDED TWO IN THE BUDGET THIS
 YEAR AFTER DISCUSSION IN THE BUDGET PROCESS. I WON'T BE
 SUPPORTING THIS AMENDMENT JUST BECAUSE I -- I -- I THINK THAT WE
 SHOULD HAVE DISCUSSION ABOUT THESE KIND OF THINGS IN COMMITTEE.
 EVENING WE SHOULD HAVE KURT COME AND SPEAK WITH WHAT HE WOULD DO

WITH THE PEOPLE AND WHERE THEY GO AND HOW THEY WOULD BE USED. I LIKE TO KNOW. I'M -- I'M FRANKLY CONFIDENT THAT THE BUDGET SURPLUS WILL SUPPORT THIS. BUT AT LEAST I THINK IT WILL. I WOULD LIKE TO KNOW THAT FOR CERTAIN BEFORE WE SPEND WHAT WOULD BE SURPLUS MONEY. I DO THINK THAT WE'LL BE AN OPPORTUNITY IN SHORT ORDER AND I -- JUST MEAN IN THE DECEMBER MEETING TO -- TO SPEND THAT SURPLUS MONEY AND IF THERE'S ENOUGH I CERTAINLY THINK CODE ENFORCEMENT OFFICERS ARE IMPORTANT. THAT'S WHY WE ADDED TWO THIS YEAR AS PART OF THE BUDGET PROCESS. >> COUNCILMAN. COUNCILMAN WINKLER.

- >> HOLLANDER TOOK THE WORDS OUT OF MY MOUTH. I AGREE. THE IDEA IS A RIGHT ONE. WE NEED MORE CODE ENFORCEMENT OFFICERS. I LIKE TO HEAR FROM THEM BEFORE WE MAKE THE DECISION. I WOULD PUNT ON THIS UNTIL WE HAVE THAT OPPORTUNITY.
- >> THANK YOU. AND COUNCILWOMAN FLOOD?
- >> THANK YOU. MR. PRESIDENT, COULD YOU PLEASE ASK COUNCILMAN ACKERSON WHAT HE SAID THE TOTAL AMOUNT WAS FOR THAT?
- >> ACKERSON, COULD YOU REPEAT THE -- THE AMOUNT?

- >> THE TOTAL AMOUNT IS GOING TO BE -- YOU'RE RIGHT. IT WAS ONLINE. THE INITIAL TOTAL AMOUNT WAS SALARIES AND WE TALKED TO KURT AND IT WAS BUMPED UP FOR THE EQUIPMENT, CARS, VEHICLES AND THE OTHER SUPPLIES THAT COME WITH IT. THE TOTAL AMOUNT IS 577, 208. 34. THAT'S ALL INCLUSIVE.
- >> THAT ANSWER YOUR QUESTION?

- >> THANK YOU.
- >> COUNCILWOMAN PURVIS.
- >> THANK YOU MR. PRESIDENT. I JUST WANT MY COLLEAGUES TO KNOW THAT I'LL SUPPORT THIS ORDINANCE THAT COUNCIL MEMBER ACKERSON IS PROPOSING THE AMENDMENT. THE REASON BEING YOU ALL HEARD MY COMMENTS TO THE MAYOR. WE ARE REALLY IN NEED OF ENFORCEMENT IN THE WESTERN DISTRICT. NOT ONLY DISTRICT FIVE BUT ONE THREE FOUR AND FIVE AND SIX. THE LAST TIME THAT I MET WITH PUBLIC -- I'M SORRY, THE LAST TIME I MET WITH CODE ENFORCEMENT IT APPEARS THAT EACH -- EACH CODE ENFORCEMENT OFFICER HAS A CASE LOAD OF 500 EACH. IT IS BECOMING VERY VERY DIFFICULT FOR THEM TO HANDLE THE AMOUNT OF CASES THAT THEY HAVE WITH THE AMOUNT OF VIOLATIONS, TOTAL VIOLATIONS THAT THEY HAVE. I THINK IT IS SOMETHING NEEDED. WE SHOULDN'T KICK THE CAN DOWN THE ROAD AS YOU ALL HAVE THE TERM YOU USED BEFORE TO EXPLAIN WHAT WE NEED. DISTRICTS IN NEED OF ENFORCEMENT. I INTEND TO SUPPORT THIS. MY COLLEAGUES WILL UNDERSTAND THIS AND WILL SUPPORT IT A WELL. IT IS VERY NEEDED. THANK YOU.
- >> THANK YOU.

>> ACKERSON.

>> THANK YOU. I SAY THIS, I'M NOT TRYING TO SURPASS THE NORMAL BUDGET PROCESS. WE KNOW THAT EVERY YEAR WE HAVE A LARGE BUDGET SURPLUS. LOTS OF TIMES 10 MILLION, 12 MILLION, I DON'T FEEL A NEED TO TALK TO -- I DON'T FEEL A NEED TO BRING HIM HERE BECAUSE EACH ONE OF YOU REPRESENT YOUR AREAS. PLAIN AND SIMPLE. PURVIS IN THE BUDGET COMMITTEE MEETING. I HEAR FOWLER TALK ABOUT HER DISTRICT AND BEING UPSET WITH THE LAST CODE ENFORCEMENT. I DON'T NEED TO HEAR FROM KIRCHNER ABOUT WHAT HE WOULD DO WITH THE MONEY. I HEAR FROM MY COLLEAGUES AND LIVE IN THE AREAS EXPRESS THESE CONCERNS. SO YOU KNOW, WHAT THEY COULD DO WITH THE MONEY, ALLOCATE IT, LISTEN TO THE COUNCIL MEMBERS AND ENFORCE THE LAWS WE PUT IN PLACE. I HOPE THAT -- THE FACT WE NOT BROUGHT MR. KIRCHNER OVER HERE. I SAY LISTEN TO COUNCIL PURVIS, FOWLER'S COMPLAINTS, OTHER COMPLAINTS, I HAVE MY OWN COMPLAINTS, THEY'RE OVERWORKED AND UNDERSTAFFED. THEY'RE DOING THE BEST JOB THEY CAN WITH THE RESOURCES THEY HAVE. IN LIGHT OF THIS ORDINANCE, I THINK AT THE SAME TIME LET'S PUT MORE RESOURCES OUT THERE ALSO. THANK YOU.

>> THANK YOU. SO JUST TO CLARIFY FROM -- FROM A -- FROM COUNCILMAN ACKERSON'S STATEMENTS -- I'M VERY HAPPY WITH THE -- WITH THE CODE ENFORCEMENT OFFICER IN THE DISTRICT. HE DOES A PHENOMENAL JOB. HE DOES IT ACROSS THE COUNTY. THERE ARE TWO FOR THE WHOLE FAMILY. TWO. IT IS CRAZY. ONE THING I WOULD LIKE TO SEE IF THIS PASSES, SO I LIKE TO AMEND A FRIENDLY AMENDMENT TO HIS, COUNCILMAN ACKERSON'S AMENDMENT AND I WOULD

LIKE TO DESIGNATE ONE OF THE -- OF THE -- OF THE -- OF THE POSITIONS TO FOLLOW THROUGH ON OUR -- OUR DEVELOPMENT PLAN, BINDING ELEMENT. I THINK WE TALKED ABOUT THAT BEFORE. I THINK WE MAY FIX THAT AT THE SAME TIME. IF THIS HAS SUPPORT. IF IT DOESN'T HAVE SUPPORT, I'LL WORK HARD TO MAKE SURE THIS HAPPENS BY DECEMBER TO COME AROUND. AT ANY RATE, I LIKE TO MAKE THAT AS AMENDMENT IF I COULD PLEASE.

- >> I TAKE THAT AS A FRIENDLY AMENDMENT.
- >> YOU TAKE THAT AS FRIENDLY AMENDMENT. DO I HAVE A SECOND?
- >> SECOND BY COUNCILMAN ARTHUR. ANY FURTHER DISCUSSION?
 ENGEL?
- >> THANK YOU. IS THIS ON THE LATEST AMENDMENT OR I WOULD LIKE TO SPEAK TO THE WHOLE -- WOULD IT --
- >> IT WAS A FRIENDLY AMENDMENT SO ADDED TO THE AMENDMENT A YOU'RE TALKING TO BOTH OF THEM RIGHT NOW.
- >> THANK YOU. IN COMMITTEE AND I APPRECIATE ACKERSON HERE. IN COMMITTEE WE HAD THE DISCUSSION. WE TALKED ABOUT HOW THE 4 A. M. TO 2 A. M. CLOSURE MORPHED INTO THIS OPPORTUNITY TO ADDRESS AN ISSUE WHICH WE THOUGHT WAS -- WAS PRETTY PROFOUND. THAT'S ONE ISSUE. THAT'S ONE DISCUSSION ITEM. AND THEN WE GOT INTO THE NUTS AND BOLTS OF ADDING THESE IPO OFFICERS. THERE WAS DISCUSSION BACK AND FORTH IN THE COMMITTEE. I KEEP HEARING MCCRANEY TALK ABOUT BIG AND BOLD. I MADE THE COMMENT IN COMMITTEE WHICH I THINK ACKERSON FOLLOWED UP WITH A LITTLE BIT THAT HEY, IF WE WANT TO BE BIG AND BOLD, LET'S TAKE SIX OR SEVEN CODE

ENFORCEMENT OFFICERS. I GUESS I -- THERE WAS NO MORE DISCUSSION ABOUT THAT IN COMMITTEE. SO WE MOVED FORWARD WITH WHAT WE HAVE IN FRONT OF US. TO AMEND THIS PARTICULAR APPROPRIATION, WE GOT THE ARC OUT OF IT BUT I THINK IT IS RECKLESS. I THINK IT IS RECKLESS HERE FOR US TO -- TO START AMENDING THE CITY BUDGET ON-THE-FLY IF YOU WILL. I DO FEEL FOR THE COLLEAGUES THAT NEED ENFORCEMENT, ADDITIONAL ENFORCEMENT, LET'S HAVE THAT DISCUSSION. I'M VERY HAPPY WITH MY IPO FOLKS AND VERY PLEASED WITH DIRECTOR ROBERT KURT'S LEADERSHIP HERE. I HAVE TO TELL YOU WHILE I'M ABSOLUTELY SYMPATHETIC TO ADDITIONAL IPO OFFICERS, COUNCILMAN ACKERSON, I PROMISE YOU, I AM, TONIGHT I DON'T THINK I -- I DON'T BELIEVE I'M GOING TO SUPPORT THIS AMENDMENT BECAUSE I BELIEVE THIS IS A COMMITTEE DISCUSSION AND A BIGGER BROADER DISCUSSION THAT WE HAVE IN FRONT OF US. I WILL PROBABLY BE A NO VOTE ON THIS. I'M NOT GIVING ADDITIONAL ENFORCEMENT OFFICERS FOR PUBLIC SAFETY IN YOUR DISTRICT. THANK YOU.

- >> PRESIDENT JAMES.
- >> YES.
- >> HOLLY WITH THE COUNTY ATTORNEY'S OFFICE. I WANTED TO MAKE ONE POINT OF CLARIFICATION WITH RESPECT TO -- TO COUNCILWOMAN FOWLER'S PROPOSED AMENDMENT. SHE SPOKE IN TERMS OF NEEDING ADDITIONAL OFFICERS TO -- TO ENFORCE THE BINDING ELEMENTS. THIS WOULD NOT BE CODE ENFORCEMENT OFFICERS BUT ZONING ENFORCEMENT OFFICERS. SO IF ACKERSON'S AMENDMENT AND THIS LEGISLATION IS DIRECTLY ON CODE ENFORCEMENT OFFICERS THAT -- THAT MAY NOT BE

THE PLACE TO PUT THIS. THAT'S ON FOWLER'S AMENDMENT. WE WOULDN'T BE ABLE TO DIRECT THEM TO DO THAT. IT IS NOT CODE ENFORCEMENT'S DUTY. IT IS CODE ENFORCEMENT. HE IS TRYING TO JOIN THE MEETING AND FEELS MORE DIRECTLY WITH THOSE QUESTIONS.

>> PRESIDENT. CAN I SPEAK ON THAT POINT?

- >> YES, SIR.
- >> IN FACT I THINK THERE'S CONFUSION HERE. WE HAVE MORE THAN TWO CODE ENFORCEMENT OFFICERS IN THE COMMUNITY. WE MAY HAVE TWO ZONING ENFORCEMENT OFFICERS. BUT I DON'T THINK ANYTHING DEALS WITH ZONING ENFORCEMENT OFFICERS IN THIS AMENDMENT.
- >> THANK YOU. COUNCILWOMAN FOWLER.
- >> SO COUNCIL MEMBER IS CORRECT. SORRY FOR THE MISTAKE. WE NEED THEM AND WE NEED THEM BADLY. I THINK THE ZONING. NOT SURE IF THE ZONING OFFICER IS COMPLIANT BINDING ELEMENTS WOULD FALL UNDER THE SAME PURVIEW, BUT THE -- THE -- THE CURRENT ZONING OFFICERS ARE RELUCTANT TO ENFORCE OUR -- OUR BINDING ELEMENTS AND OUR CODE ENFORCEMENT, OR OUR DEVELOPMENT PLANS. IT IS A BIG ISSUE IN MY DISTRICT. I DON'T KNOW THAT ABOUT ANYBODY ELSE. IT IS A PROBLEM.

- >> I THINK I'M GOING TO PULL MY AMENDMENT AND NOT SURE HOW THIS IS GOING TO GO DOWN BUT I THINK THAT -- I DON'T KNOW. I THINK THAT WE NEED TO REALLY PROBABLY SEND THIS TO COMMITTEE AND TALK ABOUT IT. I DO.
- >> SO.
- >> JUST MY OPINION.

- >> THAT WAS AN OPINION.
- >> SO YOU'RE REMOVING YOUR -- YOUR FRIENDLY AMENDMENT. I FORGOT WHO SECONDED IT. OKAY. WE'RE BACK TO THE ORIGINAL AMENDMENT BY COUNCILMAN ACKERSON AND THAT DISCUSSION, COUNCIL MEMBER REED. >> THANK YOU, MR. PRESIDENT. YOU KNOW, I LIKE THEN TO ADDING OVERHEAD IN A BUSINESS AND -- AND I WE'RE TALKING ABOUT TAXPAYER DOLLARS HERE. I COULDN'T IMAGINE SIMPLY DOING THIS WITHOUT SOME DISCUSSION IN COMMITTEE ABOUT IT. FULLY IN SUPPORT OF COUNCIL MEMBER ARMSTRONG. THAT'S WELL SAID. IT IS IMMEDIATE AND NECESSARY. I'M NOT SAYING I DON'T AGREE THAT WE NEED MORE PEOPLE IN CODE AND REC, WE DO.  OFFICER WAS DISCUSSED IN COMMITTEE. OPPOSED AND HOPE WE MOVE
 FORWARD WITH THAT. I DON'T BELIEVE WE NECESSARILY, IF THE CODE
 ISSUE IS CRITICAL, I DON'T THINK WE NEED TO WAIT UNTIL DECEMBER.
 SOMETHING WANTS TO INTRODUCE AN ORDINANCE AND WE THAT
 DISCUSSION, THAT'S FINE. EVERYBODY HAS THAT RIGHT. DOING THINGS
 WITHOUT GOING THROUGH THE COMMITTEE. I THINK MORE IMPORTANTLY,
 DO WE KNOW DEFINITIVELY THE BOTTLENECK THAT WE NEED TO SOLVE
 AROUND CODE ENFORCEMENT. WHAT IF IT IS A DIFFERENT ISSUE?
 WE WOULD BE MISALLOCATING MONEY IF WE COULD HAVE A BIGGER IMPACT

WITH THE CODES ISSUE. LET'S SAY THE CODE ENFORCEMENT OFFICER AND STEP B IS WHATEVER OTHER PROCESS. - >> I DO SUPPORTING TO SOMETHING AROUND CODE ENFORCEMENT AND STAY ANTI-VIOLENT FIRST. INVEST IN THINGS LIKE FIXING UP BUILDINGS AND MAKING THOSE ENVIRONMENT CHANGES. STUDIES SHOW YOU SEE A DECREASE IN VIOLENT CRIME. I SUPPORT COUNCILMAN ACKERSON'S IDEA. LOOKING AT WAYS THAT WE COULD THAN COURAGE THOSE ENVIRONMENT CHANGES. IT IS REALLY IMPORTANT. I DO AGREE HAVING IT GO THROUGH THE COMMITTEE PROCESS IS -- IS GOOD GOVERNMENT AND ALLOWS US ALL TO DO OUR HOMEWORK AND BRING FOLKS IN TO HAVE THE CONVERSATION. HOWEVER, I ALSO AGREE THAT I THINK -- IT DOES HAVE A CONNECTION TO ANTI-VIOLENCE. THIS DIDN'T NEED TO WAIT UNTIL DECEMBER. - >> THANK YOU, MR. PRESIDENT. EVERYBODY STRAP IN. I'M FULLY
 ALIGNED WITH COUNCILMAN HOLLANDER AND ARMSTRONG HERE. WHAT I
 WOULD -- I MEAN, BECAUSE NOT ONLY IS THE PROCESS IMPORTANT WHICH
 IT VERY MUCH IS, BUT FOR EXAMPLE, WHAT COUNCILMAN SAID NUMBER
 ONE PROBLEM IN CODE ENFORCEMENT IS OUR CODE. I DON'T CARE HOW

MANY CODE ENFORCEMENT OFFICERS YOU HAVE OUT THERE WRITING
TICKETS WE HAVE NOWHERE TO PUT THE VEHICLES. THERE'S AN EXAMPLE.
AND COUNCILMAN ARMSTRONG'S POINT, I SENT A NOTE OUT MANY COUNCIL
MEMBERS WERE UNABLE TO SUPPORT THIS IN THE ENVIRONMENT.
ABANDONED PROPERTY. I'M IN SUPPORT OF HAVING A FULL-BLOWN
DISCUSSION BUT -- BUT OBVIOUSLY, WE STINK AT DOING THIS IN
REGULAR CHAMBERS. THAT'S WHAT IT IS FOR WITH ALL OF THIS
