Good morning Mr. Dow,

I just wanted to check back in with you regarding the funding of the multiple speed hump projects we've got going on in D-2. Did the funding that had been restricted ever get unrestricted so that you can utilize it for these projects? I know that a few weeks ago Dr. Shanklin spoke to Mr. Brown to ensure that this happened, but I hadn't heard back on whether or not it did.

If so, the last figure I had from those three separate accounts all together was \$88,000 for speed humps/signage. Assuming this has all been unrestricted, my figures show that an additional \$10,850 will be necessary to complete all of the projects (all projects added up come to \$98,850 total). Does this all sound correct, and if so, are you ready/willing to receive a CIF in the amount of \$10,850 so that these projects will all be completely funded?

Dr. Shanklin wants to make sure that you have all of the funding that you need to get these projects completed, and as another Appropriations deadline approaches for the Metro Council, we want to make sure you get the funding you need for them as soon as possible.

Hi Mr. Dow,

Thank you for sending these last couple estimates along.

Based upon these estimates, as well as the previous spreadsheet of costs for all of the speed hump projects we're doing right now in D-2 from Beth a few weeks ago (which amounted to \$77,870), we have \$98,850 in total cost for the projects. Also, again based upon the email with the spreadsheet, we have \$88,000 already available from 3 different accounts for speed humps and signage. If this is all correct, that means that we still have to fund \$10,850 additional via CIF for the remainder necessary to complete the projects.

1. Beth/Greg: Do these figures sound correct? If so, I will try and write up a CIF by the end of the week in the amount of \$10,850 to PW for the remaining cost.

2. Greg: The CIF/appropriations process will take a little time to work through the system, as you know. Since a majority of the money necessary for the projects is already available, will you be able to schedule all of the projects to be done now or will we have to wait for the CIF money to get to PW for the remaining costs before the last few projects can be started? We are hopeful that they can all be scheduled relatively close together, if at all possible.

Good morning Mr. Dow,

I just wanted to check back in with you regarding the funding of the multiple speed hump projects we've got going on in D-2. Did the funding that had been restricted ever get unrestricted so that you can utilize it for these projects? I know that a few weeks ago Dr. Shanklin spoke to Mr. Brown to ensure that this happened, but I hadn't heard back on whether or not it did.

If so, the last figure I had from those three separate accounts all together was \$88,000 for speed humps/signage. Assuming this has all been unrestricted, my figures show that an additional \$10,850 will be necessary to complete all of the projects (all projects added up come to \$98,850 total). Does this all sound correct, and if so, are you ready/willing to receive a CIF in the amount of \$10,850 so that these projects will all be completely funded?

Dr. Shanklin wants to make sure that you have all of the funding that you need to get these projects completed, and as another Appropriations deadline approaches for the Metro Council, we want to make sure you get the funding you need for them as soon as possible.

Hi Mr. Dow,

Thank you for sending these last couple estimates along.

Based upon these estimates, as well as the previous spreadsheet of costs for all of the speed hump projects we're doing right now in D-2 from Beth a few weeks ago (which amounted to \$77,870), we have \$98,850 in total cost for the projects. Also, again based upon the email with the spreadsheet, we have \$88,000 already available from 3 different accounts for speed humps and signage. If this is all correct, that means that we still have to fund \$10,850 additional via CIF for the remainder necessary to complete the projects.

1. Beth/Greg: Do these figures sound correct? If so, I will try and write up a CIF by the end of the week in the amount of \$10,850 to PW for the remaining cost.

2. Greg: The CIF/appropriations process will take a little time to work through the system, as you know. Since a majority of the money necessary for the projects is already available, will you be able to schedule all of the projects to be done now or will we have to wait for the CIF money to get to PW for the remaining costs before the last few projects can be started? We are hopeful that they can all be scheduled relatively close together, if at all possible.
