Case Number 16AMEND1010 and 14AREA1002

Brian Davis presented the proposed R-2A zoning district for the City of Anchorage. The district varies slightly from the existing R-2 because some of the existing structures do not meet those requirements. The differences are for the side yard setbacks and the FAR. If approved, there will be an areawide rezoning of the Stone Bridge subdivision to rezone those 47 parcels from R-4 (which isn't recognized in Anchorage) to R-2A. There is also one other zoning cleanup attached to 14AMEND1002 to rezone the property at 805 Surrey Lane from R-4 to R-1.

On a motion by Committee Member Carlson and seconded by Committee Member Kelly, the following resolution was adopted:

RESOLVED, the Louisville Metro Planning Committee does hereby **RECOMMEND** that Case Number 16AMEND1010, Anchorage R-2A Zoning District, and Case Number 14AREA1002, Anchorage Areawide Rezoning, be sent to the Land Development & Transportation Committee on Thursday, June 9, 2016.

Infill in the Suburban Form Districts

Brian Mabry presented recommendations for amendment to Chapter 5 of the LDC related to infill in the suburban form districts. "Step back requirement" is how it is worded in the metro ordinance. Commissioners asked questions for clarification on the step back formula and how it would be applied. Barbara Kelly asked if this could be waived or varied, to which Brian Mabry said yes.

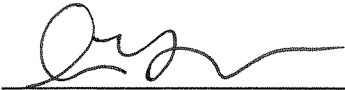
