- In Section (D) on Page 12, replace 'No later than 30 days before the hearing date' with 'At least 30 days prior to the hearing'
- In Section (E) on Page 13, add 'within 90 days' after the word 'District'

A motion was made by Committee Member Peden, seconded by Vice Chair Kramer, that this Ordinance be tabled. The motion to table carried by a voice vote.
