Council President James reviewed the Metro Council agenda, and briefly spoke about the guest he had invited to the meeting.

The Clerk confirmed that there were ten Addresses to Council.

Council Member Purvis requested that item 39 (O-335-20) be moved from the Consent Calendar to Old Business so that she could abstain from voting on this item.

Council Member Piagentini explained that the following items were on Old Business:

- Item 40 (RP081120MH), so that one of the Council Members can abstain from voting on the item; and
- Item 41 (R-100-20), because it was amended in committee.

Council Member Triplett briefly spoke to item 42 (O-336-20).

Council Member Coan also spoke to item 42 (O-336-20) and explained how he would address it when called upon during the Council meeting.
