Council Member Piagentini spoke about parliamentary procedures regarding Council Members explaining their votes when roll call votes are taken.

Council Member Kramer, Council Member Mulvihill, and Council Member Shanklin also spoke on this topic.

Sarah Martin, Jefferson County Attorney's Office, provided some background information and an update on the Explorer Program lawsuits.

- In 2017, there were seven lawsuits filed alleging sexual assault by police officers.
- The lawsuits name nine Louisville Metro Police Officers and other Louisville Metro Government employees: Brandon Wood and Kenneth Betts, who both have taken plea deals and are currently serving time for crimes against the victims; Bradley Schuhmann, who has not been criminally charged; Paul Paris, Julie Schmidt, Casey Scott, Matthew Gelhausen, Curtis Flaherty, and Louisville Metro Government, all who allegedly should have known the abuse was going on.
- There are several outside Counsel representing the employees, and the Jefferson County Attorneys Office and Jeff Phillips represented Louisville Metro Government.
- The Boy Scouts of America's insurance carrier, Old Republic, recently took on the defense of Louisville Metro Government because the insurance policy covered the Explorer Program.
- A few weeks ago, Old Republic also took over the defense of all of the Louisville Metro Government employees.
- Louisville Metro Government has also submitted past legal bills to Old Republic for reimbursement of past legal expenses, which totals over \$660,000.
- The case is in the middle of discovery, and all seven trials were scheduled for 2021 but have now been cancelled, presumably due to the pandemic.
- There are still a few depositions going on, but most have already been taken.
- The case is pending in Federal court, and the discovery process is managed by U.S. Magistrate Judge Colin Lindsay.
- A few weeks ago, Judge Lindsay had all parties submit confidential settlement statements so that he could assist the parties in settlement discussions.

Council President James asked the Council Members to review the proposed calendar of Metro Council meetings for 2021, which they will vote on soon. He also stated that January 28, 2021 is being proposed as a meeting of the Council where the vote would be taken regarding the Council's selection to fill the soon-to-be vacated seat of Council Member Yates (who has been elected to the Kentucky State Senate).

Council President James asked the Council Members to respond to the Clerk's Office if interested in being part of the office drawer since there will soon be some vacant offices.
