Review of Metro Council Agenda

Council President James briefly reviewed the Metro Council agenda.

Council President James spoke about the Council Members recognizing the University of Louisville Interns.

The Clerk provided information about the Addresses to Council.

Council President James briefly reviewed the items under Special Legislation (item 38 - R-151-20 and item 39 - R-159-20). He reviewed the proposed timeline regarding the filling of the upcoming vacancy due to Council Member Yates being elected to the Kentucky Senate, which is as follows:

- Council Member Yates will submit his resignation around January 3, 2021, and it will be accepted by the Council at the January 4, 2021 meeting.
- Resumes must be submitted within seven business days of that meeting, which makes the deadline January 13, 2021.
- The Jefferson County Attorney's Office will have a week and a half to complete the background research on each person that applies.
- A special meeting of the Committee of the Whole will be held on January 25, 2021 to conduct interviews.
- At the regular Metro Council meeting on January 28, 2021, the Council will vote on who will fill the vacancy.

Council Member Shanklin briefly reviewed item 40 (O-395-19) and item 49 (R-146-20) that came out of the Community Affairs, Health and Education Committee.

Council Member Green briefly spoke about item 41 (O-481-20) that came out of the Public Safety Committee.

Council Member Flood briefly spoke about item 42 (O-426-20), item 43 (O-477-20), item 44 (O-504-20), and item 45 (O-505-20) that came out of the Planning and Zoning Committee.

Council Member Yates briefly spoke about item 46 (O-507-20) and item 47 (R-133-20) that came out of the Labor and Economic Development Committee.

Council Member Ackerson briefly explained that the Reappointment of Lee Weyland (item 48) was on Old Business so that Council Member Sexton Smith could abstain.

Council Member Blackwell briefly spoke about item 50 (O-500-20) and item 51 (NDF111120LHF06) that came out of the Appropriations Committee.
