A motion was made by Committee Member Purvis, seconded by Committee Member Triplett, that this Ordinance be recommended for approval.

Wanda Mitchell-Smith, Legislative Assistant for District 4, stated that this needs to be amended due to the scope change for the project. Initially the project was a Shakespeare Hamlet Parks Tour, and now has become a virtual project with professionally recorded performances to create and disseminate an accompanying curriculum guide. Also to withdraw sponsorship from Districts 1, 13, 17, 19, 20, and 23, as well as to decrease sponsorship from District 7.

Committee Member Peden questioned about the funding being returned to the districts that withdrew sponsorship. He also questioned if this was amending the original ordinance or if this is a new ordinance for the virtual project. He stated that withdrawing sponsorship does not necessarily mean withdrawing

the funds and just wanted clarification.

LaTonya Bell, Metro Council Financial Analyst, the ordinance being presented now is amending the original ordinance and withdrawn sponsorships from the original have not been included in this current ordinance and those funds will be returned to each Neighborhood Development Fund account. This ordinance being approved will facilitate the funds being returned to each account and all documents will be given to the Office of Management and Budget so they will know to do a budget revision transfer in which funds will go back into the accounts of the sponsor who withdrew funds for the project. She stated that this is the same process being followed as in the past for sponsorship withdrawals.

Sonya Harward, Metro Council Clerk, stated that attached to the agenda is the proposed amendment and should clear any questions. It list all funds being appropriated and why it is being changed.
