Council Member Dorsey stated this project is gap funding for homeowners with foreclosure until more funds are available from the government. In addition, it is for residents needing shelter due to a fire or a displacement emergency. The Red Cross no longer provides shelter or funding unless the fire or displacement is a total loss. This funding is also available to a resident if a non-related crime has been committed and damage occurs to the home and the resident is displaced, and this would help provide an overnight stay in a facility.

There is not an actual cap for funding. Additional documentation could be obtained from the police district to cover the addition of funds.

Committee Member Kramer recommended that the initial funding be accepted and approved, then send the legislation to Council and amend on the floor with the additional amounts the police department requests with additional documentation. This should not be confused at Council that this is only one police district out of seven.

The motion to reconsider carried by a voice vote and the Neighborhood Development Fund was recommended for approval.
