- The issues addressed in this Ordinance were raised by constituents and

should make life easier for some people in the community

- Referenced the proposed amendment version of the legislation attached hereto for discussion

- The purpose is to address some issues with accessible parking spaces and the room needed for those using such spaces to safely maneuver their modified vehicle, wheelchair, etc.

- The Ordinance:

- provides some new definitions
- provides specifications and design requirements for access aisles
- references the American with Disabilities Act in reference to how many accessible parking spaces must be provided and removes the table currently in the Ordinance
 - adds van accessible parking requirements
 - specifies when a property owner is obligated to update accessible parking
- changes to the penalty section, including the ability to have a vehicle towed

- The amount of time allowed to park at an accessible parking space

- First piece of legislation vetted by the Commission for Persons with

Disabilities, who provided some stylistic changes

- Question about striking the language "at no additional charge" and the cost to park at accessible parking meters

- The real-world problem of accessible parking
- State statute penalties versus local penalties

Enactment No: Ordinance 076-2020
