#### SPECIAL DISCUSSION: UPDATE ON METRO PARKS AND POOLS

#### The following was discussed:

- Metro Parks had its first lifeguard training in February, 4 lifeguards attended the training and 3 life guards will be moving forward with 3 additional lifeguard trainings starting at the beginning of March
- Sun Valley pool will continue to be closed on Wednesdays
- Fairdale pool will continue to be closed on Mondays
- Due to COVID-19 restrictions, pre-registration is required to use the pool
- The pools will have 2 sessions per day; 12-2, and 3-5 to allow time for the pools to be cleaned
- Time has been reserved at the Sun Valley pool for seniors only to swim on Thursdays mornings from 11 a.m until noon
- Metro Parks is working on getting summer swim teams to teach children the fundamentals of swimming at every pool location for 1 day per week and the program is expecting to start this summer
- Volunteers will be helping so the children can have one-on-one training
- The new Metro Parks head lifeguard is Mike Jotautas
- Algonquin pool has had a structure engineer to put in a new pump, and the pool was also painted last year
- Algonquin pool house needs repairs to make it safe and family centric
- Algonquin pool still has major problems, the concrete is breaking away, there is deteriorating concrete, rebar in the concrete is exposed, and there is also leaking
- Question whether Algonquin pool should open this year and what is expected for the future with this pool
- Algonquin pool has security concerns with people coming in at night when the pool is closed
- Question about making Algonquin pool an aquatic center or a closed in pool that could be open year round
- Norton pool was built in 1964
- Algonquin pool was built in the late 1960's
- Concerns and questions about safety issues around Algonquin pool
- Lighting and cameras have been added around the Algonquin pool
- Question about whether the state has been contacted on the guidelines about the capacity level of 60% in pools
- Pools are set to open on Memorial Day and the last day open will be Labor Day

- Pools will be open daily during the summer and when school is in session the pools will be open only on weekends
- Question about what other cities have done to save their pools
- Question whether there have been partnerships with universities and/or community partnerships
- Question about the plan from 2018 for a indoor pool
- Question about fixing pools since there is a surplus in the budget
- Operational dollars have been set aside for repairs
- Questions about what investments can be made and what visions does Metro Council have for the pools
- Question about making cosmetic updates at Norton pool
- Questions about whether to reduce the number of pools in the city by making a new location with larger pool
- Question about whether the golf deferred maintenance plan for golf only
- Question about whether there has been a 2-years plan for deferred maintenance submitted to Office of Management and Budget
- Question about whether there is a prioritized list of the most pressing needs of the Metro Parks system and if so can they be handled in-house
