- There was a discussion regarding the overall intent and goal of the legislation, which is to prevent employers from discriminating against applicants based on credit reporting.
- There were several questions regarding whether the legislation should be heard in a different committee.
- There was a discussion regarding credit history and the role of the Equal Opportunity Employment Commission.
- There were several questions regarding whether other peer cities have this type of legislation.
- There was a discussion regarding the research showing that 11 other jurisdictions have similar ordinances.

A motion was made by Committee Member Arthur, seconded by Committee Member Holton Stewart, that this Ordinance be amended as stated in "O-400-21 PROPOSED CAM 091621 PREVENTING CREDIT WORTHINESS DISCRIMINATION IN EMPLOYMENT.pdf". (See attached)

- There were several questions regarding whether this legislation would add barriers for employers.
- There was a discussion regarding this legislation being a complaint driven law that would be investigated by the Human Relations Commission.
- There were several questions regarding whether peer cities with similar legislation have shown definitive outcomes.

The following was discussed:

- There was a discussion regarding restitution/reparations to descendants of slaves.
- There was a discussion regarding wealth and equality disparities for people of color.
- There were several questions regarding why wealth gap differences occurred and what were the root causes, such as "Jim Crow" or slavery.
- There was a discussion regarding people of color continuing to be impacted

by the injustices of slavery.

- There was a question regarding the best way to move forward and whether reparations is the best direction.
- There was a discussion regarding other races/groups that have received restitution, however, descendants of slaves have never received reparations.
- There was a discussion regarding reparations repairing those that were injured by racial injustices.
- There was a discussion regarding who would pay reparations.
- There was a discussion regarding the scope and intent of the legislation to support House Bill 40 for a study to ascertain the ramifications of racial injustice and a manner to remedy those injured.
- There was a discussion regarding Council President James' proposed amendment by substitution that would further clarify the overall intent of the legislation.

A motion was made by Committee Member Winkler, seconded by Committee Member Arthur, that this Resolution be amended as stated in "R-081-21 PROPOSED CABS 091621 RESOLUTION TO SUPPORT HOUSE RESOLUTION 40 RE REPARATIONS.pdf." (See attached)

- There was a discussion regarding the focus of the legislation centers on descendants of slaves
- There was a discussion regarding whether House Bill 40 studies other potential options to remedy the financial impacts experienced by descendants of slaves.
- There was a discussion regarding how to determine who qualifies for reparations.
- There was a discussion regarding the true definition of reparations and all it entails.
- There was a discussion regarding whether immigrants that came to the United States would be tasked to pay reparations.
- There was a discussion regarding whether the war on poverty offset the need for reparations.
- There was a discussion regarding the fact that universal programming does not fix systemic injustices.
