# AN ORDINANCE AMENDING LOUISVILLE METRO CODE OF ORDINANCES SECTION 72.039 RELATING TO ABANDONED AND JUNKED VEHICLES.

#### The following was discussed:

- This legislation will amend the Louisville Metro Code of Ordinances (LMCO) regarding junk vehicles with two components, such as, (1) it ensures that the LMCO aligns with existing Louisville Metro Police Department protocol with regard to notifications prior to towing and (2) that it adds clarity to the definition of "junked vehicle."
- These changes will allow Louisville Metro to enforce laws to remove junk vehicles, while also addressing a larger challenge.
- The changes will be in Section B stating "if the vehicle has not moved in three days and has been marked, it can be deemed abandoned."
- The new language will provide clarity to the language and definitions provided to better align with present Louisville Metro Police Department protocol.
- The language will state, "the warning shall be affixed to the vehicle window closest to the roadway and shall include a notation of the length of time the vehicle has been in the location which will serve as notice to the owner/operator of the vehicle; and, that the vehicle is subject to being impounded."
- In Section C (1), language will be added to give further definition to a "junked vehicle." The definition will further define a "junked vehicle" as being without a license plate and/or license tag that has been expired for at least three months or more.
- Section C (4) will detail the process for the vehicle to be towed.
- The Louisville Metro Police Department is in full support of the proposed amendments.
- There were several questions regarding the current status of junked or abandoned vehicles in the Louisville Metro Police Department impound lot.
- There were several questions regarding when a junked vehicle is a Codes and Regulations issue versus when it is a Louisville Metro Police Department issue.
- There was a discussion regarding similar legislation in the Public Works

Committee that may appropriately address the proper enforcement agency.

- This legislation modifies the existing animal welfare Ordinance adding two primary components appropriate shelters (during extreme or severe heat/cold), it also allows first responders to rescue animals in locked cars (during extreme heat/cold).
- There was a discussion regarding the reasonability standard expressed by the American Kennel Association on who will decide an animal is in peril or in need of rescue.
- There is an average of 332 calls per year to first responders regarding animals in hot cars.
- There were several questions regarding whether the enforcement officer answering an endangered animal call would use the reasonability standard when assessing each case.
