The following was discussed:

- Whether the money received from the drop in contracts and services is money from the Convention Center -- the money received is from all of the properties that pays LDMD to perform services for them and the Downtown area
- Questions were asked regarding where Louisville's Downtown area stands compared to other comparable cities -- 23 percent vacancy in office space for Downtown Louisville. Nashville, TN is currently ranking higher and Indianapolis, IN has a low office space vacancy as well due to the COVID-19 pandemic -- a solution could be to bring more housing downtown to provide more stability
- More diversity within the Downtown workforce community
- West Muhammad Ali Blvd. is doing significantly better than other parts of Muhammad Ali Blvd.
- Thanks were given to Bill Shreck for his expertise with Downtown Louisville and all efforts he has made for the city
