# Millcreek Wetland Stream Project - Bennet Knox, Parks and Recreation (KY Fish and Wildlife)

The following was discussed:

- The Corps of Engineers requires land developers to mitigate for losses of stream and wetland habitat
- Developers can buy mitigation credits from Fees-In-Lieu-Of Mitigation (FILO)
- The FILO program restores, enhances and/or preserves aquatic habitat in streams and wetlands
- The project location is in the Mill Creek parcel
- There are five segments and each segment has to be monitored for seven years after it is completed
- Construction is determined on available funding, and construction could last from one to two years construction
- The projected monitoring period will be finalized in 2035
- Question about what makes a parcel eligible for the FILO
- Question about how much funding is available within this region
- Metro Parks received a commitment from Nature Conservancy to provide \$100,000 towards the development of conceptual ideas for trail and trailhead improvements

- The property is approximately 114 acres that will be divided into 2 tracts
- The owner of the property will retain ownership of the property
- The owner has the right to build two houses on the property

- Currently there is a house on the property that will be demolished
- There is an opportunity for continue of horticulture on the land
- Question about whether the two houses that will be built on the property will be kept in the family
- Regardless of who owns the two homes on the land the integrity of the easement stays in place with no more future development on the property
