Chief Dwayne Clark, Louisville Metro Department of Corrections, gave a status report on the recent inmate deaths.

The following was discussed:

- There were several questions regarding the total number of inmate deaths in Louisville Metro Department of Corrections during 2021.

- There were several questions regarding measures that the Louisville Metro Council could take to assist/support the Louisville Metro Department of Corrections.

- There was an update on three recent inmate deaths at Louisville Metro Department of Corrections.

- There was a discussion regarding chronic health and/or mental health challenges experienced by each deceased inmate.

- There were several questions regarding the frequency of

observation/well-care checks and whether autopsies would be performed on each inmate.

- Toxicology studies will be conducted on each of the deceased inmates.

- The Louisville Metro Department of Corrections will provide the Louisville Metro Council with details on all inmate deaths for 2021, as well as medical assessment/autopsy results for each deceased inmate.

- There were several questions regarding the details surrounding the inmate that allegedly committed suicide at the Louisville Metro Department of Corrections.

- There was a discussion regarding ongoing investigations of the inmate deaths by the Federal Bureau of Investigations and American Civil Liberties Union (ACLU).

- There was a discussion regarding an ongoing Civil Rights investigation for

one of the inmate deaths.

- There was a discussion regarding the number of hospital admissions from Louisville Metro Department of Corrections from 2019 through 2021.

- There was a discussion regarding the lack of knowledge by leadership

concerning the number of deceased inmates in Louisville Metro Department of Corrections custody.

- There were several questions regarding continued staffing shortages and how these staff shortages impact inmate safety.

- There were several questions regarding why Jefferson County does not elect a jailer.

- There was a discussion regarding whether the election of a jailer may have changed in merged governments, such as Louisville Metro and Lexington.

- There were several questions regarding how the frequency of observation checks may have been impacted by staffing shortages.

- There was a discussion regarding observation/well-care checks being conducted every 30 minutes.

- There was a discussion regarding the correlation between the level of care that Louisville Metro Department of Corrections Officers may provide and the observation of inmates in an efficient time span.

- There was a discussion regarding the imbalance of inmate to officer ratios.

- There was a discussion regarding a total of four inmate deaths, to date for 2021.

- There was a discussion regarding the lack of peer mental/behavioral support for officers within the Louisville Metro Department of Corrections.

- There were several questions regarding how Louisville Metro Council may assist the American Civil Liberties Union in assisting the Louisville Metro Department of Corrections.

- There was a discussion regarding the Louisville Metro Department of Corrections lowering its population by allowing Louisville Metro Police Department Officers to cite rather than arrest low level offenders.

- There was a discussion regarding a request for Judges and the Jefferson County and Commonwealth's Attorneys to suspend issuing bench warrants, failure to appear warrants or cash bonds for offenders that do not pose a threat to the community.

- There were several questions regarding changes to the cash/bail system.

- There were several questions regarding the Louisville Metro Department of Corrections leadership receiving suggestions and/or recommendations to improve current conditions.

- There were several questions regarding how many staff members were available during each inmate death.

- There were several questions regarding who evaluates medical events/incidents within the Louisville Metro Department of Corrections.

- There were several questions regarding whether a third-party agency

evaluates if proper protocol was followed after each incident.

- There were several questions regarding the different aspects/details between the current three inmate deaths.

- There were several questions regarding whether Louisville Metro Department of Corrections Officers receive any mental/behavioral support services after critical incidents.

- There were several questions regarding the level of Officer/inmate interactions and how these interactions may be impacted by staffing shortages.

- There were several questions regarding whether a homicide investigation had been launched concerning the inmate that had allegedly committed

suicide due in part to early physical altercations with other inmates.

- There were several questions regarding whether any individuals/vendors are exempt from searches when entering the Louisville Metro Department of Corrections.

- There were several questions regarding facility transfers for inmates that require substance abuse services/counseling.

- There were several questions regarding the number of suspended services due to COVID, such as gym time, religious services, and General Educational Development (GED) training.

- There were several questions regarding how the suspension of such activities may impact inmates.

- There were several questions regarding the percentage of individuals incarcerated due to the inability to post bail.

- There was a discussion regarding drug trafficking within the Louisville Metro Department of Corrections.

- There were several questions regarding measures that the Louisville Metro Council may take to assist the Louisville Metro Department of Corrections in combating drug trafficking, staff shortages, etc.

- There was a discussion regarding the purchase of new equipment, such as, body scanning, magnetometers, and ex-ray machines that the Louisville Metro Department of Corrections would greatly welcome support from the Louisville Metro Council.

Deflection Program Agreement - Seven Counties

A motion was made by Vice Chair Peden, seconded by Committee Member George, that this Resolution be recommended for approval.

The following spoke to this item:

The following was discussed:

- This legislation will fund a deflection program that will provide mental health/behavioral service technicians to individuals in crisis.

- This program will utilize the deflection technicians rather than dispatching Louisville Metro Police Officers.

- This program is recommended as the result of a study conducted by the University of Louisville and Spaulding University.

- The program has been managed by Metro Emergency Management Services since its launch in June of 2021.

- The initial program goal was to have the program contracted and in force by December 1, 2021.

- The program had a few initial delays, but is now ready to fully launch.

- The program is managed two-fold with Metro Emergency Management

Services and Seven Counties Services.

- Metro Emergency Management Services is tasked to deflect and divert 911 calls from Louisville Metro Police Officers.

- Seven Counties Services is tasked with assigning behavioral health

specialists in instances where mental health intervention is warranted.

- Seven Counties Services will also conduct follow up visits with individuals in the field via a Crisis Response team.

- The pilot program will be conducted with the Louisville Metro Police Department's Fourth Division for six months.

- After the pilot period has concluded, a program evaluation will be conducted for overall needs/improvements.

- The University of Louisville and Spaulding University will conduct the program evaluation, at which time a subsequent Resolution will be submitted to the Metro Council.

- There was a discussion regarding the Seven Counties Services proposal, specifically, the recommended salary and needed credentials for the field Crisis Response workers.

- Seven Counties Services will seek the most qualified applicants for the positions.

- There was a discussion regarding pay disparities and inequities.

- There were several questions regarding the respite center that Seven Counties Services will utilize during the pilot program.

- There were several questions regarding whether the University of

Louisville/Spaulding University provided an evaluation on the sustainable needs to fund the project beyond the pilot program.

- There were several questions regarding whether the program corresponds with the program evaluation.

The motion carried by a voice vote and the Resolution was sent to Old Business.

Adjournment
