The following was discussed:

- Total cost of the program is \$14,000
- Funding from Metro Council was \$6,000 and Goodwill contributed \$8,000
- Goodwill Staff: Sharon Allgeier and Gary Schrock
- Goodwill is located at 909 East Broadway
- Staffed with 2 people, driver and career coach
- United Way donated the van to Goodwill
- A lunch was provided, and clients were transported to volunteer work sites chosen by the city
- \$50 stipend given and information about employment services, treatment, emergency shelters and housing at the Goodwill
- Discussion regarding the summary of locations
- Litter Abatement: Conn Street Dan Luckett (D-15), South Side Dr./Amherst Council Member Nicole George (D-21), Dresden and Long Field Ave. Council Member Kevin Triplett (D-15), all participated and helped with the cleanup project
- A total of 25 participants worked 2 to 3 days
- Evaluation questions regarding what motivated the participants to join the Goodwill Team
- Participants were open and honest about their situations, some due to addiction were not candidates because of safety concerns
- Participants panhandle to survive, but they do not like it
- Individuals given the opportunity will work despite their circumstances
- Discussion regarding success stories
- Successful participants will be connected to internal and external resources leading to long-term employment and barrier reduction services
- Discussion on how homelessness will be addressed
- Discussion regarding no locations in the East End and how the areas were selected
- Goodwill bought the Center and have resources in their center
- Two out of 25 individuals were placed into permanent housing and employment
- The participants like the change and were welcomed by the staff

- Concern regarding only three people on the van-restrictions due to COVID-19 allowed only three people per van and each had a seat
- Working hours were Tuesday and Thursday,10 a.m. to 3 p.m.
- The program started at the beginning of April and ended May 27th
- The Adult Education School will be opening in the Newburg area located on Preston Highway
- Cincinnati has been funding Adult Education Schools for approximately 10 to 12 years
- The state of Kentucky will be funding the Adult Education School here in Louisville
