# AN ORDINANCE AMENDING THE LOUISVILLE METRO CODE OF ORDINANCES CHAPTERS 92 AND 130 RELATED TO BIAS-RELATED CRIMES AND OFFENSES TO MAKE PEOPLE EXPERIENCING HOUSELESSNESS A PROTECTED CLASS.

#### The following was discussed:

- Add's housing status as a protected class in Louisville's current local hate crime code
- Provided the Federal Bureau of Investigation's ("FBI") definition of a hate
- This has already been introduced and or passed in the following cities:
  - Seattle, WA
  - Cleveland, OH
  - Los Angeles, CA
  - Washington, DC
- There is a current effort in Congress to pass this on the Federal level
- The un-housed population has an even higher victimization rate than any other class in the Western industrialized world
- The victimization rate of homeless individuals in between 66 and 82 percent
- Gave examples of hate crimes directed upon un-housed people
- Concerns shared about how this Ordinance will be enforced
- This Ordinance will be enforced as a complaint driven process under LMCO Section 92.40
- Questions as to how this Ordinance differs from the current civil and criminal system in place
- This Ordinance protects actions that are motivated by a hostel intent towards a protected class
- Question as to whether the city can move a homeless camp and, if so, would that be considered a hate crime under this Ordinance
- Question as to how often the city has vindicated itself as it related to a civil rights violation when a crime has been involved

- If a protected class is created based upon housing status, what does this Ordinance entitle the person hereby protected to
- Definition of homelessness and examples were given
- Local code of Ordinances addresses property and gave Kentucky's definition on property
- Question as to why we have protected classes
- Gave definition of protected classes and listed the current protected status'
- A protected status is created because of targeting due to certain characteristics
- Protected classes are set in place because of discrimination
- If the criminal justice system fails the victim or does not produce the intended outcome, does the Ordinance allow for a civil process to have redress
- To pursue with civil action after criminal prosecution did not take place, there is a lesser standard of burden for the civil action under the Civil Rights Ordinance than for the criminal prosecution
- Majority of crimes experienced are not reported by the houseless population
- Whether there have been situations where a homeless person has been assaulted by another homeless person, and it was confirmed regarding people whom are housed as well as the un-housed population
- If the Council can hear from the Louisville Commission of Human Rights for further discussion

A motion was made by Committee Member Purvis, seconded by Committee Member Green, that this Resolution be tabled.

The motion carried by a voice vote and the Resolution was tabled.
