## AN ORDINANCE APPROVING THE FISCAL YEAR 2021-2022 BUDGET FOR LOUISVILLE TOURISM.

A motion was made by Committee Member Piagentini, seconded by Committee Member Arthur, that this Ordinance be recommended for approval.

Chair Hollander explained why this Ordinance and item 5 (O-240-21) were filed separately from Louisville Metro's Operating Budget and provided some background history. He stated that in recent years there have been five

agencies [Louisville Tourism, KentuckianaWorks, Parking Authority of River City (PARC), Transit Authority of River City (TARC), and Waterfront Development Corporation] whose budgets have been attached to and approved as part of Louisville Metro's Operating Budget, no hearings have been held regarding those agency's budgets, and the attached documentation has been an abbreviated version of their actual budgets. He spoke about Council Member Pat Mulvihill's employment with TARC and how including the TARC budget in Louisville Metro's Operating Budget would not allow him to vote on it. He explained that only two of the five agency's budgets have been filed separately because the Jefferson County Attorney's Office has determined that only two of the budgets must be approved per statute, and those are the budgets of TARC and Louisville Tourism and their complete budgets have been attached to each item in Granicus. He also explained that he thought the other three agency's budgets should not be approved as they have been in the past because KentuckianaWorks and Waterfront Development Corporation actually come to hearings and funds are appropriated to them, and PARC participates as part of the hearing for Louisville Forward.

#### The following was discussed:

- Concerns about the statutory requirement to review the TARC and Louisville Tourism budgets and the Committee approving them after only getting the complete budgets the night before, and requesting not to discuss the Ordinances at this time
- Having TARC and Louisville Tourism come before the Committee for a full Budget Hearing
- Louisville Tourism and TARC present their budget in public meetings before each agency approves their own budget
- Both budgets need to be approved by June 30, 2021
- Neither agency has stated that they did not want to come before the Committee
- Louisville Tourism's process for approving their budget
- TARC's budget being discussed in meetings on March 16, March 23, April 20, and April 27
- Carrie Butler, TARC, being out of town and unable to attend the meeting but is willing to come before the Committee at a later date
- Clarification about the reason for separating the two agency's budgets and Council Member Mulvihill's not being able to vote on the TARC budget

#### The following was discussed:

- Clarifying that their operating budget is approximately \$16.8 million and approximately \$10 million in debt service
- Question regarding status of revenue before the pandemic, during the pandemic, and expectations for this year
- Question regarding what critical drivers are necessary in order to see recovery
- The transient room tax flows through the Revenue Commission and they saw the most dramatic decreases in these taxes
- Question regarding the transient room tax in terms of getting conventions to return to Louisville
- Question about the recovery of the tourism industry in Louisville compared to other parts of the state
- Question about work with arts organizations and how they can help each other recover
- Question about the \$240,000 appropriated in Louisville Tourism budget for Derby entertaining, and other entertaining of economic development prospects
- Question regarding whether the Downtown Revitalization work is covered in their budget
- Question regarding whether funds were still being budgeted to help support the community
- Additional questions about the \$240,000 appropriation for Derby entertaining, and why it is being passed through Louisville Tourism
- Question about reserve funds being available to cover the bond for the Convention Center even though there was a significant decrease in revenue from the transient room tax, and having the resources to continue to make the bond payments
- Transparency in spending of the funds allocated for Derby entertaining
- Question about the impact an increase in short-term rentals will have on the transient room tax
