Chief Erika Shields, Louisville Metro Police Department, gave a presentation and overview of the top-to-bottom review conducted by Hillard Heintze.

The following was discussed:

- There was a discussion regarding a top-to-bottom review of the Louisville Metro Police Department by Hillard Heintze.

- There was a discussion regarding Hillard Heintze's recommendations for the Department that are categorized in twelve domains for improvements and/or changes.

- There are a total of 102 recommendations total that are outlined in the twelve domains.

- The majority of the recommendations are within the planning and development or in-process stages for implementation.

- Louisville Metro Police Department is reviewing each recommendation for its feasibility and possible implementation that is inline with overall department goals.

- There was a discussion regarding the manner to formulate the most effective and efficient process to accomplish sustainable achievement and improvement.

- There was a discussion regarding the fact that several recommendations require collaborations with other departments and offices, such as the Office of the Inspector General, etc.

- There was a discussion regarding the current/accumulated traffic stop data, Public Integrity Unit (PIU) cases, and arrest case statistics.

- There were several questions regarding narcotics detectives throwing snowballs at West Louisville residents. There is currently limited information on this incident, however, the Federal Bureau of Investigations (FBI) is currently conducting an investigation.

- There were several questions regarding how many officers were involved in the snowball incident and whether they are on desk duty presently.

- There were several questions regarding the Louisville Metro Police Department's dashboard web site.

- There were several questions regarding review of Louisville Metro Police Department's strategies and processes for crowd control and how this relates to Louisville Metro's general fund budget.

- There were several questions regarding Civil Service testing and specialty unit assignments.

- There was a discussion regarding infractions of the Louisville Metro Police

Department similar to the snowball incident and transparency with the public. - There were several questions regarding the shooting investigation of several individuals that participated in the protests last summer.

- There were several questions regarding specific reforms that the Louisville Metro Police Department will implement from the Hillard Heintze recommendations.

- There were several questions regarding an investigation of the officer that struck an individual during an arrest.

- There were several questions regarding a recommendation from the Hillard Heintze report that references the Louisville Metro Police Department's Internal Affairs file system and potentially auditing this system.

- There was a discussion regarding the changes to section 1 and section 2 that spoke to "emergency" language and encampments in relation to schools and daycare centers.

- There was a discussion regarding emergency language within the amendment.

- There was a discussion regarding the homeless encampments being adjacent to schools and daycare centers.

- There were several questions regarding whether Louisville Metro would store an individual's property if displaced prior to the expiration of the 21-day notice.

- There were several questions regarding whether the amendment outlines what agency would make the determination that the situation is an emergency and the encampment should be displaced.

- There was a discussion regarding Jefferson County Public Schools policy

versus individual school discretion.

- There were several questions regarding the protocol for storing/disposing of homeless persons' property after displacement.

- There was a discussion regarding the instructions and procedures that Solid Waste Management Services follows when clearing encampments. Clearing encampments does not entail storing property, only disposing of the property.

- There was a discussion regarding updating policy and legislation to ensure preservation of property of displaced individuals.

- There were several questions regarding whether the designation for emergency displacement is sufficient versus if it is warranted to make the legislation location specific.

- There was a discussion regarding whether proposed changes would affect policy versus protocol.

- There were several questions regarding what constitutes a health and safety risk to be identified as an emergency for expedited clearing/displacing.

- There was a discussion regarding providing dislocated/displaced individuals with resources and respect along with relocation.

- There were several questions regarding the definition of the phrase "adjacent to".

- There was a discussion regarding homeless displacement from public versus private property.

- There was a discussion regarding Jefferson County Public Schools discretion in removing homeless persons.

- There was a discussion regarding establishing priorities and a way to capture risks in regard to health, wellness and safety.
