The following was discussed:

- There was a discussion regarding the scope and intent of the Ordinance overall and the content that it adds to the original legislation.
- The goal of the legislation is to help deter the repeated discharge of firearms unnecessarily.
- There was a discussion regarding the functions of the ShotSpotter program and areas where the ShotSpotter program does not make impacts.
- There was a discussion regarding the legislation offering another level of protection against repeated discharges of firearms in densely populated areas.
- There was a discussion regarding areas and organizations that are exempt from this legislation.
- There was a discussion regarding the aid and support this legislation may give to law enforcement officers.

- There was a discussion regarding the deficiencies of the legislation and whether it would have a significant impact on either the practice of repeated gunfire or the participant.
- There were several questions regarding new firing ranges and the licensure process and possible exemptions.
- There were several questions regarding whether the Fraternal Order of Police are in support of the legislation.
- The sponsors have discussed the legislation with several Louisville Metro Police officers.
- There was a discussion regarding the impacts of the legislation to individuals in urban areas as opposed to individuals in rural areas.
- There was a request for a Comstat report detailing instances of gunfire including a comparison of urban versus rural ratios.
- There was a discussion regarding further clarifying definitions on acreage, infrastructure, and roads.
- There were several questions regarding instances of repeated gunfire in urban areas, and whether Louisville Metro Police officers requested the legislation.
- There were several questions regarding whether there is a fee to operate a gun range.
- There was a discussion regarding the fact that licensed hunting is exempt from this legislation.
- There were several questions regarding whether firearm maintenance violates the Ordinance, such as, repeated gunfire to adjust a gun sight on private property.
- There were several questions regarding the differences between private property in rural areas versus an outdoor shooting range.
- There were several questions regarding whether this legislation would change/deter the behaviors of individuals that continue in the practice of repeated instances of celebratory/recreational gunfire.
- There was a discussion regarding the scope, definitions, and elements for successful prosecution in instances of "Reckless Endangerment" versus "Wanton Endangerment."
- There was a discussion regarding the intent of the legislation to criminalize and establish probable cause against individuals that have participated in the practice of repeated celebratory gunfire.
- There was a discussion regarding repeated gunfire within densely populated urban areas.
- There was a discussion regarding Louisville Metro Police officer calls for service and how this legislation will further support officers.
- There were several questions regarding discharging a firearm in the air versus a concentrated target.
- There were several questions regarding whether discharging a firearm from a moving vehicle is unlawful.
- There was a discussion regarding possible changes to the Ordinance citing "discharge of weapons within an approximate distance of structures, roads, etc."
- There was a discussion regarding the elements and regulations that were considered to draft the legislation.
- There were several questions regarding the length of turnaround time for permitting and licensure, if this legislation is passed.

A motion was made by Vice Chair Peden, seconded by Committee Member McCraney, that this Ordinance be tabled.

The motion to table carried by a voice vote.
