The following was discussed:

- There was a discussion regarding greater volume of vehicles parked on streets.
- There was a discussion regarding vehicle parking that blocks residents' mailboxes.
- There was a discussion regarding similar legislation in peer cities that prohibit individuals from blocking others' mailboxes.
- There was a discussion regarding parking causing increased challenges for mail carriers as they deliver mail in later hours and are often unable to access mail boxes due to parked vehicles.
- There was a discussion regarding the legislation prohibiting individual's from blocking others' mailboxes during the time frame of 7am to 7pm.
- There were several questions regarding whether the time frame could be adjusted as some mail carriers are later in some areas.

A motion was made by Committee Member Flood, seconded by Vice Chair Peden, that this Ordinance be amended to change the time frame ranging from "7am to 8pm" to prohibit parked individuals from blocking residents' mailboxes.

- There was a discussion regarding how this act also impacts public safety as there are currently staffing shortages in the Louisville Metro Police Department.
- The goal of the legislation is to garner support in the Kentucky General Assembly in order to conduct a study to consider whether utilizing the software/equipment would be beneficial to the community.
- There was a discussion regarding whether similar legislation being adopted in the Kentucky General Assembly would alleviate the need for Louisville Metro Police officers in minor accidents.

Chair Person Fox requested to be added as a co-sponsor.

- There were several questions regarding how Louisville Metro would oversee enforcement and whether a third-party vendor may be utilized.
- There were several questions regarding the accuracy of the equipment.
- There was a discussion regarding due process concerns.
