- Change in compliance requirements, which has decreased the amount of funds needed in administrative expenses for compliance

- Decisions to be made about how the remaining \$110M will be spent and whether a decision should be held until a plan to spend the full amount has been completed

- Workforce Development update:

- about 40 responses to the Request for Application ("RFA")

- recently met to review summary of each RFA

- going through a process to score and prioritize each

- will be able to provide a list in order of magnitude to Budget Committee and Council so that the impact of different amounts of money and different types of investments can be considered

- Program eligibility and qualifications needed to receive funds

- Guidance on how money can be spent has changed

- Questions about Healthy Neighborhoods funding amount -- includes Office of Youth Development and additional funds for compliance, and funds for Public Health related to COVID relief in next fiscal year

- Options to fund the Veteran's Transitional Housing facility - \$110M left from ARP; Affordable Housing; possibly HOME ARP funds
