BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$5,100~~ \$7,100 \$10,350 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,600 from District 17; \$1,000 each from Districts 10 and 15, 19, and 24; \$500 each from Districts 14, 20, 22, and 25; and \$250 each from Districts 8, 9, 14, and 21; to Camp Kesem National in support of the new

camp chapter at Bellarmine University to serve children of cancer patients.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
