**ORDINANCE NO. \_\_\_\_\_, SERIES 2017**  
**AN ORDINANCE CLOSING DUMESNIL STREET FROM 13<sup>TH</sup> STREET TO THE ILLINOIS CENTRAL RAILROAD RIGHT-OF-WAY AND BEING IN LOUISVILLE METRO (CASE NO. 16STREETS1013).**  
**SPONSORED BY: COUNCILWOMAN MADONNA FLOOD**

**WHEREAS**, the Louisville Metro Planning Commission, as set forth in its minutes and records of Case No. 16STREETS1013, has recommended to the Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") that Dumesnil Street from 13<sup>th</sup> Street to the Illinois Central Railroad right-of-way be closed since it is not used to meet public transportation needs; and

**WHEREAS**, the Council concurs in and adopts the findings of the Planning Commission in Case No. 16STREETS1013 and approves and accepts the recommendation of the Planning Commission as set out in said minutes and records.

**NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE**

**LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:**

**Section I:** That Dumesnil Street from 13<sup>th</sup> Street to the Illinois Central Railroad right-of-way and being in Louisville Metro as more particularly described in the minutes and records of the Planning Commission in Case No. 16STREETS1013 and as shown on the attached street closure plat be closed, subject to all existing easements of record and all existing utility easements or rights enjoyed by said utility companies as the result of being located in, on or over said right-of-way.

**Section II:** This Ordinance shall take effect upon its passage and approval.
