A RESOLUTION DETERMINING A PARCEL OF REAL PROPERTY LOCATED AT 247 ALPHA AVENUE, LOUISVILLE, KENTUCKY AND BEING A .393 ACRE PORTION THEREOF AND OWNED BY LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("METRO GOVERNMENT") AS SURPLUS AND NOT NEEDED FOR A GOVERNMENTAL PURPOSE AND AUTHORIZING ITS TRANSFER (AS AMENDED).

WHEREAS, according to KRS Chapter 67C.101, Metro Government may sell any real

property belonging to Metro Government;

WHEREAS, Section 1(A) of Executive Order No. 2, Series 2011, of the Mayor, which adopts Section 2(C) of Executive Order No. 3, Series 2007, provides that Metro Government may sell and convey surplus real estate upon declaration by the Legislative Council of Louisville/Jefferson County Metro Government ("the Council") that such property is no longer needed for the governmental purposes of Metro Government;

WHEREAS, the real property which is the subject of this Resolution has never been dedicated by virtue of use, deed, ordinance or any other manner for a public or governmental purpose;

WHEREAS, Metro Government, as the governmental successor of Jefferson County, Kentucky, has contracted with Norfolk Southern Railway Corporation to sell the real property which is the subject of this Resolution to Norfolk Southern Railway Company for the sale price of \$18,000.00; and

WHEREAS, the Director of Develop Louisville has declared and certified to the Council that the real property which is the subject of this Resolution is surplus to the needs of Metro Government.

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The Council hereby declares the real property designated as Tract B on the survey attached hereto as "SURPLUS" and determines that it is not needed to carry out the governmental functions of Metro Government.

SECTION II: The Mayor is hereby authorized to transfer the property named herein for the purchase price of \$18,000.00 in the manner provided according to Section 2 of the Executive Order No. 3, Series 2007, without further action by the Council.

SECTION III: \$8,000 of the purchase price shall be used by the Louisville Metro Parks Department to install a landscape barrier along the pedestrian walkway on Metro Government's property next to the property named herein. **SECTION <u>IV</u>III**: This Resolution shall take effect upon its passage and approval.
