**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The amount of ~~\$8,000~~ \$13,750 is hereby appropriated from District 21 Neighborhood Development Funds in the following manner: \$8,000 from District 21; \$500 each from Districts 9, 10, 12, 14, 15, 22, 24, and 25; \$250

each from Districts 1, 2, 3, 4, 6, 13, and 17, through the Office of Management and Budget, to Americana Community Center, Inc. for the Youth Program and Family Education Program offered four days per week, year-round.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
