(C.H.O.I.C.E., INC.), FOR A "DARE TO DREAM" SPORTS LEADERSHIP AND MENTORING PROGRAM (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$6,615~~ \$9,822 is hereby appropriated from the District 21 Neighborhood Development Funds in the following manner: ~~\$6,615~~ from District 21; ~~\$3,207~~ from District 5; through the Office of Management and Budget, to C.H.O.I.C.E., Inc., for a "Dare to Dream" sports leadership and mentoring program.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
