BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,615 \$9,822 is hereby appropriated from the District 21 Neighborhood Development Funds in the following manner: \$6,615 from District 21; \$3,207 from District 5; through the Office of Management and Budget, to C.H.O.I.C.E., Inc., for a "Dare to Dream" sports leadership and mentoring program.
