BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$13,750~~\$18,250 is hereby appropriated from Neighborhood Development

Funds in the following manner: \$8,000 from District 14; \$2,000 from District 9; \$1,000 each from Districts 1, ~~and~~ 13, 15, and 24; \$500 each from Districts 2, 3, 4, 7, 10, 12, and 21; \$250 from Districts 8, 11, and 19; through the Office of Management and Budget, to Louisville Asset Building Coalition, Inc. for operating expenses associated with coordinating the Volunteer Income Tax Assistance Program (VITA).

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
