BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$10,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,500 from District 1; \$2,500 from District 5; \$2,000 from District 6; and \$1,000 each from Districts 2 and 4; through the Office of Management and Budget, to River City Drum Corp Cultural Arts Institute, Inc. for expenses associated with the 11<sup>th</sup> Annual Da'Ville Classic Drum Line Showcase.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
