**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$77,500~~ \$95,500 is hereby appropriated from the Neighborhood Development Funds in the following manner: \$10,000 each from Districts 16, 12, 4, 1; \$5,000 each from Districts 13, 21, 8, 6, 11, 17; \$2,500 each from Districts 9, 18, 7, 19, 20; \$2,000 each from Districts 2, 14, 24; \$1,500 from District 5; \$1,000 each from Districts 15, 3, 10, 22, 23; \$500 from District 25; through the Office of Management and Budget, to the Center for Women and Families, Inc., for a roof replacement at the Joan e. Thomas (JET) facility.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
