**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$10,950~~ \$12,200 ~~\$15,250~~ \$15,750 is hereby appropriated as follows: \$2,500 from District 10; \$1,200 from District 14; \$1,000 each from Districts 24, 13, 18 and 12; \$500 each from Districts 1, 2, 4, 6, 8, 17, 5, 20, 22, 7, 19, 9, 15 and 25; \$300 from District 14; and \$250 each from Districts 3, 16 and 21 Neighborhood Development Funds, through the Office of Management and Budget, to Day Spring Foundation, Inc., for capital improvements for expansion of the office building and community center.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
