**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$12,770.40 is hereby appropriated from Neighborhood Development Funds in the following manner: \$4,385.20 each from Districts 20, 11; \$3,000 from District 18; \$1,000 from District 22; through the Office of Management and Budget, to the Jeffersontown Fire Protection District for tables, chairs and a chair dolly for use in a community room.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
