BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$7,000 is hereby appropriated from District 12 Neighborhood Development Funds, through the Office of Management and Budget, to Brightside for maintenance of Rose Farm Park, a pocket park and memorial site on Dixie Highway.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
