**BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept additional funding of \$543,947 for the continued design phase and right of way phase of the Medora section of the Louisville Loop at the Jefferson Memorial Forest.

**SECTION II:** This Resolution shall take effect upon its passage and approval.
