Plan; and

WHEREAS, by Ordinance 085, Series 2018 the Metro Council adopted the 2040

Comprehensive Plan effective January 1, 2019; and

WHEREAS, the Louisville Metro Planning Commission held a public hearing on November 15,

2018 to review amendments to the Land Development Code to update references to the 2040

Comprehensive Plan; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission in

Case No. 18AMEND1000 and approves and accepts the recommendations of the Planning

Commission as set out in said minutes and records.

NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

SECTION I: The text amendments to the Land Development Code to update references to the 2040 Comprehensive Plan are hereby adopted, as more particularly described in the minutes and records of the Planning Commission in Case No. 18AMEND1000.

SECTION II: This Ordinance shall take effect upon its passage and approval.
