(JCPEF), TO BE USED BY THE YOUTH SERVICES CENTERS (YSC) FOR EDUCATIONAL PROGRAM EXPENSES AT SOUTHERN HIGH SCHOOL INCLUDE **INDIVIDUAL** OR **GROUP** COUNSELING SERVICES: CYBER-BULLYING AND SUICIDE EDUCATIONAL PRESENTATIONS.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,000 is hereby appropriated from the District 24 NDF, through the OMB, to the JCPEF, Inc., to be used by the YSC for educational programming expenses Southern High School to include individual or group counseling services; cyber-bullying and suicide educational presentations.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.
