BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$8,750 \$8,500 is hereby appropriated from District Neighborhood Development Funds as follows: \$2,000 each from Districts 15, 21; \$1,000 each from Districts 12, 13, 14, 25; \$750 from Districts 6, 25; through the Office of Management and Budget, to South Louisville Community Ministries, Inc. for program expenses associated with its Taste of South Louisville fund-raising event.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
